ASYNCHRONOUS VIDEO SUBMISSIONS

Asynchronous videos must be appropriately submitted into Tabroom by Wednesday, December 9th, 11:59 PM. Judging for asynchronous videos will take place between Thursday December 10th and Saturday December 12th until 2:00 PM.

TOURNAMENT REGISTRATION

Due by 5:00 PM December 9th. Adds afterwards will incur a hassle fee (10.00 dollars per instance), and can only be accommodated as circumstances permit.

JUDGE BURDEN

One judge for every two LD, PF, and Policy teams.

One judge for every five Congressional competitors.

One judge for each 5 IE entries.

Schools that are short judges will be required to drop any uncovered entries unless they are able to find judges from another school to help cover their judging burden. Ultimately, we believe it is each competitor's responsibility to ensure that their entry is covered, not their program's responsibility.
