

## Legislation #549

### A Bill to Implement Medicare-for-all

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1   **SECTION 1.**   The United States Centers for Medicare and Medicaid Services shall  
2                   implement Medicare for all to ensure equal healthcare services for all  
3                   Americans.
- 4   **SECTION 2.**   Medicare for all is defined as an expansion of the current medicare system,  
5                   and will cover all essential treatment with no premiums or deductibles.  
6                   Medicare for all will be a single-payer program in which all Americans are  
7                   covered by a more generous version of the current Medicare insurance.
- 8   **SECTION 3.**   The United States Centers for Medicare and Medicaid Services within the  
9                   United State Department of Health and Human Services shall be  
10                  responsible for the implementation and oversight of this legislation.
- 11                  A. In order to finance this bill, a 4% income-based premium paid by  
12                  households would be implemented.
- 13                      a. A 4% income-based premium paid by households will raise \$3.5  
14                      trillion in ten years, which is approximately the amount this bill  
15                      will cost over the same period of time.
- 16                  B. Medicare for all will be implemented over the next 10 years, from 2021  
17                  to 2031. Individuals will all be switched from their current insurance, to  
18                  the new expanded medicare insurance.
- 19                      a. Individuals currently on medicare and medicaid will see minimal  
20                      changes, only new benefits and lower fees. Individuals on  
21                      private insurance will be switched over to the new medicare  
22                      insurance with expanded benefits.
- 23   **SECTION 4.**   This bill will be implemented on January 20th, 2021.
- 24   **SECTION 5.**   All laws in conflict with this legislation are hereby declared null and void.

## STOP THE STEAL ACT

1. **Article 1** To reaffirm that Congress should have the authority to regulate money in politics.
2. **Article 2** this bill specifically addresses monetary donations to campaigns.
3. **Article 3** The act takes effect starting March 22, 2021 even if the Federal Election
4. Commission has not promulgated regulations to carry out the measure or its enforcement.
5. **Article 4** The Federal Election Commission, with assistance from the state in which the
6. offender resides will see to a placard measuring three feet by six feet being displayed on the
7. individual or establishment stating the pilfering of the offender(s) at the offender's expense
8. and the offender will give twice the amount of capital given to be donated to local homeless
9. shelters with the federal election commission's supervision. The shelters will be located in the
10. district(s) in which the election is taking place. This ensures that people are being
11. refranchised as voters with the capital that attempted to disenfranchise them.
12. **Article 5** Laws in conflict with this new policy shall be declared null and void, except for the 13. U.S. Constitution.

## A Bill to Extend Provisions for Those With Pre-Existing Conditions and Allowing More Cohorts Access to Medicare Benefits

BE IT ENACTED BY THIS CONGRESS HERE ASSEMBLED THAT:

ARTICLE 1. To expand access for the vulnerable, any individual born with a Chronic Disease shall be entitled to full medicare benefits pertaining to treatment of that disease or related illnesses at any point in their life. All individuals in the public and private sector are entitled to full medicare benefits outright from age 60 and above, lowering the eligibility age by 5 years. Pertaining to payments, no individual earning less than 4x the poverty rate shall pay no more than 8% of their income for medicare, regardless of the services they receive.

ARTICLE II. The current regulations will operate on the assumptions of the continued implementation of the Patient Protections Act passed by the 111th Congress in 2010. This bill, if passed, will serve as a safeguard to protect the repealing of this previous act, and so its provisions on the inability of private insurance companies to deny a patient services for pre-existing conditions would be upheld under the assumption of full medicare benefits for such patients mentioned in the previous article, expanding and protecting those who receive such services.

ARTICLE III. The Department of Health and Human Services (HHS) will oversee the implementation of all of these newly enacted provisions, and shall conduct audits of any kind of licensed insurance company who is in violation of any of these standards and take necessary legal action toward those who are in proven violation. The department will also see to any complaints made by civilians made about the failure to uphold this act.

ARTICLE IV. This legislation will be implemented at the beginning of the 117th Congress.

ARTICLE V. All laws in conflict with this legislation are hereby declared null and void. Current existing laws will be required to accompany this universal standard.

12.                  A. In order to monitor progress, the EPA shall create approval and oversight
13.                  teams, which will complete evaluations as delegated by the EPA.
14.                  B. Should a program be unnecessary or flawed, it will be terminated
15.                  immediately.
15. **SECTION 4.** This law shall go into effect one fiscal year following its passage.
16. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

### A Resolution to Amend the Constitution to Reform Election Funding and Regulations

1. **RESOLVED**, By two-thirds of the Congress here assembled, that the following article is
2. proposed as an amendment to the Constitution of the United States, which
3. shall be valid to all intents and purposes as part of the Constitution when
4. ratified by the legislatures of three-fourths of the several states within seven
5. years from the date of its submission by the Congress:

#### ARTICLE --

7. **SECTION 1:** The amendment will put a limit on the amount of money
8. corporations can donate to SuperPACS at an amount of
9. 50,000 dollars from each entity exactly for one election
10. period. Any corporation found breaking this would be fined
11. 10 million dollars initially and for the next year wouldn't be
12. able to receive any tax breaks/cuts. Moreover, SuperPACS
13. must not be associated with a public office candidate and
14. must disclose every person (even if they are linked to a
15. corporation or other group) that donated money. The penalty
16. for a SuperPAC not following the law will be a complete
17. shutdown of the SuperPAC by the federal government. The
18. Federal Election Commission Chair will also now be required
19. to be voted in every 4 years by the American people.. This
20. amendment will be carried out by the newly reformed
21. Federal Election Commission.

**ARTICLE I.** The assets of the upper class shall be taxed through a progressive rate structure.

To process these taxes, the IRS shall be allocated an additional \$875 million to run more efficiently and train more officers.

**ARTICLE II.** The upper class is defined as the wealthiest 0.1% of the population. A progressive rate structure is one which increasingly taxes specific ranges of wealth as the minimum and maximum values of that range increase.

**ARTICLE III.** This legislation will go into effect on January 1<sup>st</sup>, 2022.

- A. A 1 percent wealth tax will be placed on net worth above \$32 million for a married couple. This will increase to 2 percent for a net worth from \$50 million to \$250 million, 4 percent from \$500 million to \$1 billion, 5 percent from \$1 to \$2.5 billion, 6 percent from \$2.5 to \$5 billion, 7 percent from \$5 to \$10 billion, and 8 percent on wealth over \$10 billion.
- B. The above brackets shall be reduced to half for single American citizens.
- C. The IRS shall be required to perform an audit of all wealth tax returns for all those specified in the above brackets.

**A Legislation To Allow Optional Access To Affordable Government Health Care To All U.S. Citizens Who Are Not Under Any Government Health Care Plan**

**BE IT ENACTED BY THE CONGRESS ASSEMBLED HERE THAT:**

**RESOLVED**, By a two-third support of the Congress assembled, the following article is proposed as a government healthcare reform bill that when ratified by either two-thirds of both branches of Congress or three-fourths of state congressional conventions within the next 2 years of the submission of this legislation:

**SECTION 1:** Government healthcare plans such as Medicare will be made affordable by adjusting price according to income and ability to pay.

The bill can be applied to government healthcare programs only and must not be used to cut private healthcare plans.

Any U.S. citizen seeking to acquire or switch to a government healthcare plan must sign up and inform the government healthcare provider/organization.

All U.S. citizens already under government healthcare will be automatically accepted into this plan but have the option to quit if it doesn't suit them.

This healthcare plan should not be forced on anyone who does not sign up or chooses to continue or start a private healthcare plan.

**SECTION 2:** In order for this bill to be passed, it will require a submission of payment plans to fund the healthcare program along with either at least a  $\frac{2}{3}$  vote in both the House of Representatives and the Senate or at least a  $\frac{3}{4}$  vote by all state congressional conventions within 2 years.

When ratified, Congress may fund the government healthcare programs to allow them to exercise the actions of the bill and extend it to those who sign up for government healthcare or stay in government healthcare.

**SECTION 3:** All laws in conflict with this legislation are hereby declared null and void.

## #3131 — A Bill to Reduce Federal Funding for Universities

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **Article I.** In response to the student loan debt crisis of over \$1.6 trillion, the United States  
3 Federal Government must reduce the cost of higher education by cutting all  
4 federal general appropriation funding (such as for administration costs) and halve  
5 (based off of the 2020 fiscal year budget and its currency value) all research  
6 funding and federal Pell Grants (financial aid for students) to universities with  
7 tuition costs exceeding \$15,000 a year.

8 **Article II.** With the money appropriated from this program, universities who comply will  
9 receive increased funding as a reward for the reduction in tuition. Research  
10 funding and Pell Grants will be redirected to institutions in compliance, with the

### A BILL TO ESTABLISH A SINGLE PAYER HEALTHCARE SYSTEM IN THE UNITED STATES

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT

1 **SECTION 1.** Establish a national health insurance program to provide comprehensive protection against the costs of health care and health-related services for every  
2 individual who is a resident of the United States

3 A. No cost-sharing, including deductibles, coinsurance, copayments, or similar charges, be imposed on an individual for any benefits provided under  
4 this Act. In addition, no provider may impose a charge to an enrolled individual for covered services for which benefits are provided under this Act.

5 B. No person shall, on the basis of race, color, national origin, age, disability, or sex, including sex stereotyping, gender identity, sexual orientation,  
6 and pregnancy and related medical conditions, be excluded from participation in, be denied the benefits of, or be subjected to discrimination by any  
7 participating providers.

8 **SECTION 2.** Extensive coverage is defined as:

9 A. Hospital Services, including inpatient and outpatient hospital care, 24-hour-a-day emergency services and inpatient prescription drugs, as well as laboratory and  
10 diagnostic services

11 B. Ambulatory Patient Service, such as emergency services and transportation, including transportation to receive healthcare services for individuals with disabilities  
12 and low-income individuals

13 C. Primary and Preventative Services, including chronic disease management and prescription drugs, medical devices, biological products, including outpatient  
14 prescription drugs, medical devices, and biological products.

15 D. Mental health and substance abuse treatment services, including inpatient care.

16 E. Comprehensive reproductive, maternity, and newborn care. Pediatrics, including early and periodic screening, diagnostic, and treatment services are guaranteed.

17 F. Oral health, audiology, and vision services.

18 **SECTION 3.** Establish uniform State reporting requirements and national standards to ensure an adequate national database containing information pertaining to health  
19 services practitioners, approved providers, the costs of facilities and practitioners providing such services, the quality of such services, the outcomes of such services, and the  
20 equity of health among population groups

21 **SECTION 4.** The United States Department of Treasury shall work in cooperation with the Department of Health and Human Services and its agencies to oversee the implementation  
22 of this legislation.

23 **SECTION 5.** These legislations upon passage will go into effect on January 1, 2021.

## **A BILL TO MAKE ABORTION A HEALTHCARE SERVICE**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT

**SECTION 1.** Qualify abortion as a healthcare service, increase accessibility comprehensive reproductive services, reduce the costs of abortion and finally follow the World Health Organization guidelines for abortion.

- A. A healthcare provider has a right under this Act to provide abortion services, and that provider's patient has a corresponding right to receive such services, without any limitations or requirements

**SECTION 2.** A healthcare provider is defined as any entity or individual —

- A. Engaged in the delivery of healthcare services, including abortion services; and
- B. Licensed or certified to engage in the delivery of such services.

**SECTION 3.** The government, private individual, or entity with grievances may take legal actions against non compliant individuals or services.

- A. The Attorney General may commence a civil action for prospective injunctive relief on behalf of the United States against any government charged with implementing or enforcing any limitation or requirement that is challenged as a violation of a statutory right under this Act.
- B. Any individual aggrieved by an alleged violation of this Act may commence a civil action for prospective injunctive relief against the government official that is charged with implementing or enforcing the limitation or requirement that is challenged as a violation of a statutory right under this Act.
- C. A healthcare provider may commence an action for prospective injunctive relief on its own behalf and/or on behalf of the provider's patients who are or may be adversely affected by an alleged violation of this Act

**SECTION 4.** The Department of Health and Human Services will oversee the implementation of this act.

**SECTION 5.** These legislations upon passage will go into effect on January 1, 2021.

**SECTION 6.** No State, territory, or possession of the United States, or the District of Columbia, or the Commonwealth of Puerto Rico, or subdivision, branch, department, agency, instrumentality, or official (or other person acting under color of law) of any of the forgoing, shall enact or enforce any law, rule, regulation, standard, or other provision having the force and effect of law that conflicts with any provision of this Act.

**A BILL TO TIGHTEN THE FEDERAL STANDARD ON PM<sub>2.5</sub>**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**SECTION 1.** Establish a new, rigorous, national annual standard on PM<sub>2.5</sub>.

A. The standard will be 8 to 10 micrograms per cubic meter of air.

**SECTION 2.** PM<sub>2.5</sub>, otherwise known as particulate matter, can be defined as a mixture of solid particles and liquid droplets found in the air that are 2.5 micrometers in diameter.

**SECTION 3.** Under 42 U.S.C 7414, the best available form of fence-line monitoring of sources of hazardous air pollution

A. The Environmental Protection Agency, using its Inspector General's Report of this year, will determine the sources of pollutants as well as any other source that poses a cancer risk of 1-in 1 million as well as a chronic non-cancer risk

B. The Environmental Protection Agency's Inspector General must report their findings annually to Congress

**SECTION 4.** Regulations shall be imposed on any source violating said standard

A. Sources must implement the best available form of continuous emissions monitoring and fence-line monitoring to assure compliance with the emission standards for hazardous air pollutants

B. Facilities are required, under the Clean Air Act Section 112(r), to submit risk management plans to prevent accidental releases of PM<sub>2.5</sub> as well as an effective emergency response

C. Establish a corrective action at the fence-line, and require a root cause analysis and consequence if the action is exceeded

**SECTION 5.** The Environmental Protection Agency will cooperate with the Department of Health and Human Service to oversee the implementation and enforcement of the standard.

**SECTION 6.** This legislation, upon passage, will go into effect on January 1, 2021.

**SECTION 7** All laws in conflict are hereby declared null and void.
