Double Entry: Double-entry is allowed ONLY for well-grounded upper class students (no novices!)

Awards: Certificates will be awarded to the finalists in each category. Honorable mentions will be awarded as standings dictate.

Judges: One judge for every <u>five</u> entries, or fraction thereof, is required.

One duo pair equals one entry. Parent, teachers, or other interested adults may serve as judges. High school students who have experience in speech are also welcome to judge. Electronic tabulation will be used via Tabroom.com. Rounds will be conducted on the NSDA Campus platform. Since we will be using a few new technologies and tools this year, we recommend ALL judges (new and returning) read the MMSSL 2020-2021 Judging Guide.

Events: All 10 regular competition events will be offered at the virtual tournament. To see a complete list and descriptions for each event, please consult the MMSSL 2020 Judging Guide or our website at mmssl.weebly.com.

Please note that, due to the digital format of the tournament, the following events have had slight protocol changes:

- Impromptu: Judges will be sent a list of Impromptu topics via email, with a set of 3 topics
 for each competitor. During an Impromptu round, the judge will copy and paste a different
 set of 3 topics into the chat for each competitor when it is their turn to speak. Judges
 should send topics to each competitor privately (if supported by the platform), and
 not to the entire group.
- Duo: In order to conform to social distancing guidelines, Duo performers must join each round separately and perform separately. (This rule also applies to Duo pairs who may be quarantining together.) In Duo rounds, any students not performing should mute themselves and turn off their video so that the current performers are the only ones visible. (If the judge needs to give time signals, they can leave their video on as well.) Duo competitors will need to assume that their video windows may not be positioned near each other in the video chat screen.

Fees: No entry fees will be required. Schools are required to be members of the Massachusetts Middle School Speech League.

Entries are considered final as of 9:00 p.m. Wednesday, January 20th.

Schools remain responsible for judges.

NO ADDITIONAL ENTRIES WILL BE ACCEPTED AFTER THE CLOSE OF ONLINE REGISTRATION.
