Notes***

We will follow NSDA and KSHSAA rules except where indicated. When in direct conflict, NSDA rules shall take precedence; for example, there will be 4 minutes of prep time in LD.

We will endeavor to recruit a healthy community pool of judges. Each school will be asked to bring 1 judge per 12 entries, and that judge must be available throughout the weekend even if your school's entries are eliminated from further competition. Judging assignments may be split as appropriate. All judges must have linked Tabroom accounts and should be trained on how to use online ballots.
