# A Bill to E-Learn for E-ternity to E-volve E-ducation

#### BE IT ENACTED BY THE UNITED STATES CONGRESS HERE ASSEMBLED THAT:

Section 1. A.	Every state government shall be required to establish an online K-12
	educational institution as an alternative to in person schooling. Any student
	with permission from a parent or guardian can opt in or out of this online
	school prior to their enrollment for in-person schooling.
B.	25 billion dollars will be taken from the United States Department of Defense
	and distributed to the aforementioned institutions based on respective state
	Populations.
C.	States that fail to create such institutions one year after the implementation of
	this legislation shall lose 50% of their federal education funding.
Section 2.	An online educational institution shall be defined as an accredited public
	institution where instruction is done by teachers over the internet through
	forms including but not limited to video instruction, digital notes, online tests,
	and any other means that meet Common Core and state educational standards
	required to graduate.
Section 3.	This bill will be overseen by the United States Department of Education and
	the United States Department of the Treasury.
Section 4.	This bill will go into effect at the start of the 2022 fiscal year.
Section 5.	All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Add Value for Our Children

1	BE IT ENACTED BY THE UNITED STATES CONGRESS HERE ASSEMBLED THAT:	
2	SECTION 1.	The United States shall implement a value-added tax at a rate of ten percent on
3		all nonessential items and purchases.
4		All revenue from this value added tax will be directed to the creation of public
5		childcare centers, with the goal of creating one center for every 2,500 children.
6	SECTION 2.	A value-added tax shall be defined as a tax levied on the price of a product or
7		service at each stage of production, distribution, and sale.
8		An essential item or purchase shall be defined as anything considered a necessity
9		for minimal living. These include certain groceries, mobility equipment, and
10		household items, and the list will be determined by the Department of Health
11		and Human Services.
12		Childcare centers shall be defined as places which provide regular care of
13		children from birth to the age of five in an environment suited to child
14		development.
15	SECTION 3.	The Internal Revenue Service and the Department of Health and Human Services
16		will carry out this bill.
17	SECTION 4.	This legislation will go into effect starting Federal Year 2022.

All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Create a Universal Basic Income

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:	
2	SECTION 1.	A. Each United States Citizen above the age of 18 shall receive a monthly	
3		Universal Basic Income from the United States Government.	
4		B. The Universal Basic Income (UBI) shall be paid through a Value Added	
5		Tax of 10 percent.	
6	SECTION 2.	A. Universal Basic Income shall be defined as monthly payments of 1000	
7		dollars	
8		B. Value Added Tax shall be defined as a tax that is implemented on each	
9		stage of the supply chain to sale.	
10		C. Recipients shall not include any citizens who are felons or unbanked	
11		citizens.	
12		D. Any American citizen that travels abroad for more than 60 days will be	
13		suspended from monthly payments until they return	
14	SECTION 3.	The Department of Treasury and the Internal Revenue Service shall be	
15		responsible for enforcing the provisions of this bill	
16		A. The Internal Revenue Service shall be responsible for the	
17		collection and enforcement of the Value Added Tax	
18	SECTION 4.	The provisions of this bill shall take effect immediately upon the 2021	
19		Fiscal Year	
20	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.	

### A Bill to Stop Tehran Apart the Iran Nuclear Deal

#### 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 Section 1. The United States will rejoin the Joint Comprehensive Plan of Action to 3 rejoin the Iran nuclear deal. All current sanctions on Iran will no longer be in effect. 4 5 Section 2. Sanctions will include but not be limited to the ban on arms, 6 origin-imports, dealings with the United States, financial institutions, and 7 selling aircraft parts. The U.S Department of State will oversee the implementation of this bill. 8 Section 3. 9 Section 4. This Legislation will go into effect on January 1st, 2022.

All laws in conflict with this legislation will be considered null and void.

# A Bill to Separate History From Hatred

1	BE IT ENACTED BY THE UNITED STATES CONGRESS HERE ASSEMBLED THAT:	
2	SECTION 1.	A. All Confederate monuments that are currently in public parks or open
3		areas within a municipal district shall be removed. The Confederate
4		monuments within a municipal district will be distributed equally to the
5		respective state's historical museums that are willing to hold them.
6		B. All remaining monuments that are still in public parks or areas shall be
7		destroyed by the National Park Service.
8	SECTION 2.	Municipal districts are areas of land that consist of the proper
9		population and size to be recognized as a territorial entity. Monuments
10		are structures used to commemorate certain individuals or events.
11		History museums are museums that collect historical objects for the
12		purpose of showing the history of a certain time period or place to the
13		public.
14	SECTION 3.	The National Park Service shall oversee the implementation of this bill.
15	SECTION 4.	This legislation will go into effect on January 1st, 2022
16	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void

# A Bill to Stop the Reign of Terror

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	<b>SECTION 1</b> . A. The Department of Homeland Security will create a taskforce to target		
2		Domestic Terrorism. Domestic terrorists will now face the full punishment	
3		that foreign acts of terror face.	
4		B. 1.5 billion dollars shall be allocated from the Department of Defense's	
5		Counter Terrorism Budget to fund this legislation.	
6	<b>SECTION 2</b> . Domestic terrorism involves violent or dangerous acts that that are a		
7		violation of the criminal laws of the United States. Such actions must	
8		appear to be intended to:	
9		(A) to intimidate or coerce a civilian population;	
10		(B) to influence the policy of the government through intimidation or	
11		coercion; or	
12		(C) to affect the efficiency of a government through mass destruction,	
13		assasination, or kidnapping.	
14	SECTION 3.	The Department of Homeland Security shall be responsible for:	
15		(A) selecting the agents and participants of the new task force.	
16		(B) providing training materials and references for educational	
17		purposes.	
18		(C) Appointing an appropriate head of the task force.	
19		Ensuring a fast and efficient implementation of this legislation.	
20	SECTION 4.	This legislation will take effect immediately upon passage.	
	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.	

1	SECTION 1.	ARTICLE I	The United States shall establish a formal designation for U.S. domestic
2			terrorist organizations.
3		ARTICLE II	Groups formally designated as U.S. domestic terrorist organizations shall
4			have their membership rolls seized by federal authorities.
5		ARTICLE III	Individuals identified as members of U.S. domestic terrorist organizations
6			shall be permanently disenfranchised.
7	SECTION 2.		"U.S. Domestic Terrorist Organizations" shall be defined as groups that
8			advocate for and/or carry out, through their members, violent acts against
9			individuals based on race, color, national origin, religion, sex (including
10			gender, pregnancy, sexual orientation, and gender identity), age, or disability;
11			or local, state, or federal government officeholders. "Disenfranchise" shall
12			be defined as depriving an individual of the right to vote.
13	SECTION 3.		The Department of Justice and the Federal Election Commission will oversee
14			the implementation and enforcement of this legislation.
15	SECTION 4.		This legislation shall take effect January 1, 2022.
16	SECTION 5.		All laws in conflict with this legislation are hereby declared null and void.

# A Resolution to Create Free Trade with China

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	WHEREAS,	The United States and China have been locked in a trade war for the past 2
2		years; and
3	WHEREAS,	The economic toll of this tit-for-tat policy has created economic instability
4		for many including farmers; and
5	WHEREAS,	The price of goods have also increased as a result of this trade war; and
6	WHEREAS,	The COVID-19 pandemic has also lead to price increases that have further $$
7		burdened everyday Americans; now, therefore, be it
8	RESOLVED,	That the Congress here assembled make the following recommendation
9		for a removal of all tariffs from both sides of this trade war; and, be it
10	FURTHER RES	<b>OLVED,</b> That any president cannot, without approval from Congress, install
11		tariffs on Chinese goods to further political goals and, be it
12	FURTHER RES	<b>OLVED,</b> That if China refuses to remove tariffs with the United States in
13		three months within removal of U.S. tariffs on Chinese goods, the United
14		States shall reimplement tariffs on China.

# **A Resolution to Cancel Social Credit**

1	WHEREAS,	China has adopted a national scoring system known as the 'Social Credit
2		System' to standardize citizens' and businesses' economic and social
3		reputations; and
4	WHEREAS,	China is attempting to monitor and dictate citizens' choices by exploiting
5		their online behavior, suppressing their opinions, and prioritizing those
6		with higher scores while simultaneously punishing those with lower
7		scores; and
8	WHEREAS,	Citizens with low social credit are prohibited from travelling within China
9		by air or train, getting desirable jobs, getting accepted into top schools,
0		applying for credit cards and loans, et cetera; and
1	RESOLVED,	That the Congress here assembled demands that the Chinese
2		government abolish the Social Credit System; and, be it
3	FURTHER RES	<b>OLVED,</b> That if the Chinese government fails to do so, a technology
4		embargo shall be placed on them indefinitely.
