# A Bill to Tax Extreme Wealth to Reduce Extreme Inequality

1	Article I:	A progressive tax shall be imposed on the wealth and assets of households
2		whose net worth is valued at \$32 million or higher.
3	Article II:	Wealth and assets of up to \$50 million will be taxed at a rate of 1 percent,
4		up to \$250 million at a rate of 2 percent, up to \$500 million at a rate of 3
5		percent, up to \$1 billion at a rate of 4 percent, up to \$2.5 billion at a rate of
6		5 percent, up to \$5 billion at a rate of 6 percent, up to \$10 billion at a rate
7		of 7 percent, and above \$10 billion at a rate of 8 percent.
8	Article III:	This legislation will take effect at the beginning of fiscal year 2022.
9	Article IV:	The Internal Revenue Service (IRS) will be responsible for the
10		implementation of this legislation.
11		A. The minimum threshold and tax brackets affected by the provisions of
12		this legislation shall be adjusted annually by the IRS in order to
13		account for inflation.
14	Article V:	All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Make Policing Records Transparent

- 1. Article I The United States will require any registered police's active or past records, to
- 2. be transparent and accessible by civilians on a national database. Any criminal arrests,
- 3. fines charged, or significant activity done during or before time of employment will be
- 4. stored on a transcript that will be accessible on the central database.
- 5. Article II The central database in which these records can be accessed, will be available
- 6. to all civilians to view and report upon.
- 7. Significant activity entails any action which had an impact on another individual during
- 8. duty. Example includes use of an assault weapon/force against another individual and other forms of misconduct.
- 9. Race and age data of the the individuals incarcerated, fined against, or impacted by a
- 10. police will be stored within the police's profile records as well.
- 11. Article III This bill takes effect January 1, 2022
- 12. Article IV The United States Department of Justice will be responsible for the
- 13. enforcement of this bill. Local districts which fail to log accurate records, no censoring of
- 14. any information, of personnel will be charged a fine of \$500.
- **15. Article V** All laws in conflict with this new policy shall be declared null and void.

# 1571: A Bill to Aid the Northern Triangle to End the Border Crisis

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **ARTICLE I.** The United States shall provide \$1 billion in developmental aid to the people of the Northern Triangle through non-governmental organizations (NGOs) operating within these nations.
- **ARTICLE II**. The Northern Triangle shall be defined as the nationals of Guatemala, Honduras, and El Salvador. Developmental aid shall be defined as humanitarian, economic, and medical assistance for the purpose of alleviating humanitarian crises in these nations.
- **ARTICLE III.** This legislation shall go into effect on July 1, 2021.
- **ARTICLE IV.** The United States Agency for International Development (USAID) shall be responsible for the implementation of this legislation.
  - A. USAID shall be responsible for setting up a bid process to award federal grant funding to NGOs based on past effectiveness, distribution capabilities, and proposed plan of distribution.
  - B. The \$1 billion in funding shall be awarded over the next five years, with\$200 million in funding each calendar year.
  - C. Government officials in the Northern Triangle that interfere with the successful distribution of aid shall be sanctioned under the Magnitsky Act.

**ARTICLE V.** All laws in conflict with this legislation are hereby declared null and void.
