Please note, per VHSL policy: "Individuals/teams must be present and compete to receive awards, advance to the next level of competition and/or earn sweepstakes points."

Facility: The tournament(s) will be held online via ZOOM. Please make sure Zoom is accessible for your school. If not please work with your IT division in order to make it available for the tournament date. If there are concerns with your school division's policy and making use of this competition platform please refer your AD and/or superintendent to Darrell Wilon, Assistant Director for Academic Activities at dwilson@vhsl.org. It is also strongly encouraged and highly recommended that debaters be on campus to debate virtually as schools should have a more stable internet connection and better technology available as opposed to working from home. This is not required to participate, however.

Lincoln Douglas - Resolved: The United States ought to guarantee universal child care.

Public Forum - Resolved: On balance, the benefits of creating the United States Space Force outweigh the harms.

Schools should take care not to submit more than one piece of legislation in a topic area until all areas have been addressed (i.e. No two Domestic pieces of legislation unless International, Economic, and Virginia have also had something submitted.)

Each school competing in Student Congress must also submit one bill or resolution for Super Session. The Super Session topics are:

Domestic: Federal Building Security

International: Travel Bans

Economic: Speculation Regulations

Virginia: Motor Vehicle Operation
Licensing Regulations

Tournament CX, LD, and PF Round determination: Per the VHSL Manual -
Format:

"In all four divisions of debate, **pairings shall be determined by the tournament director to provide the most equitable schedule possible depending on the number of participants in each group.** A director may choose either a round-robin format or...in the event there are more than eight teams, the director shall schedule four preliminary rounds using the power pairing format below.

Power Pairing Format -

1. Rounds 1 and 2 paired at random with regional constraints.
2. Round 3 paired on win-loss records and speaker points (High-High).
3. Rounds 4 paired on win-loss records and speaker points (High-Low).
4. Top four debaters break to semifinal* rounds.
5. Break to the final round."

* - Due to the large number of potential entries there may be a quarterfinal round in Lincoln-Douglas and/or Public Forum. Alternate in L-D (fifth place) will be determined based on preliminary round record and through the VHSL tie-breaking procedure as indicated in the Debate Manual.

Fewer than eight teams may necessitate a Round Robin format being used.

Tournament Format (cont'd): Student Congress Round determination: Following the Debate Rules Clinic in the fall of 2019 the recommendation that will be followed is that regions consisting of twelve (12) Student Congress debaters or fewer need **NOT** have a competition at the regional level. ~~In order to determine whether such a competition is necessary, it is being asked that you complete~~ pre-registration form linked on the first page under "Registration".

Per the VHSL Manual - "The number of representatives or senators participating determines whether the meet is divided into multiple chambers. In general, 24 representatives or senators per chamber is ideal, with chambers ranging in size from 15 to 30 members. If there is to be more than one chamber, schools and regions should be split equally between or among chambers. At the regional tournament, each chamber should meet between two and four sessions, as determined by the Clerk of Congress."

Tournament set-up will be finalized after all Tabroom.com registrations and/or entry forms have been submitted to their respective tournament director.

Tournament format finalization will be communicated following the registration deadline.

At that time any, and all, coach's decisions will need to be made and communicated back to that coach's respective tournament director before the date of the tournament, otherwise the tournament will proceed with school seeing school (see below by "Coach's Decision").

**Coach's
Decision(s):**

Per the VHSL Debate Manual, coach's decisions will apply to a round robin format only.

If a tournament is set-up with preliminary rounds followed by elimination rounds schools will not face themselves in the preliminary rounds.

“In this format, (round robin) each team would be assigned a debate against each of the other teams. If that involves a debate against a team from the same school, the coach must state at the time of entry whether:

1. The teams/individuals shall debate as scheduled.
2. The ballot shall be awarded to the team/individual with the ***higher*** overall record, and all competitors will receive speaker points and ranks from the average of all rounds.
3. The ballot shall be awarded to the team/individual with the ***lower*** overall record, and all competitors will receive speaker points and ranks from the average of all rounds.
4. The ballot shall be awarded to the team/individual ***specified by the coach***, and all competitors will receive speaker points and ranks from the average of all rounds.

Judges:

The tournament will attempt to provide independent, qualified judges. However, each school is asked to provide a judge (1) if they have ***any*** entries in Lincoln-Douglas Debate AND a judge (1) if they have ***any*** entries in Public Forum Debate. The coach may serve as one of these judge requests if so desired.

Judges will be paid the going rate. If a coach is called upon to judge they should not necessarily expect payment due to the obligation of being present and prepared with judges in the first place. Judges are required to attend the training at the beginning of the day and any violations of the appropriate behavior form (including disclosures) may also be grounds for withholding payment.

**Coach’s/Judge’s
Lounge:**

There will be a judge lounge set-up in Zoom to pool judges together following round completion so that ballots may be worked on. There will also be a chat space via Google Hangouts set-up for communication during the tournament - school e-mail accounts tend to not allow this so please plan on using a personal account or you may communicate via e-mail/text with the tournament director(s) throughout the course of the tournament.

Tab Room:

Tabulation will be done through Tabroom.com with tournament directors staying in the general area of Zoom for questions/concerns as they arise.

Team / Debater Area(s):	<p>Debaters are to remain in their competition space as they will be moved by our resident Zoom Master to their different locations requiring no input on their part.</p> <p>If teams would like to set-up their own personal space via their own Zoom or Google Meet or whatever other service that team prefers that is up to the coach.</p>
Observers:	<p>Coaches, debaters and other school representatives are free to discuss strategies and opposing teams, even to ask a team what it is running. All that is fine as long as they fully identify themselves by name and are clear and accurate about their association with any and all schools that they might represent. It must also be understood that following that disclosure, the participants in a debate have no obligation to permit the visitors to remain in the room. Those asked about cases or defenses, their own or those of another school, are under no obligation to provide the information. A school whose coaches, student debaters or other representatives fail to provide full and accurate disclosure or who unfairly pressure other participants into providing access or information they do not want to provide may be reported for unsportsmanlike conduct and discipline according to VHSL Rules and Regulations.</p>
Prohibitions:	<p>The following are prohibited during a VHSL Debate Tournament: videotaping of rounds, (this including recording of virtual tournaments) switching judging assignments without prior approval from the tab room and assigning half-points.</p>
Individual Awards:	<p>1st, 2nd and 3rd place winners will receive recognition (With 4th place in LD being announced as having qualified for the Super Regional Tournament). The 4th place finalist in Policy and Public Forum and 5th place in Lincoln-Douglas will also be announced as call-ups for their Super Regional tournaments. 1st, 2nd and 3rd place (and 4th in LD) will participate in the Class 1-3 Central and North and Class 5 - C and D Super Regional Tournament(s).</p> <p>No substitutions are allowed by VHSL rules (111.1.1). Awards will be announced via Zoom breakout room with all competitors/coaches present as they are able.</p> <p>Awards “Watch Parties” are recommended as schools are able to do so. Unmuting will be requested to recognize champions in their respective events.</p> <p>Any associated materials with awards (trophies, medals, certificates, etc.) will be handled and distributed by each region’s respective activities director.</p> <p>Speaker awards, if recognized, will be based on the preliminary rounds performance</p>
Team Awards:	<p>The team(s) with the greatest number of place points will be declared their Regional Champion. The team(s) with the second greatest number of place points will be declared their Regional runner up. First places earn 7 points, second places earn 5 points, third places earn 3 points, and fourth places earn 1 point. If there is a tie, the team with more first place winners will be declared their Regional Champion. If still tied, the total speaker points of the first place winners will break the tie.</p>

Final Results:

The results of the tournament will be official as announced and sent out to coaches unless challenged within **one hour (60 minutes) of the end of the announcements/email time** by any team. Any team not contacting within the 60 minutes window of opportunity after awards have been announced and results have been shared via email forfeits the ability to challenge the results. The official results will be forwarded to the VHSL office in Charlottesville, VA and the Super Region Tournament Director within 24 hours of the end of the announcements. Individual schools are responsible for registering for the Class 1-3 Central and North Super Regional Tournament and Class 5 C and D Super Regional Tournament.
