Students may enter up to three events, but no more than one draw event. Schools are not limited to a maximum number of entries. Events with at least one competitor, but lacking the required six, must be filled. **If your school is not part of the league, only non-qualifying students may participate.**

**Each league school is responsible for providing two judges.** Schools not in the league need to supply a judge for every 6 entries. These judges should have prior speech and drama judging experience. A speech or drama coach from a league school may not be used as one of these judges. However, coaches may be asked to judge as well if enough qualified judges cannot be found. If a school enters more than a full slate (18 entries), that school will provide one additional judge. All judges must be familiar with KSHSAA rules and judging criteria.

According to KSHSAA rules, a minimum of seven teams are required to participate. Non-league teams may be invited to attend the tournament if fewer than seven league teams are entered. These schools must be no larger than 3A. Non-league schools attending must bring one qualified judge for every six entries.

Medals shall be presented to the top three finishers in each event. Non-league competitors may medal in individual events. Plaques will be awarded to the 1<sup>st</sup> and 2<sup>nd</sup> place teams based on preliminary rankings. Only league schools participating will be eligible to receive plaques.

There will be a Hospitality Room for coaches, bus drivers, administrators, and judges. Students will either need to plan to purchase meals/snacks from the local convenient/grocery stores or bring their own. Cookies and other snacks will be provided for all.
