Registration

Registration closes on **March 29th at 5pm**. At this time, registration fees and judge commitments lock in. As you enter your entries, the committee will make sure that registration is correct for qualifiers so that we know that students are correctly entered. You must also make sure that students have waivers and all necessary information including performance information. You must also check your to make sure your judges have completed judge training. Because of the small window of time, we will **not** be able to allow for the 48 hour window to fix issues. So please make sure that you check your entries and get them in early. We will drop entries at no cost to the school if there are errors.

Judge Requirements

You will owe the following obligations -

1 Judge Per 10 IE Entries

1 Judge Per 5 Debate Entries

1 Judge Per 5 Congress Entries

Drops after Monday, March 29th (Judges and Entries) - \$25

Missed Rounds during Tournament(including missing from judge pool)- \$25

Missing Judges - \$60

Drops made after the entry deadline but prior to online registration are \$25.

Drops made during the tournament or post online registration are \$35. It's the coaches responsibility to confirm their entries.

We've divided the obligations up to equal \$60 - You must mark your availability. If you don't do this and then are assigned a round you are unable to judge, that is the same as a 'missing round' fee which is \$25 per ballot.

In addition, the Executive Council voted unanimously to allow for waivers for competitors who competed out of state, at the Cabot Classic, Har-Ber Speaker Series, and our Arkansas District Tournament to qualify as well as long as they competed at least one regional tournament.
