A Bill to Decriminalized Sex Workers

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. Sex work shall be decriminalized in the United States.
- SECTION 2. Sex work is defined as the provision of sexual services for money or goods, including physical sexual contact as well as non-physical sexual stimulation.
- SECTION 3. The enforcement of this legislation will be seen by the Department of Justice and the Department of Health and Human Services.
- SECTION 4. This bill will go into effect immediately following the fiscal year of September 2023.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Enforce Mask Mandates By Reducing Federal Funding of Public Schools

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1.** In order to slow the rise of COVID-19 cases and combat the Delta Variant, public schools within counties facing a spike in COVID cases shall be required to enforce a mask mandate or face a 6% loss in federal funding monthly.
- **SECTION 2**. A spike shall be defined as a 10% increase or greater in COVID-19 cases over a month-long period.
- **SECTION 3.** The Department of Education will oversee the implementation of this legislation.
- **SECTION 4.** This shall go into effect January 1 2022
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

- **SECTION 3.** The Department of Education shall oversee the implantation of this legislation. All funding for this legislation will be diverted from the Department of Defense.
- **SECTION 4.** This bill shall be implemented in the beginning of the fiscal year 2023
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

20	SECTION 5.	Accessory dwelling units are defined as housing units sharing a lot with a
21		detached single family home.
22	SECTION 4.	This legislation will take effect on October 1, 2021. All laws in conflict with
23		this legislation are hereby declared null and void.

A Bill to Tax Deforestation

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. All national or international corporations that engage with the act of deforestation within the United States shall hereby be taxed 3% of their yearly revenue. The funds collected from the tax shall be allocated to the process of reforestation within the United States.
- **SECTION 2**. A. Deforestation shall be defined as the action or process of clearing of forests or large swaths of trees for non-forest use.
 - B. Engaging with the act of deforestation shall be defined as funding deforestation and/or carrying out the act of deforestation.
 - C. Reforestation shall be defined as the act of intentional restocking of existing forests that have been depleted of trees.
- SECTION 3. The Department of the Interior's Environmental Protection Agency, alongside the Department of the Treasury's Internal Revenue Service, will oversee the implementation and enforcement of this bill.
- **SECTION 4.** This bill shall be implemented on January 1st, 2022.

- WHEREAS, Our failure to recognize Palestine has enabled Israeli settlers to take land that rightfully belongs to Palestine; and
- WHEREAS, Israel has violated many basic rights of the Palestinians, bombing places of worship and people's homes, detaining Palestinians and denying them education or medical care; and
- WHEREAS, Israeli settlers are settling in Palestinian terrority, displacing thousands of Palestinians; and
- WHEREAS, the illegal occupation of Israel has resulted in many protests around the

 world due to the fact that Palestinians are suffering, and we have turned

 a blind eye; now, therefore, be it

RESOLVED, By the Congress here assembled that the U.S. recognizes the state of Palestine, with its borders as agreed to by the United Nations prior to Israel's territorial expansion into Palestinian land in 1949.

A Bill to Aid the Afghan Refugee Crisis

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. The United States shall provide funding to aid the Afghan refugee crisis that has resulted from the Taliban takeover of Afghanistan.
- **SECTION 2**. The funding shall consist of a one-time payment of 3 billion dollars to be distributed between nations accepting Afghan refugees.
- SECTION 3. Aid shall be received and distributed by Non-Governmental

 Organizations (NGOs) and United Nations-based organizations in the regions of the nations accepting Afghan refugees.
- **SECTION 4.** The United State Agency for International Development (USAID) and the Office of the Inspector General (OIG) shall work in conjunction for the implementation, distribution of funds, and oversight of this legislation.
- **SECTION 5.** USAID shall allocate the funding included in this legislation from their Fiscal Year 2022 budget.
- **SECTION 6.** The Office of the Inspector General will monitor aid for evidence of misuse. If misuse is detected, aid payments to that NGO, organization, or nation will be discontinued in the future.
- **SECTION 7.** This legislation will take effect immediately upon passage.
- **SECTION 8.** All laws in conflict with this legislation are hereby declared null and void.
