Important FAQs

Q: Will internet use be allowed in Parliamentary Debate and Extemp?

A: We have decided to allow internet use for both events. Please remind your students that this may not be the case in future tournaments.

Q: How do both teams stay on screen during Parli prep?

A: Teams will mute their microphones. They will then need to find a way to communicate with each other during prep- phone, meets, zoom, etc.

Q: Are competitors allowed to be in the room for Impromptu?

A: Students will be allowed to listen to each other's speeches. Please instruct your students to always enter a room with their camera off and mic muted.

Q: How will students access their virtual rooms?

A: We are using NSDA Campus for all live events. Judges and students will be able to access the rooms through their tabroom account. (This is why it is so, so important to have linked accounts!!)
