

A Bill Requiring Men and Women to Register with the Selective Service System

BE IT ENACTED BY THIS STUDENT CONGRESS HERE ASSEMBLED THAT:

1 **Section 1:** Effective January 1st, 2023, all men and women aged 18 to 25 must register with the  
2 Selective Service System.

3 **Section 2:** A person failing to register for the Selective Service faces a maximum  
4 punishment of 5 years imprisonment and/or a fine of no more \$250,000. Failure to register  
5 prevents future employment with the federal government and disqualifies an individual from  
6 federal student aid.

7 **Section 3:** All laws in conflict with this legislation will be null and void.

# A Bill to Alter the Image of the Twenty Dollar Bill

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** All United States twenty dollar federal notes will be printed with American  
2 abolitionist Harriet Tubman's likeness and image, replacing the current  
3 image of President Andrew Jackson.

4 **SECTION 2.** The United States Treasury will have the task of creating the image of  
5 Harriet Tubman in the same way that it has created other images on United  
6 States currency.

7 A. The image Harriet Tubman, full-length portrait, standing with hands on  
8 back of a chair by Lindsley, Harvey B. as a reference.

9 B. The reference image shall be provided by courtesy of the Library of the  
10 Congress.

11 C. A Federal note is defined as paper currency produced by the U.S. mint  
12 and other U.S. Federal agencies.

13 **SECTION 3.** The printing of the new bills and the design of them will be managed by the  
14 Department of the Treasury.

15 **SECTION 4.** This bill shall be enacted January 1st, 2024. All laws in conflict with this  
16 legislation are hereby declared null and void.

# Judicial Reform Act

BE ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

**Section 1:** The number of Justices on the United States Supreme Court will change from nine to thirteen.

**A.** The Supreme Court shall be composed of one Chief Justice and twelve Associate Judges.

**Section 2:** All justices are restricted to serving one term on the Court.

**A.** All Associate Justices are limited to serving exclusively one sixteen-year term, established at the point of their swearing in. The Chief Justice shall be limited to serving exclusively one twenty-year term, established at the point of their swearing in. These limits on membership do not apply to Justices who are currently serving on the Court, before this bill is enacted into law.

**B.** The Supreme Court shall be divided into two panels; the two panels will be responsible for deciding whether a case is heard by the entire Court.

**C.** Each panel will be composed of 6 Associate Justices . Only 3 members of a panel will need to support a case being heard by the entire court.

**D.** For a Justice to be confirmed to the Supreme Court, three-fifths of the Senate must approve.

**E.** The Supreme Court shall provide live video footage of their proceedings on the Supreme Court's website.

**Section 3:** The Department of Justice shall oversee the appropriate enforcement of this legislation.

**A.** The Department of Justice will decide who shall be seated on each panel.

**Section 4:** This bill, if enacted, shall be in effect by January 11<sup>th</sup>, 2022.

**Section 5:** All other laws in conflict with this legislation are hereby null and void.

## **A Bill to Decrease Recidivism through Therapy**

**Article I:** The United States Department of Justice shall be required to provide a quarterly mandatory therapy session per year to all criminals of all offenses.

**Article II:** Mandatory therapy sessions shall be defined as quarterly annual meetings between the legal offender and a licensed psychologist running for an hour with support available in case the situation becomes violent.

**Article III:** The provisions of this bill shall take effect on June 21st, 2022.

**Article IV:** The United States Department of Justice shall be responsible for enforcing the provisions of this bill. The U.S. DOJ shall enforce this by:

- A. Creating a separate subcommittee that shall henceforth be referred to as the Criminal Reconstruction Agency who shall be responsible for:
  - a. Collecting and creating a means of reporting for each individual prison after all mandatory sessions have been completed.
  - b. Reporting any negligence to the U.S. DOJ for investigation into criminal welfare and life.
  - c. Subsidizing the price of hiring psychologists through reallocation of funds from the Crime Victims Fund and Criminal Reconstruction Fund.
  - d. Connecting licensed psychologists with prison networks.
    - i. Prisons shall be free to provide additional therapy sessions on their own payroll to criminal inhabitants.

**Article V:** All laws in conflict with the provisions of this bill shall be declared null and void.

2                     BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

3     **SECTION 1.** All federal, state, and local businesses will be required to  
4                     participate in this paid holiday.

5     **SECTION 2.** The first Tuesday in November will be designated as the  
6                     date for  
7                     the Presidential Election Federal Holiday.

8     **SECTION 3.** The United States Congress shall oversee this bill.

9                     1. This shall be observed every four years during presidential  
10                    elections.

11    **SECTION 4.** This shall go into effect July 1, 2022.

12    **SECTION 5.** All laws in conflict with this legislation are hereby declared  
                      null and void.

1     **A Bill for Government Recall on Standard Car Seat Belts to improve safety**  
2     **of female drivers.**

3                     BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

4     **SECTION 1.** All car manufacturers will be required to recall standard car seat belts to  
5                     be replaced by approved seat belts that will provide full protection for  
6                     female drivers.

7                             1. The odds of serious injury or death are much greater for any  
8                             seat-belt-wearing, female involved in a car crash than men.

9     **SECTION 2.** All car manufactures include those whose vehicles are marketed  
10                     and driven in the United States.

11    **SECTION 3.** The United States Transportation Administration shall oversee this bill.

12    **SECTION 4.** This shall go into effect July 1, 2022.

13    **SECTION 5.** All laws in conflict with this legislation are hereby declared  
14                     null and void.

**A bill requiring all Junior and Senior High Schools in Iowa to Discontinue the use of Native American Names as their School's Mascot.**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**Section 1.** The use of Native American names is inappropriate for schools in Iowa to be using.

**Section 2.** The use of a Native American tribe, chief, or any term associated with Native Americans shall be prohibited.

**Section 3.** The Iowa Board of Education and Iowa state legislature shall enforce this new law.

**Section 4.** This bill shall be implemented for the 2022-23 school year.

**Section 5.** All laws in conflict with this legislation are hereby declared null and void.
