The tournament will be held using Tabroom

  - *Broadcasting will be a Round 2 format (student written 3 min)*
- Videos must be uploaded to Tabroom **by Tuesday November 16<sup>th</sup> 8:00 pm Eastern.**

**COSTS**

School Fee = \$10

Single Entry = \$6 per entry & Double Entry = \$12 (Duo Interp, Duo Improv)

Entry Drops = \$10 single/\$20 double

Substitutions are free

Unfulfilled judge burden = \$40 per judge

Judge Drops = \$50

Judge No Show = \$30 per round

**AWARDS**

We will be giving medals to the top 6 speech performers in each event. Sweepstakes plaques will be given to the top 3 schools. Speech awards will be announced via a video link provided in an email on Saturday afternoon. Awards will be mailed within 2 weeks.

## JUDGES

You must provide one judge for every six entries or fraction thereof; 7 entries = 2 judges committed, etc. You may hire judges you do not provide for \$40 apiece. Your judges should be familiar with the KHSSL rules and ballots. Please ensure judges are linked on Tabroom and are aware of the schedule for judging preliminary rounds and final rounds (all asynchronous).

*To help us all meet our judge burdens, you can submit two judges to cover "one judge commitment" i.e. one can judge prelims and another can judge finals = one total judge commitment. If you do this, please email which judge plans to cover which time frame so I can properly strike them in Tabroom.*
