

A Bill to Have a First Use Policy for Nuclear Weapons

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The United States Ought to reaffirm our hegemonic power with
2 the adaption of a first use policies for nuclear weapons for the
3 defense of freedom in this world as it falls to the hands of
4 tyrannical nations. More nations are bending their knee to
5 nations at the cost of freedom and democracy, and peaceful
6 talks have failed, threats are the only thing that can move
7 nations in the modern day.

9 **SECTION 2.** First use policy shall be defined as the ability of a nation to use
10 their Nuclear weapons for reasons not necessarily restricted to
11 defensive purposes. Nuclear weapons shall be defined as

13 split or combine a nuclear atom.

15 **SECTION 3.** This bill shall be implemented by the United State Department

A Bill to Improve Local Law Enforcement

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** The United States federal government will implement new accountability
2 measures to ensure the fair and just treatment of its citizens.
- 3 **SECTION 2.** The U.S. Department of Justice will create a new task force specifically
4 designed for policing local police, with a specific emphasis on investigating
5 systemic constitutional violations.
- 6 **SECTION 3.** The task force will be given authority to implement rulings on widespread
7 issues, including but not limited to:
- 8 A. Suspension or firing of problematic officers
- 9 B. Restructuring of police department personnel and procedures
- 10 C. Reallocating department funds to alternative federal programs, such as
11 rehabilitation focused efforts, community outreach, or other social
12 activist programs with federal/state/local connections.
- 13 **SECTION 4.** Failure to comply with task force recommendations will result in an
14 immediate end of all federal funding for the organization under
15 investigation.
- 16 **SECTION 5.** This bill will go into effect on January 1st, 2022.

A Bill to Criminalize the use of Chemical Castration in the Criminal Justice System

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:
2. **SECTION 1:** The practice of utilizing chemical castration (here being defined as the use
3. of anaphrodisiac drugs for the purposes of inhibiting primary sex characteristics) as
4. a means of either parole or punishment is to be made a class B felony under federal law.
5. **SECTION 2:** Commissioning the use of chemical castration for the criminal justice
6. purposes outlined above will be made a class B felony under federal law.
7. **SECTION 3:** Any institutions within the criminal justice system found to be engaged in
8. the practice of retributive castration after the passage of this legislation will have all
9. federal funding revoked after three months, unless a complete report detailing who was
10. responsible for the authorization of the procedure is made, and those who are implicated
11. in the report are to be terminated and are barred from rehire.
12. **SECTION 4:** The Department of Justice and Bureau of Prisons shall be responsible for
13. the enforcement of this legislation.
14. **SECTION 5:** This legislation shall go into effect on June 1, 2022
15. **SECTION 6:** All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Amend the Constitution to Repeal the Second Amendment

1 **RESOLVED,** By two-thirds of the Congress here assembled, that the following article is
2 proposed as an amendment to the Constitution of the United States, which
3 shall be valid to all intents and purposes as part of the Constitution when
4 ratified by the legislatures of three-fourths of the several states within
5 seven years from the date of its submission by the Congress:

ARTICLE --

7 **SECTION 1:** The Second Amendment to the Constitution shall be
8 repealed.

9 **SECTION 2:** The Congress shall have power to enforce this article by
10 appropriate legislation.

A Bill for Selective Service

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

SECTION 1. The Selective Service System qualifiers will be revised. The qualifier for selective service will be all gun owners ages 18-35, regardless of gender. Individuals will be required to register for selective service within 30 days of ownership.

SECTION 2. Selective Service is defined as service in the armed forces by conscription.

Gun Ownership is defined as the ownership of a barrelled weapon from which any shot, bullet, or other missile can be discharged.

SECTION 3. The United States Selective Service System Agency in conjunction with the Federal Bureau of Investigations and the Department of Justice will oversee the implementation of this bill.

- a. The United States Selective Service System Agency will oversee the implementation of the selective service registration process.
- b. The Federal Bureau of Investigations will oversee the implementation of this bill when applying to gun ownership.
- c. The Department of Justice will oversee the implementation of this bill when applying to all penalties for the failure to register.

SECTION 4. This legislation will be implemented January 1, 2022.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

Introduced for Congressional Debate by Dubuque Hempstead

A Bill to Nationally Ban Conversion Therapy

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** The United States Government will put a national ban on conversion
2 therapy.
- 3 **SECTION 2.** Conversion therapy will be defined as is any attempt to change a person's
4 sexual orientation, gender identity, or gender expression.
- 5 **SECTION 3.** Individuals who are seeking conversion therapy for themselves and/or
6 their children will be required to attend family counseling.
- 7 **A.** Family counseling will be provided by the state through the Department
8 of Human Services.
- 9 **B.** DHS will determine if custody changes will be required in order to deal
10 with the situation.
- 11 **SECTION 4.** Companies offering services involving conversion therapy will be required
12 to end all services immediately upon passage. Failure to comply will
13 result in a monetary fine of \$10,000 per offense.
- 14 **SECTION 5.** All fines collected from this bill will go toward the psychological and/or
15 medical treatment of those affected by this bill.
- 16 **SECTION 6.** This bill will go into effect one week after passage..
- 17 **SECTION 7.** All laws in conflict with this law are considered null and void.

Introduced for Congressional Debate by **Bettendorf High School**.

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** Marijuana will be decriminalized in the United States of America and all
2 surrounding United States territories.

3 **SECTION 2.** Decriminalization in this case means that no person possessing less than
4 one kilogram of marijuana shall be prosecuted by the federal government
5 for possessing it.

6 **SECTION 3.** Those previously convicted of marijuana possession in federal court and
7 sentenced to longer than five years in prison shall no longer be required to
8 serve time. All individuals previously convicted of marijuana possession in
9 federal court shall automatically regain their right to vote.

10 **SECTION 4.** The Department of Justice shall be responsible for enacting this law.

11 **SECTION 5.** This section shall be implemented on April 20 of 2022.

12 **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Promote Safety on Film Sets

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** Functioning firearms and live ammunition, whether blanks or bullets, are
2 prohibited on any film set that requires a license or a permit.
- 3 **SECTION 2.** Any violation of this legislation shall be treated as reckless endangerment
4 and prosecuted accordingly based on the relevant portions of the penal
5 code in the jurisdiction where the crime occurs. Either the entire film
6 company or one or more specific individuals may be held culpable,
7 depending on the circumstances.
- 8 **SECTION 3.** This legislation shall be jointly overseen by local law enforcement and the
9 Occupational Safety and Health Administration (OSHA).
- 10 **SECTION 4.** This legislation shall take effect on January 1, 2022.
- 11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Declassify Area 51 Documents

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The Secretary of Defense is hereby ordered to declassify all documents
2 related to Homey Airport (XTA/KXTA), popularly known as Area 51, with the
3 exception of any documents the Secretary deems a material and
4 immediate threat to the security of the United States if declassified, though
5 any exceptions must be approved unanimously by the President, the Vice
6 President, the Speaker of the House of Representatives, and the President
7 Pro Tempore of the Senate.

8 **SECTION 2.** The Secretary will have six months from the passage of this bill to satisfy its
9 mandate, up to and including a full public release of these documents.
10 Should the Secretary fail to meet this deadline, Congress shall begin
11 impeachment proceedings against him and the duty to declassify will fall to
12 the Speaker of the House.

13 **SECTION 3.** This legislation shall take effect immediately upon passage.

14 **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Acknowledge and Apologize for the Role of the United States in the Holocaust

1 **WHEREAS,** Adolf Hitler drew direct inspiration for many of the most egregious
2 elements of his ideology and regime from American laws and society of the
3 time; and
4 **WHEREAS,** many prominent American figures vocally supported Hitler and Nazism
5 before and during the Holocaust; and
6 **WHEREAS,** America's failure to intervene in a timely and direct manner in the events
7 of the Holocaust resulted in much unnecessary death and trauma; now,
8 therefore be it
9 **RESOLVED** by the Congress here assembled that the United States formally
10 acknowledges its pivotal role in the leadup to the Holocaust as well as in
11 the Holocaust itself; and
12 **FURTHER RESOLVED** that the United States hereby apologizes to the victims of the
13 Holocaust, their families, and to all of humanity for the unforgivable role
14 our nation played in this, the greatest of all atrocities in human history; and
15 **FURTHER RESOLVED** that the United States formally commits to preventing and
16 combatting genocide in all its stages promptly and comprehensively from
17 this day forward.
