DIRECTIONS: The Parliamentarian should lead the chamber in setting its agenda for the day. The agenda should be set according to these guidelines:

- 1. B/R whose named author is in the chamber should be scheduled ahead of other B/R. These authors are entitled to an opportunity to present their B/R.
- 2. If the author is not in the chamber, another legislator from the school that submitted the B/R **may** act as the author of the B/R (if they do not have a B/R of their own).
- 3. B/R with no same-school sponsor should be scheduled after all sponsored items. Sponsors for these B/R will be chosen according to the rules of priority as the items come up for debate.
- 4. Every school with legislation is entitled to present one B/R before any school presents a second B/R.
- 5. Supplemental items, if any, must be placed at the end of the agenda.
- 6. **Once set, the agenda MAY NOT be reordered.** However, the chamber may use appropriate procedure to delay consideration of items, e.g., by postponing the Session 1 PO's B/R until Session 2.

A Bill to Prohibit the Use of Firearms in Motion Pictures

1	BE IT ENACT	TED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	It shall be unlawful for any person in the United States to use, display, exhibit,
3		brandish, or possess a firearm for depiction in a motion picture.
4	SECTION 2.	A. As used herein, "motion picture" includes film, television, streaming video,
5		and other similar formats in existence or to be invented.
6		B. The provisions of this bill do not apply to documentaries filmed live, nor to
7		individuals providing security to a motion picture site.
8		C. The provisions of this bill do not apply to non-working simulacra of firearms,
9		provided no actual firearms are on the set.
10	SECTION 3.	A. The Department of Labor and the Librarian of Congress shall be responsible
11		for enforcing the provisions of this bill.
12		B. Violation of the provisions of this bill shall be punishable by a fine not to
13		exceed \$250,000 per incidence.
14		C. Any motion picture produced in whole or in part after the effective date of this
15		bill which contains a violation of the provisions of this bill shall be ineligible for
16		copyright protection.
17	SECTION 4.	The provisions of this bill shall take effect six months after passage.
18	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Propose a Constitutional Amendment to Establish an Age Limit for Public Office

1	BE IT RESOLVED, By two-thirds of the Congress here assembled, that the following article is		
2	proposed as an amendment to the Constitution of the United States, which shall be		
3	valid to all intents and purposes as part of the Constitution when ratified by		
4	conventions in three-fourths of the several states:		
5	ARTICLE		
6	SECTION 1: No person shall hold any elected or appointed office under the		
7	United States or any State if that person shall have attained to the		
8	age of seventy years.		
9	SECTION 2: This article shall be inoperative if the median life expectancy in the		
10	United States exceeds ninety years.		
11	SECTION 3: This article shall take effect four years after its ratification.		
12	SECTION 4: The Congress shall have power to enforce this article by		
13	appropriate legislation.
