### ***Event Rules***

#### **Lincoln-Douglas Debate**

The resolution will be the January-February NSDA topic. Lincoln-Douglas will follow the 6-3-7- 3-4-6-3 format, with 4 minutes of prep time. Ties will be broken based on record, adjusted points, total points, double-adjusted points, judge variance, opponent wins, and flip of a coin, in that order. The break will depend on the number of teams registered. The TOC bid is at VLD *finals*.

#### **Public Forum Debate**

The resolution will be the January NSDA topic. Ties will be broken using the same criteria as Lincoln-Douglas Debate. The event will probably break into double-octofinals. The TOC bid is at Varsity *quarterfinals*.



## ***Judging Requirements and Policies***

Teams should bring the following number of qualified judges:

PF: 1 judge / 2 teams  
LD: 1 judge / 2 entries

## ***Obligations***

Judges in LD and PF are obligated [this may change] to judge through octafinals, then **one round past the last full round in which their students are active.**

A number of judges may be available for hire. Requesting a hired judge does not guarantee that the request will be accepted. **Acceptances will be sent by email via tabroom.com. No school can hire out its entire obligation.**

## **Paradigms**

We expect all varsity judges to publish paradigms on tabroom.com; teams will only be able to strike judges if their own judges do have paradigms.

## **Tab & Ballots**

We will publicly post the results of every round in LD and PF after each round is tabbed, to serve as a confirmation. Though judges in debate events are not required to disclose their decisions, they are highly encouraged to do so and give feedback and critiques. Pairings will be posted on- line.

## **Awards**

All competitors reaching elimination rounds will receive awards. Logistical details for awards will be specified at a later date.



# ***Registration***

## **General Information**

All registration will take place online via the Tabroom tournament page. Please be sure to register before the deadline (Monday - Jan 24th, 2022).

## **Waitlist**

To accommodate as many teams as possible as efficiently as possible, we will open registration for the tournament on tabroom.com on a waitlist-only basis. Schools with a history of judge absences and unpaid fees will be given precedence for remaining on the waitlist until next year.

Waitlists will be cleared two weeks after registration opens.

## **Eligibility**

Only teams officially representing their own bona fide degree – issuing high schools are eligible to register. The tournament does not consider independent entries, camp entries, hybrid entries, entries made by parents or students or anonymous email accounts, etc. Schools with unique situations can apply for exemptions.

**Novice** is defined as a student in their first season (2021 - 2022) of debate competition at any level. **JV divisions** are limited to students not past their second year of debate competition at any level, including former middle school debaters. Coaches may contact the tournament directors if they wish to offer exceptions.



## ***Fees and Fines***

### **Registration Fees**

### **Fines and Deadlines**

Arriving with fewer judges than claimed:	\$500/judge
Unreported team drops day of tournament	\$100
Judge misses a preliminary round	\$50/round
Judge misses an elimination round	\$100/round
