

A Bill to Fund Gene Therapy Research

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States government shall allocate \$500 million towards funding the
3 research and development of gene therapy for medical purposes.

4 **SECTION 2.** A. “Gene therapy” shall be defined as any process wherein human genes are
5 modified in order to combat ailments such as, but not limited to, diseases, health
6 conditions, mutations, and viruses.

7 B. “Medical purposes” shall be defined as any circumstance wherein gene therapy
8 is legally and ethically used to mitigate the effects of such maladies.

9 **SECTION 3.** A. The Department of the Treasury shall be responsible for allocating the funding
10 for gene therapy research.

11 B. The U.S. Food and Drug Administration’s Center for Biologics Evaluation and
12 Research shall have jurisdiction over all research and shall enforce the
13 requirements of legality and ethicality dictated in this bill.

14 **SECTION 4.** The provisions of this bill shall take effect on January 1, 2023.

15 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ban Anti-Homeless Architecture

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All anti-homeless architecture will be banned in public areas.

3 **SECTION 2.** A. Anti-homeless architecture shall be defined as infrastructure purposely

13 C. States that fail to comply with this legislation will have their federal funding
14 from the Community Development Block Grant cut by 500 million dollars.

15 **SECTION 4.** The provisions of this bill shall take effect 30 months after passage.

16 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Assert Federal Authority over Refugee Placement

5 adversely any refugee placed within their jurisdiction under the provisions of this
6 bill.

7 **SECTION 3.** A. The Department of Homeland Security and the Department of Justice shall be
8 responsible for enforcing the provisions of this bill.

9 B. State and local governments and officials in violation of Section 2 of this bill
10 shall be subject to civil or criminal action under existing civil rights laws.

11 **SECTION 4.** The provisions of this bill shall take effect immediately upon passage.

12 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
