# **DEBATE FORMAT & TOPICS:**

#### **CONGRESS:**

- Here is the docket for this tournament.
- The docket is set and the pieces of legislation will be debated *in order*. This docket cannot be rearranged by the debaters or the presiding officer.
- We will be using direct questioning.

#### **LINCOLN DOUGLAS:**

- Will follow the 6-3-7-3-4-6-3 format with 4 minutes prep time.
- LD will debate the 2022 January/February LD debate topic set by the NSDA: Resolved: The appropriation of outer space by private entities is unjust.

#### **PUBLIC FORUM:**

- We will be using the NDSA pilot of the new speech times. This means both summary and prep time will be three minutes instead of two.
- PF will debate the 2022 February PF debate topic set by the NSDA.

#### **POLICY DEBATE:**

- Policy debate will debate the 2021-2022 debate topic: Resolved: The United States federal government should substantially increase its protection of water resources in the United States.
- The novice division will be limited to the NDCA novice policy packet.

## **AWARDS:**

The top six speakers in each division will be given an award. For PF, LD, and Policy, debaters advancing to elimination rounds will receive an award.

# FEES:

Policy -- \$25 Lincoln-Douglas Debate -- \$20 Public Forum -- \$25 Congress -- \$15

### JUDGE COVERAGE:

- Policy -- One judge per two teams. May be hired for \$150.
- Lincoln-Douglas One judge per two debaters. May be hired for \$125
- Public Forum One judge per two teams. May be hired for \$125
- Congressional Debate One judge per six debaters or part thereof. May be hired for \$15 per debater.

We will use online ballots in ALL events. Please make sure all of your judges have a tabroom.com account and that they bring a device on which they can fill out a ballot.

## OTHER:

<u>MAVERICKS:</u> Under no circumstances will a maverick competitor be allowed to enter the tournament. Exemptions will be allowed the day of the tournament if one member of a team (policy or PF) is unable to attend or unable to continue due to sickness.

**GRIEVANCE POLICY:** Any grievance must be brought to the tab room. The decisions will be made by the tournament director. All decisions are final.

#### HARASSMENT POLICY:
