

A Bill to Establish Federal Mandate of All Approved CDC Vaccines for Students

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 SECTION 1. All schools under the US Department of Education will require all
- 3 in person students to have all vaccines that have full approval of the FDA.
- 4 SECTION 2. Distance learning shall be defined as the education of students who are
- 5 not physically present at school. Furthermore, we shall define in-person learning as any

6 form of instructional interaction that occurs "in person" and in real time between teachers

- 7 and students.
- 8 SECTION 3. The enforcement of this bill shall be overseen by the State of Education.
- 9 A. Any schools failing to abide by this bill shall not receive federal
 10 for educational grant funds.
- 11 B. This bill shall encompass any school in the United States, such as
- 12 public schools, charter schools, private schools, colleges and universities.
- 13 C. Any school that applies for any type of federal educational grants must
- 14 follow this bill to be approved.
- 15 D. Any schools which follow distance learning protocol (and have
- 16 no extracurricular activities happening on campus) may be exempt from
- 17 this bill.
- 18 SECTION 4. This bill shall be enacted at the start of the 2022-2023 school year.
- 19 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

	A Bill to Create a Government-Mandated Assault Weapon Buyback Program
1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1. A federally run and funded program shall be set up to buy back all privately
3	owned firearms that fit under the definition of an "Assault Weapon" as listed in Section 2.
4	SECTION 2. Assault weapons shall be defined as "semiautomatic firearms with a large
5	magazine of ammunition that were designed and configured for rapid fire and combat use."
6	SECTION 3. Revenue to offset the funds lost from this mandatory buyback shall be
7	gained through a new 15% excise tax all firearms bought and sold in the United States.
8	SECTION 4. The specifics of the buyback program are indicated as follows:
9	A. Drop off points will be set up at designated locations where
10	citizens can give up their weapons to be disposed of.
11	B. The amount given to citizens for each assault weapon will be based on the
12	market value of the specific firearm in its present condition.
13	C. Failure to comply by six months after this law goes into effect will result in
14	a two hundred dollar fine per month for each assault weapon.
15	SECTION 5. This law will take effect on February 5, 2022. If not renewed, the
16	provisions within this bill shall expire on February 5, 2027.
17	SECTION 6. This bill shall be carried out by the Departments of Homeland Security and the Treasury.
18	SECTION 7. All laws in conflict with this legislation are hereby declared null and void.



A Resolution to Grant Hawaii Sovereignty From the US Government

- 1 WHEREAS, There is a current Hawaiian Sovereignty movement and Hawaiians are
- 2 concerned with the state of their island because of the dependency on tourism and
- 3 the military.
- 4 WHEREAS, Hawaii's tourist economy has become harmful to the natives of the island,
- 5 resulting in high homelessness rates and higher prices.
- 6 WHEREAS, There is a scarce amount of land, and most of it is becoming
- 7 commercialized, therefore taken from the native people.
- 8 WHEREAS, In 1893 the Hawaiian government was illegally overthrown and unlawfully
- 9 annexed by the US government.
- 10 RESOLVED, By the Congress here assembled that the State of Hawaii shall have the

opportunity for sovereignty, that shall be voted on by the state if passed by the US Congress.

A Bill to Require Licenses for the use of Electric Bikes

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. California will require licenses for the use of electric bikes to prevent the ongoing and increasing crisis of car and bike accidents.

SECTION 2. A license shall be defined as a card perming a person to drive or operate a vehicle,

an electric bike license shall permit the operation of an electric bike on all streets excluding highways.

SECTION 3. The stipulations for these licenses shall be as follows:

Section A. All those 12 and older are eligible.

Section B. Those eligible must pass a multiple choice road safety test administered by the

Department of Motor Vehicles to receive a license.

SECTION 4. The California Department of Transportation shall oversee the enforcement of this bill.

SECTION 5. This legislation will take effect on January 1, 2023 .

SECTION 6. All laws in conflict with this legislation are hereby declared null and void.
