**RESOLVED,** that the Congress here assembled that food suppliers repurpose or recycle their

leftover food.

### A Bill to Enact the John Lewis Voting Rights Act

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. The Voting Rights Act of 1965 will be amended to revise the criteria for determining which States and political subdivisions are subject to section 4 of the Act, and for other purposes.
- **SECTION 2**. In order to effectively protect voting rights, the bill will:
  - 1) Broaden the scope of the courts in voting regulations,
  - 2) Restore federal pre-clearance of new state level voting laws and policies,
  - 3) Expand federal pre-clearance for changes to: election seats/jurisdictional changes, redistricting, voter ID requirements, multi-lingual voting materials, voting locations/opportunities, and voter roll maintenance.
- **SECTION 3.** Enforcement will be via the United States Department of Justice, and will allow the Attorney General or any US citizen to sue for compliance.
- **SECTION 4.** This legislation will take effect on July 1, 2022. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Require Colleges and Universities to Pay Student Athletes

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. Public and private Colleges and Universities will pay competitive athletes playing on behalf of their institutions.
- **SECTION 3.** The United States Department of Labor will oversee the implementation and enforcement of this legislation.
  - A. All active student athletes will be paid at least the federal minimum wage set by the US Department of Labor.
  - B. Pay may vary based on player performance
- **SECTION 4.** Implementation of this bill shall take place June 1, 2022
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

### A Bill to Mandate Covid-19 Vaccinations

3	SECTION 1. All United States citizens who are at least five years old should

	postponed until August 21, 2022 in order to allow previously

### A Bill to Mandate Organic Farming

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**SECTION 1.** Every farm will switch to Organic Farming by January 1, 2025.

SECTION 2. 3 Organic Farming will be defined as farming with a focus on renewable resources, soil and

4 water conservation, and management practices that restore, maintain and enhance

<sup>5</sup> ecological balance. Further, Organic Farming will be split into two categories Organic Crop

Farming and Organic Livestock Farming.

**SECTION 3.** 8 Organic Crop Farming will be defined as:

9 A. Use of cover crops, green manures, animal manures, and crop rotation to fertilize

the soil, maximize biological activity, and maintain long-term soil health;

12 B. Use of biological control, crop rotations and other techniques to manage weeds,

insects, and diseases and to increase biodiversity of the agricultural system and the

surrounding environment.

**SECTION 4.**16 Organic Livestock Farming will be defined as:

A. Use of rotational grazing and mixed forage pastures for livestock operations and

alternative health care for animal wellbeing;

B. Reduction of external and off-farm inputs and elimination of synthetic pesticides

and fertilizers and other materials, such as hormones and antibiotics.

**SECTION 5.** The US Department of Agriculture will oversee the details of this legislation.

**SECTION 6.** This legislation will take effect on September 1, 2022.

**SECTION 7.** All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Implement Fair and Equitable Representation in the United State House of Representatives

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

After the first article required enumeration in the United States Constitution, there shall be one representative for every 60, 000 constituents in a congressional district.

**SECTION 2.** Representatives will not be allowed to represent more than 60,000 people in a congressional district.

**SECTION 3.** On the first day, or within one week thereafter, of the first regular session of the 113° Congress, and of each fifth Congress thereafter, the President shall transmit to Congress a statement showing the whole number of persons in each State, and the number of Representatives that each State would be entitled to, based on the 60,000-person apportionment.

**SECTION 4.** No State shall receive less than one Member.

**SECTION 6.** This bill shall be implemented immediately upon passage.

**SECTION 7.** All laws in conflict with this legislation are hereby declared null and void.
