## **Arlington Legislation Addendum**

A Bill to halt all Russian Imports into the United States of America

Article 1: This bill is intended to punish Russia for its unwarranted war against the legitimate and sovereign nation of Ukraine and the Ukrainian people as well as threats made against other European nations.

Article 2: Ukraine is defined as a nation with borders as drawn as of January 1, 2005 well prior to the constant Russian aggressive moves to conquer some or all of legitimate Ukrainian territory including the separatist states in Eastern Ukraine and the Crimea.

Article 3: An embargo on imports and sales of all Russian products is effective as of March 15, 2022.

Article 4: Determination of what is a Russian product will be made by the Department of Commerce but includes any product manufactured, distributed, sold or produced legally or otherwise even if the product is sold by a non-Russian entity. All shipments in route as of March 15<sup>th</sup> or thereafter shall be refused by the US Customs Department. Stockpiles of Russian material in the United States may not be sold internally within the United States after March 15<sup>th</sup>. If it is Russian manufactured, distributed, sold or produced, the embargo shall apply.

Article 5: All laws in conflict with this legislation are void until such time as the President certifies to Congress that Russia is no longer a threat to Ukraine or other European nations.

## A Bill To End Solitary Confinement in Prisons

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**Article 1.** More than 80,000 people are in solitary confinement within American prisons. This extensive cruel and unusual punishment would be fully banned in all United States incarceration facilities.

**Article 2.** Solitary confinement will be defined as the isolated incarceration of a prisoner in a separate cell without human interaction or eye contact for an extended period of time (more than two days).

**Article 3.** The Criminal Justice Department and the Bureau of Prisons (BoP) will be responsible for overseeing the elimination of solitary confinement practices.

**Article 4.** All enforcement of the current federal standards allowing solitary confinement will be overturned when this legislation takes effect on January 31, 2022.

Article 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill To Increase The Use OCO's

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**Article 1.** The United States Federal Government will increase the funding to OCO's by 25 billion dollars.

**Article 2.** OCO's, or Offensive Cyber Operations, will be defined as operations that "project power by application of force in or through cyberspace."

**Article 3.** The United States Department of Defense (DoD) will become responsible for directing the funds appropriately.

A. The United States Cyber Command will be responsible for deploying the new OCO's when necessary.

Article 4. This legislation will take effect immediately after its passing.

**Article 5.** All laws in conflict with this legislation are hereby declared null and void.

## A Bill To End The Cuban Embargo

- **Article 3.** This legislation would take effect on July 1, 2022.
