A BILL TO BAN RESIDENTIAL ZONING TO MAKE OUR COUNTRY GREAT

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. Any zoning codes which are listed as "R1", "R2" or any restrictive zoning similar
- 2. to it can no longer be used in any municipal zoning code.

A Bill to Zhoosh Alternative Power Sources (ZAPS)

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United States shall reduce the importation of non-medical Lithium by 15% annually and allocate 1.5 billion dollars to the Environmental Protection Agency to research sustainable alternatives to lithium-ion batteries.

SECTION 2. Lithium is the chemical element of atomic number 3, a soft silver-white metal. It is the lightest of the alkali metals. Lithium-ion batteries are used to produce lightweight, rechargeable power for laptops, phones and electric vehicles.

SECTION 3.

A. The United States Department of Homeland Security- Customs and Border Control shall enforce the new regulations as a part of their existing duties.

B. The Environmental Protection Agency shall use 1.5 billion dollars to explore battery alternatives including, but not limited to iron, silicone, aluminum, and magnesium, and analyze their efficiency and sustainability.

SECTION 4. This law shall go into effect on January 1, 2023 and a reduction of 15% of non-medical lithium imports shall go into effect every successive year on January 1. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A BILL TO REQUIRE ALL U.S. CITIZENS TO GET ALL VACCINES

A BILL TO LEGALIZE EUTHANASIA IN TERMINALLY ILL PATIENTS

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. This bill would legalize euthanasia for terminally ill patients in the 3 United States.

4 **SECTION 2.** Euthanasia is an act of self assisted suicide. 10 SECTION 4. This bill will go into effect September 7th of 2023 upon passage.

11 SECTION 5. All laws in conflict with this bill are hereby declared null and void.
