# **A Bill to Prevent Prescription Drug Abuse**

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The United States shall safely slow down the production of abused
2		prescribed drugs. To keep up with reduced production, medical
3		professionals will prescribe fewer doses of abused prescription drugs
4		unless a life-threatening situation requires otherwise.
5	SECTION 2.	To reduce the number of prescription drugs that are abused, one must
6		gradually consume smaller and smaller doses.
7	SECTION 3.	This legislation is defined by the following: "An abused prescribed drug is
8		obtained only with a doctor's prescription." The most commonly abused
9		prescription drugs are opioids, heroin, synthetic opioids such as fentanyl,
10		and painkillers like oxycodone, hydrocodone, codeine, morphine, and many
11		others. "Life-threatening situation" is defined as a situation in which a
12		medical professional deems such drugs necessary.
13	SECTION 4.	The bill's implementation and operation will be supervised by the U.S. Food
14		and Drug Administration and the Substance Abuse and Mental Health
15		Services Administration (SAMHSA).
16	SECTION 5.	The legislation will go into action as early as January 1st, 2023.
17	SECTION 6.	All laws in conflict with this legislation are hereby declared null and void.

## A Resolution to Pass the Taiwan PLUS Act

1	WHEREAS,	Enhanced support for defense cooperation with Taiwan is critical to the
2		national security of the United States; and
3	WHEREAS,	Taiwan is recognized by 15 countries as an independent state, and it is
4		presently treated as a major non-NATO ally by the United States under
5		section 1206 of the Foreign Relations Authorization Act; and
6	WHEREAS,	Taiwan is the 10th largest trading partner in goods with the United States
7		and a technological powerhouse; and
8	WHEREAS,	Taiwan is a leading democracy and a key partner in the Indo-Pacific; now,
9		therefore, be it
10	RESOLVED,	That the Congress here assembled move with haste to pass H.R. 2103, the
		Taiwan PLUS Act.

## A Bill to Improve the Quality of Life for Bears in Zoos

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	This bill will ensure that zoos around the country will take steps to improve
2		bears' lives and end their stress, anxiety, or boredom-induced pacing
3		habits.
4	SECTION 2.	Zoos will be funded \$10,000 each in order to provide enriching activities
5		and outdoor or outdoor-inspired enclosures for their bears to limit pacing.
6	SECTION 3.	"Enriching activities", as mentioned in Section 2, will be defined as any
7		piece of equipment or toy added to a bear's enclosure that provides
8		entertainment. This includes, but is not limited to, the following: swimming
9		pools, colorful toys, and digging pits.
10	SECTION 4.	"Outdoor-inspired enclosures" will be defined as enclosures that
11		incorporate nature into bear enclosures to imitate real wildlife and
12		decrease pacing in bears.
13	SECTION 5.	The Association of Zoos and Aquariums will fund and oversee this project.
14	SECTION 6.	This legislation will take effect immediately upon passage.
15	SECTION 7.	All laws in conflict with this legislation are hereby declared null and void.

# **A Bill to Enforce Mandatory Military Service**

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The purpose of this bill is to enforce mandatory military service in the
2		United States.
3	SECTION 2.	Mandatory Military Service shall be defined as a period in which a person
4		must enroll in the military.
5	SECTION 3.	The Department of Defense shall be in charge of enforcing this bill.
6		A. The period of Mandatory Military Service shall be 300 days.
7		B. A person must enroll for service before the age of thirty.
8		C. A person can only be excluded from the service if they prove the same
9		requirements to avoid the standard draft.
10	SECTION 4.	This legislation will go into effect at the beginning of 2025.
11	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Legalize Non-Vital Organ Sales

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The sale of non-vital organs to public or private entities is hereby legalized.
2		Non-vital organs may only be harvested and sold from living, consenting
3		adults over the age of 18.
4	SECTION 2.	A non-vital organ is an organ that can be removed from a person without
5		affecting the quality of life (one kidney, portions of the liver and
6		gallbladder, etc.) A consenting adult is someone who has the cognitive and
7		mental ability to fully understand the implications of organ removal.
8	SECTION 3.	The Department of Health and Human Services and the Department of
9		Justice will oversee the implementation and enforcement of this
10		legislation.
11		A. Black Market organ sales remain illegal, and individuals caught selling
12		or providing illegal organs will face legal consequences.
13		B. Insurance companies will work in conjunction with service providers to
14		determine levels of coverage.
15	SECTION 4.	This legislation shall take effect on March 1, 2023.
16	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Reform Prison Labor Pay

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The Fair Labor Standards Act (FLSA) is amended to explicitly extend
2		protection to all incarcerated individuals.
3	SECTION 2.	The Federal Bureau of Prisons shall oversee this legislation.
4	SECTION 3.	This legislation will take effect on January 1, 2023. All laws in conflict with
5		this legislation are hereby declared null and void.

## **The Paid Parental Leave Act**

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Parent(s) of children born in the United States are entitled to 12 weeks of
2		paid parental leave, available during the 12-month period following the
3		birth, adoption, or placement of a new child.
4	SECTION 2.	"Parent" is defined as a legal guardian to a child. To apply for paid leave, a
5		parent must be a citizen of the United States.
6	SECTION 3.	A Parent shall receive the minimum wage for all hours of said 12-week
7		period. If a child is raised by multiple parents, only one parent is entitled to
8		apply for this wage.
9	SECTION 4.	A Parent applying for this wage must provide a birth certificate and proof
10		of their citizenship to receive paid leave.
11	SECTION 5.	A 1% tax on the income tax of the top 10% of wage earners shall be
12		implemented to fund this bill.
13	SECTION 6.	This shall be overseen by the Department of Labor. The DoL shall expand
14		its application process for paid parental leave to all citizens. The
15		International Revenue Service shall handle the calculation and transfer of
16		money collected from the Section 5 tax. This money will be transferred to
17		the Department of Labor for any additional funding.
18	SECTION 7.	This legislation will take effect in FY 2023.
19	SECTION 8.	All laws in conflict with this legislation are hereby declared null and void.

## A Resolution to Reopen North Korean Nuclear Talks to Decrease Nuclear Tension

WHEREAS, The North Korean Nuclear Program is a threat of national security; and

WHEREAS, As we ended our Nuclear Weapons talks in 2019 due to failed negotiations and unfulfilled promises with Former President Trump, North Korea has cut off ideas of denuclearization,
