



## A Bill to Establish a New Control of Student Loans

**A Bill To Revise The Student Debt Relief Plan**

1. Article I: The Student Debt Relief Plan shall have loan forgiveness up to
2. \$5,000, instead of the previous \$10,000 loan forgiveness.
3. Article II: The Student Debt Relief Plan is a one time student loan debt relief
4. to ease borrowers into transitioning back to regular loan payments
5. from before the COVID-19 pandemic. Student debt relief is when an
6. allotted amount of money is no longer required to be paid back
7. from a past loan taken due to the cost of formal education. This
8. relief will be granted by application, due October 31st, 2022, for
9. those making under \$125,000 per year, or live in a household
10. earning under \$250,000. All exceptions and types of student debt
11. relief that is not up to \$10,000 in relief will stay the same, as
12. outlined by the original Student Debt Relief Plan.
13. Article III: This legislation will go into effect upon passage.
14. Article IV: The Federal Student Aid Office of the Department of Education will
15. oversee the enforcement of this bill.

17. null and void.

## Bill #811

### A Bill to Issue a Block Grant worth 1,000,000 to Each State Annually to Improve Inmate Healthcare

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1   **SECTION 1.**   1,000,000\$ be appropriated to each state annually in the form of a Block  
2                   Grant for the purpose of improving inmate healthcare. The funds will, in  
3                   part, specifically go towards eliminating all potential medical fees inmates  
4                   might pay.
- 5   **SECTION 2.**   A Block Grant is a form of congressional funding to the private or state  
6                   sector in which the funding allotted is largely up to the descretion of the  
7                   party receiving the grant.
- 8   **SECTION 3.**   This legislation will be implemented immediately upon its passing.
- 9   **SECTION 4.**   The United States Bureau oversees the implementation of this legislation.
- 10 **SECTION 5**   All laws in conflict with this legislation are hereby declared null and void.

**#931 - A Bill to Improve Accessibility to Medical Advising:**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1   **ARTICLE I:**   Inmates shall be granted access to both private and timely medical  
2                   appointments as well as need-based access to adequate medication without  
3                   copay.
- 4   **ARTICLE II:**   All doctors and other medical personnel must be properly trained and holding a  
5                   valid license in addition to having no prior criminal or withstanding charges.
- 6   **ARTICLE III:**   Any prescribed medication must be appropriate for the condition an inmate is  
7                   in and show signs of effectiveness within the result timeframe specific to each  
8                   medicine. Need-based signifies that inmates should be granted access to  
9                   medication as long as they need it to fight an infection.
- 10   **ARTICLE IV:**   Timely is defined as within a three-day period upon an inmate's request.
- 11   **ARTICLE V:**   This bill shall be carried out in its entirety no later than one year after the date  
12                   of its signing.
- 13   **ARTICLE VI:**   This Department of Justice (DOJ) and Federal Bureau of Prisons (BOP) shall  
14                   be responsible for the implementation of this bill.
- 15   **ARTICLE VII:**   All laws that are in conflict with this new policy are hereby declared null and  
16                   void.

A Bill to End Price Gouging in Healthcare

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1     ARTICLE I. Any healthcare organization that offers life saving care shall not charge more  
2     than 10% more than production costs.
- 3     ARTICLE II. Any governmental or private organization that conducts research, produces,  
4                 distributes, or provides medications or treatments required to lead a healthy  
5                 life will be defined as a healthcare organization.
- 6     ARTICLE III. The U.S Department of Health will allocate 250 million dollars to oversee  
7                 and audit organizations to ensure that the legislation is being enforced.  
8                 A. Organizations found to have violated this legislation will be fined 3 times  
9                 the profit made from violating products and services.  
10                B. In coordination with the Food and Drug Administration, repeat offenders  
11                face the possibility of losing certifications that allow them to create and  
12                sell these products and services.
- 12    ARTICLE IV. This legislation will take effect on June 1st, 2023.
- 13    ARTICLE V. All laws in conflict with this legislation are hereby declared null and void.

**SECTION I.** The Federal Loan Relief Agency (FLRA) shall be established, which shall forgive an amount of federal student loans owed by loan takers. The FLRA shall determine the amount of money to be forgiven; and

- A. The amount forgiven shall be an amount determined to be equally beneficial to the loan taker and available for the FLRA to forgive without extreme profit loss.
- B. It shall consider the loan taker's yearly gross income and the loan amount owed when calculating the amount to be forgiven. It shall forgive no more than \$15,000 and no fewer than \$100 per loan; and
- C. Loan takers must apply to the FLRA for loans to be considered for forgiveness, and the agency shall make applications reasonable easy to submit;
- D. It shall not forgive loans owed by any person who earns more than \$120,000 per year in gross income.

**SECTION II.** "Forgive" means to terminate an amount owed.  
"Loan taker" refers to a person who took a student loan, a loan used to pay for education. "Gross income" refers to the total amount of income earned per year, before taxes and bills are deducted.

**SECTION III.** This act will be implemented by the 1<sup>st</sup> of January, 2024.

**SECTION IV.** The Department of Education shall establish the FLRA and ensure the provisions of this Act are carried out.

**SECTION V.** All other laws found to be in conflict with this Act are hereby declared null and void.

Economically, Taiwan enjoys a market economy, which shares similarities to our capitalistic economy. As stated in, *Investopedia.com*, "*Capitalism refers to the creation of wealth and ownership of capital, production, and distribution, whereas a free market system has to do with the exchange of wealth or goods and services*".
