A Resolution to Amend Rule 22 of the Senate Manual to Eliminate the Filibuster

WHEREAS, The present-day filibuster restricts the productivity of the Senate; and

WHEREAS, The filibuster exists as a Jim Crow relic intended to impede the majority party; and

WHEREAS, The filibuster weakens legislation instead of promoting compromise; and

WHEREAS, Bypassing the filibuster requires 60 votes; now therefore, be it

RESOLVED, That the Congress here assembled make the following recommendation for an amendment to Section 2 of Rule 22 of the United States Senate Manual, changing "three-fifths" to "a simple majority."

Introduced for Congressional Debate by Eagan High School

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. Any individual running for Federal Office is required to have prior political experience in order to begin campaigning.

SECTION 2. "Federal office" shall be defined as the position of President or Vice President, of Senator or Representative, or Delegate or Resident Commissioner to, the Congress.

"Prior political experience" shall be defined as one or more of the following: Having been employed as a lawyer for at least 3 years, having served as a U.S. representative, held office as state or territorial governor, as a Senator, Vice President, Attorney General, or Secretary of State.

SECTION 3. If an individual is considering running for federal office, they must notify the Federal Election Commission before they begin campaigning. The Federal Election Commission Agency will be tasked with verifying that each candidate's political experience meets the requirements. Campaigning before certification is prohibited, and will result in a fine of up to 10,000 dollars.

SECTION 4. This legislation will go into effect January 1st, 2023

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Legalize Physician-Assisted Suicide Nationwide to Limit the Suffering of Terminally III Patients

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1		SECTION 1 . Physician-assisted suicide is henceforth legal nationwide in
2		the United States.
3	A.	The individual that is wishing to utilize physician-assisted suicide (henceforth
4		referred to as "the patient") must be at least 25 years of age.
5	В.	The patient must have a terminal illness with three confirmed prognoses of having
6		1 year or less to live.
7	C.	The patient must have their diagnosis of the terminal illness, prognosis, mental
8		competence, and voluntariness of their request confirmed by no less than three
9		physicians who all specialize in the treatment of the patient's terminal illness.
10		SECTION 2 . Physician-assisted suicide shall be defined as the legal,
11		voluntary termination of one's own life by prescription medication.
12		SECTION 3. The Department of Health and Human Services and the
13		Department of Justice shall oversee the implementation and enforcement
14		of this bill.
15	A.	Failure to meet the requirements provided by Section 1 will result in a $\$1.5$ million
16		fine for the physician that oversaw the process, as well as losing their medical
17		license.
18		SECTION 4. This legislation will take effect on January 1st, 2023. All laws
19		in conflict with this legislation are hereby declared null and void.

A Bill to Raise the Minimum Wage For School Teachers

SECTION 1. The national average salary is 58,260 dollars for teachers in the United States. This is one of the major reasons we are seeing a teacher shortage.

SECTION 2.

- A. Teachers are defined as education specialists that work in public and private schools. This bill includes preK-12 teachers.
- B. A large sum of American schools are underfunded, because of this, teachers use their own salaries to compensate for classroom material.
- C. The national average budget for teachers is \$212, which is rarely enough to afford basic material for classroom use.
- D. A liveable wage is 68,0000 dollars, however, this differs from states.

Section 3.

- A. Teacher's wage mentioned in Section 2A will be granted as follow:
 - a. Wages are raised \$9,000 above the livable wage of the state for teachers who make less than the state's livable wage.
 - b. Wages are raised \$9,000 above the livable wage for teachers who make between the state's livable wage but still under \$9,000 above the livable wage of the state.
- B. All schools are required to reimburse teachers for school supplies purchased for the school year
- C. All schools are subsidized an extra 50 percent of their projects and cost of operation.

SECTION 4.

- A. The Department of Education will be funding Section 3A and 3B, extra funding will be transferred from the Department of Defense if need be. The Department of Labor will be responsible for reporting current wages and determining the amount for fund distribution per state.
- B. The Department of Education will be responsible for managing Section 3B and funding Section 3C.

SECTION 5. This legislation will be implemented in the fiscal year of 2025.

A Bill to Establish a Term Limit Rotation of Supreme Court Justices

The Tax Act

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1.

- A. All federal subsidies shall be eliminated.
- B. The Tiered Income Tax will be replaced by a Flat Income Tax.
- C. The Flat Income Tax Rate shall be set to 25%.

SECTION 2.

- A. A federal subsidy shall be defined as any direct or indirect payment to an individual or company which comes in the form of a tax cut.
- B. The tiered income tax shall be defined as the system in which individuals are placed into tax brackets which determines the rate at which they pay taxes.
- C. The flat income tax shall be defined as the system in which every individual is charged the same income tax rate.
- **SECTION 3.** This bill shall be implemented by the Internal Revenue Service.
- **SECTION 4.** This bill shall be implemented one year after passing.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
