Contributions to such organizations are deductible by donors as provided in section 170 of the Internal Revenue Code. Bequests, legacies, devices, transfers or gifts to/or for their use are deductible for Federal, estate and gift tax purposes under the provisions of the sections 2055, 2106 and 2522 of the Code. Accordingly independent school districts are not covered by IRS Code 50l(c)(3).
