## A Resolution to Amend the Constitution to Limit the Presidential Power to Pardon

1	RESOLVED,	By two-thirds of the Congress here assembled, that the
2	following arti	cle is proposed as an amendment to the Constitution of the
3	United States	, which shall be valid to all intents and purposes as part of
4	the Constitut	ion when ratified by the legislatures of three-fourths of the
5	several states	s within seven years from the date of its submission by the
6	Congress:	
7		ARTICLE
8	SECTION 1:	The President's power to grant judicial pardons and
9		commutations, outlined in Article 2 Section 2 of the
10		Constitution, shall now read "they shall have Power to
11		grant Reprieves and Pardons for Offences against the
12		United States, except in Cases of Impeachment,
13		themselves, or any with verifiable connection which may
14		be deemed influential to the President's decision to
15		pardon".
16	SECTION 2:	The Congress shall have power to enforce this article by
		appropriate legislation.

# A BILL TO INCENTIVIZE THE PROTECTION OF ENDANGERED PLANT SPECIES TO PRESERVE BIODIVERSITY

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

**SECTION 1**. Any person who is found collecting endangered plant species on private property will be fined up to \$100 for each plant taken or destroyed.

**SECTION 2**. An "endangered species" will be defined as a species that is proposed or listed as endangered or threatened under the Endangered Species Act (ESA).

**SECTION 3.** The United States Fish and Wildlife Service will oversee the enforcement of this legislation.

**SECTION 4.** This legislation will take effect immediately upon passage.

**SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# Bill #3082 A Bill to End Partisan Gerrymandering

### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Independent redistricting committees shall be formed to redraw the United
2		State's congressional district maps for their respective states to prevent the
3		act of partisan gerrymandering.
4	SECTION 2.	Gerrymandering is defined as the process of redrawing legislative
5		boundaries for the purpose of benefiting the political party in power, or to
6		achieve a result by manipulating the boundaries of an electoral
7		constituency.
8		A. Independent committees shall be defined as committees which do not
9		consist of a local, state, or federal government official.
10		B. The redistricting committees shall be selected randomly from the adult
11		population of each state.
12	SECTION 3.	The United States Census Bureau will oversee the implementation of this
13		legislation.
14		A. Committees will be re-selected immediately following the results of the
15		U.S. Census every 10 years.
16	SECTION 4.	This legislation will take effect on FY 2025.
17	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

## A BILL TO TAX UNIVERSITY ENDOWMENTS

1	BE IT ENACT	TED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The Tax Cuts and Jobs Act of 2017 (TCJA) shall be amended to increase
3		the tax on investment income for private colleges & universities and lower
4		the threshold for being subject to said tax.
5	SECTION 2.	(A) Private colleges with endowments in excess of \$250,000 per student
6		shall be subject to an annual excise amounting to 10% of their net
7		investment profits.
8		(B) This tax shall replace the tax established by the TCJA of 1.4% on
9		institutions with endowments in excess of \$500,000 per student.
10	SECTION 3.	The Department of the Treasury shall be tasked with the enforcement of
11		this legislation.
12	SECTION 4.	This bill will go into effect January 1 <sup>st</sup> , 2025.
13	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

### A Bill to Criminalize All Production and Consumption of Meat

1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1. Production and Consumption of all Meat for human consumption
3	will be declared federally illegal. This extends to production by private individuals
4	as well as commercial organizations. Consumption by any human outside of a
5	provable emergency context will be illegal. Proven producers of meat will be
5	sentenced to a mandatory minimum of 5 years in prison and up to life depending
7	on the severity of the offense. Proven consumers of meat will receive a mandatory
3	minimum sentence of 1 year in prison for every separate conviction.
)	SECTION 2. Production is defined as, "Harvesting of any animal products that
10	involve lethal methods to procure the product."
11	Consumption is defined as, "Any usage of animal product in which
12	the product required an animal death to be utilized."
13	Emergency Context is defined as, "A scenario in which animal
14	consumption was required to save the life of a human and where no
15	suitable alternative product was reasonably available."
16	Commercial Organization is defined as, "Any public or private
17	entity."
18	<b>SECTION 3.</b> This law will be enforced by The Office of Agricultural Law
19	Enforcement (OALE) as well as The United States Department of
20	Justice
21	<b>SECTION 4.</b> This legislation will take effect no later than August 11th 2024
3	<b>SECTION 5.</b> All laws in conflict with this legislation are hereby declared null
)	and void.

## A Bill to Reduce the United States' Military Presence in Germany

- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# Bill #3084 A Bill to Decriminalize Marijuana

### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The United States will decriminalize the use of marijuana in all states by
2		removing it from the list of scheduled substances under the Controlled
3		Substance Act.
4	SECTION 2.	Marijuana refers to the dried flowers, leaves, stems, and seeds of the
5		cannabis plant. Marijuana is commonly used to treat many medical
6		conditions and symptoms. Such as anxiety, nausea, pain, inflammation, and
7		muscle spasms.
8		B. Decriminalization is defined as the action of ceasing to treat something
9		as illegal or as a criminal offense. The legalized amount that is fit for
10		consumption is one ounce.
11		C. The Controlled Substance Act is defined under Title 21 of the United
12		States Code. It places all substances which were in some manner regulated
13		under existing federal law into one of five schedules.
14	SECTION 3.	The Drug Enforcement Administration (DEA) will oversee the
15		decriminalization and implementation of this bill.
16	SECTION 4.	This legislation will take effect on January 1, 2024.
17	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Repeal the Dodd-Frank Wall Street Reform and **Consumer Protection Act**

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The Dodd-Frank Wall Street Reform and Consumer Protection Act shall
3		be repealed, and all institutions created by it shall be dissolved.
4		A. All regulation created in reference to The Dodd-Frank Wall Street
5		Reform and Consumer Protection Act shall be hereby repealed, and
6		any institutions created by such regulation shall also be dissolved.
7		B. All institutions whose powers were expanded by The Dodd-Frank Wall
8		Street Reform and Consumer Protection Act or any regulation related
9		to it shall have such powers revoked.
10	SECTION 2.	A regulation created in reference to The Dodd-Frank Wall Street Reform
11		and Consumer Protection Act is any piece of legislation whose meaning is
12		changed by this bill.
13	SECTION 3.	The Federal Deposit Insurance Corporation and The Federal Reserve shall
14		be tasked with implementing this bill.
15	A.	The Federal Deposit Insurance Corporation shall be charged with
16		implementing this bill as it pertains to Commercial Banks.
17	В.	The Federal Reserve shall be charged with implementing this bill as it
18		pertains to all other financial institutions.
19	SECTION 4.	This bill shall go into effect on January 1, 2024, and all laws in conflict

with this legislation are hereby declared null and void.

### Bill #3085

## A Bill to Forgive Student Loan Debt for Impoverished People

### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The Biden-Harris Administration student loan forgiveness plan will be
2		extended for 3 more years after its scheduled deadline, until
3		December 31, 2025.
4	SECTION 2.	Borrowers are eligible for debt relief if their individual income is less than
5		\$125,000, and \$250,000 for married couples.
6		A. These individuals can have up to \$20,000 in qualifying student loan debt
7		forgiven if they received a Pell Grant, and up to \$10,000 if they didn't.
8	SECTION 3.	The United States Department of Education and the Office of Federal
9		Student Aid will provide debt cancellation to those eligible recipients.
10	SECTION 4.	This legislation will take effect on FY 2025.
11	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

### A BILL TO REQUIRE CHILDHOOD IMMUNIZATIONS

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1: Children in the United States shall receive all childhood immunizations at the appropriate ages. However, children with cancer or children taking drugs that lower the body's immunization shall be exempt until their immunities are back to normal.

SECTION 2: Children shall be defined as "a person between birth and full growth; anyone between the ages of 1 month to the day before their 18<sup>th</sup> birthday." Childhood immunizations shall be defined as, "vaccines that protect children from more than a dozen childhood diseases."

SECTION 3: The United States Department of Health and Human Services (DHHS) shall oversee the implementation of this bill

- A. All parents/guardians who do not vaccinate their children will be charges with felony child endangerment and shall be imprisoned for between 1-10 years.
- B. Children who do not receive vaccines will not be allowed to attend school until they receive said vaccinations.
- C. Vaccines will be subsidized for those who are unable to afford it and are in the lowest tax bracket.

SECTION 4: This law shall go into effect immediately upon passage.

SECTION 5: All laws in conflict with this legislation are hereby declared null and void.
