

#### A Bill to Fund Photobioreactors

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. \$100 billion dollars will be allocated to fund the implementation and research of photobioreactors.
  - A. Of the \$100 billion dollars 70% will be put towards the implementation of photobioreactors and the other 30% will be sent to researchers to improve the efficiency of photobioreactors.
- **SECTION 2**. A photobioreactor will be defined as an installation for the production of microorganisms in an artificial environment.
  - A. For the purposes of this bill microorganisms will be constricted to algae
- **SECTION 3.** The Environmental Protection Agency shall oversee the enforcement of this bill.
  - A. The funding for this bill shall be allocated from the annual budget of the Department of Defense.
- **SECTION 4.** This legislation will take effect at the start of Fiscal Year 2023.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Regulate Online Sports Betting

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**SECTION 1**. The Unlawful Internet Gambling Enforcement Act of 2006 (31 USC 5361-5366) shall be edited to include online sports betting as a form of unlawful online gambling

SECTION 2. Online sports betting is defined as any form of money transfer from a participant towards another group as a form of wagering on sporting events as a means to generate revenue for the receiving party

SECTION 3. This legislation shall be enforced by the Federal Trade

Commission

A. Any party who knowingly receives financial compensation as a form of gambling shall face a fine of no more than 25,000 dollars per instance

**SECTION 4.** This legislation shall take effect at the beginning of FY 2024

**SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## The A.F.F.I.R.M.T.H.I.S. Bill (Applying the Founders' Federalism to Include the Regions like Malheur That Haven't been Included in their State)

#### BE IT ENACTED BY THIS CONGRESS HERE ASSEMBLED THAT:

**SECTION 1.** The border between the State of Oregon and the State of Idaho shall be adjusted to account for the political and cultural divide between the northwestern region of Oregon, dominated by Portland and Salem, and the rest of the state.

**SECTION 2.** As each of the following counties have voted "yes" on ballot measures to join the State of Idaho, and as all of the following counties form one contiguous region that produces no enclaves of either state, the Oregonian counties of **Klamath**, **Lake**, **Harney**, **Malheur**, **Grant**, **Baker**, and **Union**, hereafter collectively referred to as "Oregonian Idaho," shall be integrated into the state of Idaho.

#### **SECTION 3.** Regarding federal congressional representation:

- A. Oregonian Idaho shall join Idaho's first congressional district.
- B. Due to the comparatively small population of Oregonian Idaho, the number of federal house seats and electoral college votes from each state shall remain unchanged.
- C. As most of Oregonian Idaho comprises what is currently Oregon's second congressional district, all remaining land in Oregon's second district shall be annexed by Oregon's fifth district.

#### **SECTION 4.** Regarding state-level representation:

A. The States of Oregon and Idaho shall oversee the redistricting of their own state-level legislative districts within the existing federal constraints.



## A Bill to Make Community College Free

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1		SECTION 1.	All students in low-income households attending a

4		academic yea	rs in order to obtain an Associate's degree.

## A Bill to Save the American Public School System

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	A) The United States Government shall hold the power to tax
2		private schools 5% of their yearly income.
3		B) Charter schools shall in all ways become assimilated into the public
4		school district it is closest to geographically.
5		C) A 10% Value-Added Tax (VAT) shall be enforced on the purchase of all
6		internet-accessible cellular electronic devices such as phones, tablets, and
7		computers.
8		D) The money allocated from these measures will be used to increase
9		funding to underprivileged schools when yearly budgeting decisions are
10		made.
11	SECTION 2.	A) Private schools shall be defined as schools which are privately owned
12		and funded.
13		B) Charter schools will be defined as schools who receive funding from the
14		local district, but are independently run.
15		C) Underprivileged schools shall be defined as schools who fall under Title I
16		funding requirements.
17		D) A Value-Added Tax is a tax put on products based on a percentage of
18		the production cost.
19		E) Schools are defined as any school teaching grades K3-12.
20	SECTION 3.	A) The United States Department of Education will oversee and enforce
21		implementation of this bill.
22	SECTION 4.	A) This legislation will take effect on July 20th, 2023.
23		B) All laws in conflict with this legislation are hereby declared null and void.

## The B.R.A.N.D. (Balance and Regulate All N.I.L. Deals) Ac BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**SECTION 1**. The abuse and vast wealth gained from all Name, Image, and Likeness deals shall be restricted to \$10,000 per deal with a limit of 5 deals a year per student athlete. No athletes shall be paid or incentivized to attend a specific college for monetary gain, scholarships aside.

**SECTION 2**. Name image and likeness (N.I.L) deals shall be defined as Name, Image, and Likeness deals that would involve a brand leveraging a student athlete's name, image, and/or likeness through marketing and/or promotional endeavors.

**SECTION 3.** This legislation shall be enforced by the Federal Trade Commission as well as further enforced by the NCAA

- A. Any athlete who violates these regulations shall be subject to a fine of at least the money gained over the threshold of \$5,000 as well as a restriction on future deals depending on the violation
- B. Any company or party who employs and uses an athlete's name, image and likeness and pays that athlete over \$10,000 per deal shall be punished as much \$50,000 in accordance with the FTC's minimum fine for violating an FTC act.

**SECTION 4.** This legislation shall take effect at the beginning of FY 2024

**SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Alter Geoeconomics on Estate Ownership to Redress Great inEquity (G.E.O.R.G.E)

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1.** A 5% Land Value Tax shall be levied on all Private Land, and Federal Income Tax shall be reduced by 5% across all tax brackets.
- **SECTION 2.** "Land Value Tax" is defined as a tax on the market value of any property minus the market value of the buildings on said property; "Private Land" is defined as any privately-owned real estate.
- **SECTION 3.** All Private Land shall be appraised by the Bureau of Land Management and collection of taxes shall be enforced by the Internal Revenue Service.
- **SECTION 4.** This legislation would take effect on Jan 1, 2024. All laws in conflict with this bill are hereby declared null and void.
