

A Bill to try to Santa Claus with a Federal Crime

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** Santa Claus will be tried for breaking and entering during the Holiday
2 season.

3 **SECTION 2.** Breaking and entering will be defined as the entering of a building
4 through force without authorization.

5 **SECTION 3.** The Federal Bureau of Investigation will investigate the alleged
6 crimes and later bring them to trial according to 28, Section 533 of
7 the U.S. Code.

9 **SECTION 4.** This legislation will take effect on January 1, 2023. All laws in
conflict with this legislation are hereby declared null and void.

A Bill to Utilize Drones During Present Delivery

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** Santa will retire the use of reindeer and implement the usage of
2 unmanned drone delivery for present and coal delivery to people
3 worldwide.

4 **SECTION 2.** Reindeer are defined as Dasher, Prancer, Vixen, Comet, Cupid,
5 Donner, Blitzen, and Rudolph. Unmanned drone delivery will be
6 defined as A delivery drone is an unmanned aerial vehicle (UAV) used
7 to transport packages, medical supplies, food, or other goods.

9 **SECTION 3.** The Federal Aviation Administration will oversee the implementation
10 of the bill.

SECTION 4. This legislation will take effect on December 23, 2022. All laws in
conflict with this legislation are hereby declared null and void.

A Bill to Put Russia on the Naughty List.

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** Father Frost and Snow Maiden will skip delivering presents to Russia

2 this holiday season.

3 **SECTION 2.** Father Frost is defined as the Slavic counterpart to Santa Claus.

4 **SECTION 3.** Father Frost and Snow Maiden will oversee the implementation.

5 **SECTION 4.** This legislation will take effect immediately upon passage. All laws in

6 conflict with this legislation are hereby declared null and void.

A BILL TO PROVIDE US MILITARY AID TO SANTA CLAUS

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1: Due to the success of the existing NORAD Tracks Santa Program, The United States shall formally offer Military Aid to Santa Claus and The North Pole Workshop Defense Agency in order to help facilitate the safe and expedited international delivery of Christmas Presents.

SECTION 2: US Military Aid shall be defined as any assistance, equipment, personnel and/or financing given from The United States of America to Santa Claus in order to ensure that Santa Claus is able to deliver his Christmas Presents to every single good child on his Nice List whilst avoiding those on his Naughty List.

SECTION 3: All branches of The United States Armed Forces will coordinate with The North Pole Workshop Defense Agency in order to ensure that Santa Claus is safely escorted throughout the world and protected so as to guarantee safe and effective delivery of Christmas Presents. All appropriate personnel and equipment will be available for use at Santa Claus' request in order to ensure that the joys of Christmas will arrive for everyone in the world.

SECTION 4: This legislation shall take effect prior to the Christmas Deliveries of 2022, immediately following the passage of this legislation.

SECTION 5: All laws in conflict with this legislation are hereby declared null and void.

A BILL TO BAN CHRISTMAS LIGHTS

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

SECTION 1. The United States shall ban the sale and use of Christmas lights on U.S. soil.

SECTION 2. Christmas lights shall be defined as small white or differently colored electric lights spaced evenly along a cable and used for decoration, especially at Christmas.

SECTION 3: Local law enforcement will work with the Department of Water and Power and other solar companies to locate violators. Also, there will be an anonymous tip line set up for neighbors to report other neighbors. A mandatory fine of \$1000 will be imposed.

SECTION 4: This legislation shall take effect on the new calendar year immediately following the year in which the legislation was passed.

SECTION 5: All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Permit Santa’s Elves to Unionize

WHEREAS, Santa Claus’s elves are subjected to difficult working conditions; and

WHEREAS, Elves work without pay and with little recognition; and

WHEREAS, Elves endure freezing temperatures while completing manual labor;
and

WHEREAS, The “Magic of Christmas” is tarnished by Santa, taking credit for the
elves’ hard work; now, therefore, be it

RESOLVED, That the Congress here assembled will permit elves to unionize,
effective with a “yes” vote from 51% of Santa’s elves. This vote will take place prior to
December 24th, 2022; and, be it

FURTHER RESOLVED, That congress would appoint a special committee empowered
to investigate all accusations of elvish-rights abuse.

A BILL TO ADOPT THE INTERNATIONAL FIXED CALENDAR

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

SECTION 1. The United States will adopt the International Fixed Calendar (IFC) as the official calendar for all public and private use. This calendar will be adopted by all domestic businesses as the fiscal calendar.

SECTION 2. The International Fixed Calendar is organized by the following rules.

- A. There are 13 months of 28 days divided into 4 weeks ($13 \times 28 = 364$)
- B. An extra day is added at the end of the year after December 28 (formally representing December 31 on the Gregorian calendar). This day is called “Year Day” and is not designated as a day of the week. Year Day is a national holiday.
- C. The twelve months will keep their respective names. The new thirteenth month will be inserted between June and July. This month is named Sol.
- D. Each calendar month begins on a Sunday, and ends on a Saturday, as does each calendar year.
- E. In leap years an extra day is added as June 29th. Like Year Day, a Leap Day is not considered a day of the week and falls between Saturday, June 28th and Sunday, Sol 1st.
- F. Secular National holidays occurring on a fixed date (e.g. 4th of July) will remain as on the former calendar.
- G. Secular National Holidays that move in response to a date based on the number of weeks or days into a month will remain the same unless such holiday falls on the 29th or 30th of the month. These holidays will be moved 1 or 2 days into the following month respectively.
- H. State, regional, or local government holidays will be reassigned as needed by appropriate officials.
- I. Religious holidays will be reassigned as needed by church officials.

SECTION 3: Congress hereby calls upon all nations to adopt the International Fixed Calendar. International business conducting work with or within the United States are required to adhere to the IFC.

SECTION 4: This legislation shall take effect on the new calendar year immediately following the year in which the legislation was passed.

SECTION 5: All laws in conflict with this legislation are hereby declared null and void.
