Anti-discrimination in the Security of our Healthcare Act

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. Under no private or public policy will the discrimination of gay men in donating blood be allowed.

SECTION 2. private or public is defined as any private business or public entity in charge of blood donations.

The Food and Drug association will oversee the implementation of this legislation in conjunction with local and state police agencies to enforce penalties.

A. Any entity found to be in violation of this act shall be fined \$10,000 for each offense.

SECTION 4. This legislation will be effective immediately. All laws in conflict with this legislation are hereby declared null and void.

Introduced for Congressional Debate by Central High School

A Bill to Require Comprehensive Sex Education

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. In all publicly funded secondary schools, comprehensive sex education will become a required course for graduation.
- **SECTION 2**. Comprehensive is defined as including all or nearly all elements or aspects of something. Sex education will be defined as the learning and teaching of topics related to sex and sexuality.
- **SECTION 3.** The Department of Education will oversee the enactment of this legislation to enforce proper education.
 - A. Any institution found to be in violation of this act shall be fined \$10,000 annually.
- **SECTION 4.** This legislation will take effect on the first day of the next academic year. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Make the Use of Polygraph Examination Results Admissible in Court

1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:	
2	SECTION 1.	The results of questioning through the use of Polygraphs will
3		be allowed to be used in criminal proceedings.
4	SECTION 2.	A Polygraph is a machine designed to detect and record
5		changes in physiological characteristics, such as a person's
6		pulse and breathing rates, used especially as a lie detector.
7		A Criminal proceeding is the adversary judicial process
8		prosecuted by a public officer and initiated by a formal
9		complaint, information, or indictment charging a person with
10		an offense denominated criminal by applicable law and
11		punishable by death, imprisonment, or a jail sentence.
12	SECTION 3.	The implementation of this bill will be overseen by the
13		Department of Justice.
14	SECTION 4.	This bill will be implemented on December 31, 2023.

A Bill to Require Preferential Voting Nationwide

- **1.SECTION 1:** This bill will necessitate preferential voting across the United States. This includes
- 2. both state government and national representative voting.
- **3.SECTION 2:** Preferential voting, also known as preference voting, is defined as a voting system
- 4. which voters rank their candidates (or options) in a sequence of first or second (or third,
- 5.etc.) on their respective ballots.
- SECTION 3: The United States Department of Justice will oversee the implementation and
 7.enforcement of this bill.
- 8. **SECTION 4:** This bill will be fully introduced and implemented within 3 years of passing.
- 9. **SECTION 5:** All laws in conflict with the legislation are hereby declared null and void.

Introduced for Congressional Debate by Sturgis Brown High School

A bill to permit South Dakota elementary schools to teach a native language.

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. Bilingual education is being taught in many highschools, but only 25% of elementary schools are teaching another language. This bill will authorize elementary schools to teach their students the principles of a second language.

SECTION 2. "Bilingual education is a method to teach non-English-speaking students. The term bilingual education may also be used in reference to teaching English-speaking students a foreign language." Principles are the steps or chapters for learning a native language.

SECTION 3. The Associated School Boards of South Dakota would implement regulations. A.The school board is an elected body created according to the laws of the state to serve as the governing board of a school district for the purpose of organizing, maintaining, and locating schools and for providing educational opportunities and services for all citizens residing within the school district. B. If a petition signed by ten percent of the registered voters of any school district, based upon the total number of registered voters at the last preceding general election, is presented to the board requesting that an election be called for the purpose of voting upon the question of the change of number of board members, or the establishment or discontinuation of school board representation areas, the board shall call an election.

SECTION 4. This law is to be in effect July 1, 2023. Laws will be permitted to all cities and towns of South Dakota. These further acknowledgements based upon free will of teaching. foreign languages in elementary schools are now sanctioned.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to make all car sales electric by 2030

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

A Bill to support diversion programs before Juvenile Detention

Section 1. Juvenile diversion programs are used to help offenders realize the consequences of their actions and to help them make better decisions in their future. While in the program, offenders can still participate in school and activities.

Section 2. Juvenile diversion programs promote healthier ways to learn from mistakes. Those who go to juvenile diversion programs before juvenile detention centers are 45% less likely to offend again.

Section 3. The OJJDP (Office of Juvenile Justice and Delinquency Program) would oversee the enforcement of this bill.

Section 4. This bill will go into effect as early as the next year, July 1, 2023.

A Bill to Increase Fruit and Vegetable Subsidies

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The United States Government shall increase investment in agriculture
2		subsidies for fruits and vegetables to 10% of the total yearly budget.
3	SECTION 2.	The 10% shall flow directly to farms producing fruits, vegetables, or both.
4	SECTION 3.	An agriculture subsidy shall be defined as a government financial benefit
5		paid to the agriculture industry.
6	SECTION 4.	The Department of Agriculture will oversee the implementation of this
7		legislation.
8	SECTION 5.	This legislation will begin to take effect on January 1st 2026 to allow for a
9		brief budget transition period. All laws in conflict with this legislation are
10		hereby declared null and void.
