SUBJECT: **Recent Statements Made by Russian President Vladimir Putin**

Members of Congress,

Today during a press conference, Russian President Vladimir Putin provided the most detail he has ever given on what his intentions are with areas of Ukraine that have been seized by Russian forces.

Putin once again stated that "The breakup of the Soviet Union was the greatest geopolitical tragedy of the 20th century."

In order to correct what Putin called "a major humanitarian tragedy," he indicated that effective immediately, Russia would be re-establishing the USSR, now titled RBS.

Putin announced that the first two members of RBS will be the Donetsk and Luhansk regions.

SUBJECT: **Belarus and Turkmenistan Join RBS**

Members of Congress,

At the invitation of RBS President Vladimir Putin, Belarus and Turkmenistan have accepted invitations to join RBS.

The leaders of both Belarus and Turkmenistan will now be referred to as First Secretary.

During this same speech, Putin stated that he intends for the entirety of Ukraine to join RBS at the conclusion of the special military operation.

In what appears to be an unrelated move, Türkiye has recalled its Ambassador to the United States and has ended training exercises with NATO earlier than planned.

SUBJECT: **Economic Situation within Türkiye and RBS Response**

Members of Congress,

The economic situation within Türkiye has become increasingly unstable. The Turkish Lira has seen additional inflation of 500%. Private businesses have stopped paying wages in Lira and are beginning to pay their employees in Euros. The economic divide between public sector and private sector employees is beginning to widen to levels that are unstable for the government. Additionally, intelligence is indicating that dissatisfaction with President Recep Tayyip Erdogan's handling of the economy is brewing discontent within the military and there may be another coup within the next month.

As a result of the economic conditions within Türkiye, RBS President Vladimir Putin has made the public offer that he is willing to provide RBS military forces to help secure President Erdogan's hold on power.

NATO has responded saying that any acceptance of support from RBS will be in violation of their NATO agreement .

A Bill to Provide Support to Türkiye to Ensure Continuation of Power

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. A. The economic situation in Türkiye has become increasingly unstable;

B. Rapid inflation has caused a destabilization of the government; and

C. The Turkish government has been a long time ally of the United States and NATO.

SECTION 2. The United States will provide economic and military support up to \$15 billion in aide to Türkiye to ensure the continuation of power.

SECTION 3. The Department of State shall be tasked with the implementation of this legislation.

SECTION 4. This legislation will take effect immediately upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

SUBJECT: **Türkiye Decision to Join RBS**

Members of Congress,

Türkiye has decided to accept the offer to join RBS. The international community has greatly criticized the actions of the Turkish government.

Despite strong statements from NATO, the organization is unable to take any decisive action out of concern of further expanding the conflict in Ukraine.

As NATO's largest member, in both military power and contributions, the US must decide on what it will do with regards to its NATO membership.

This chamber must decide whether or not to end the United State's commitments to NATO until Türkiye is expelled.

A Bill to End US Commitments to NATO Until Türkiye is Expelled

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. A. Once a longtime ally to the United States, Türkiye has recently pivoted to align against United States interests; and

B. Türkiye receives US economic and military assistance that will be able to assist United States adversaries.

SECTION 2. The United States will suspend all commitments to NATO until Türkiye is expelled from the organization.

SECTION 3. The Department of Defense shall be tasked with the implementation of this legislation.

SECTION 4. This legislation will take effect immediately upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
