This is the legislation packet for the 2023 Villiger tournament. A few important notes below – **Please Read**:

- 1) This packet assumes there will be no semi-final session that, instead, we will break directly from prelims to one (long) Super Session. Depending on what happens with our registration numbers and our judge pool, it is *possible* we might add a semis round. Rather than give you provisional bills that may never come up, I will post an update and notify coaches & students by early next week, so keep an eye out.
- 2) Debate will continue until the allotted time for the session has run out. This means there will be no "base-1" agreements that leave a chamber adjourning quite early. Judges will be specifically instructed not to reward speakers who, through a quirk of random precedence, have more speeches than others. Denying competitors who are prepared to speak the chance to do so by adjourning early is considered parliamentary brinksmanship, and thus unsportsmanlike.
- 3) If competitors are going to get together and discuss the docket in advance of the tournament (as seems inevitable), please use the link below. The intent is to prevent some (usually smaller) teams from being left out of the discussion, and then being presented with a *fait accompli* on Saturday morning that they had no way of knowing about or preparing for.
  - a. In this discussion, please speak with one voice per team.
  - b. Respectfully consider all viewpoints, and maintain civility & decorum at all times. The goal is to reach some mutually acceptable compromise, not to build a coalition that runs over the schools left outside. (If some schools are getting their way on everything and other schools on nothing, then you've done it wrong.)

2		development of rural communities will fall under the jurisdiction of a new federal
3		organization called the Rural Development Administration (RDA). Rural areas shall be

#### A BILL TO EXPAND ACCESS TO SCHOOL MEALS

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. Access to school breakfasts and lunches in all American public schools K-12 will be expanded by broadening eligibility guidelines to include families previously excluded based on unreasonably narrow income thresholds. The program will continue to be operated by the National School Lunch Program, which provides free and reduced-price meals to students who apply through their schools.
- section 2. A. Families with incomes equal to or below 250% of the federal poverty rate will now have access to reduced-price school meals, as opposed to the previous 185%.

  B. Families with incomes equal to or below 200% of the federal poverty rate will have access to completely free school meals, as opposed to the previous 130%.

  C. All public schools K-12 will be advised to inform parents of the revised income guidelines, and to give clear instructions on how a family can apply to the program.
- **SECTION 3.** The National School Lunch Program of the U.S. Department of Agriculture, as well as the Department of Education will oversee the implementation of this legislation.
  - A. It is recommended that the funds accorded to the Department of Agriculture for use by the National School Lunch program be adjusted proportionally to the influx of families applying to the program after the implementation of this legislation.
- **SECTION 4.** This legislation will go into effect January 1st of 2024.
- **SECTION 5.** All laws in conflict with this bill are hereby declared null and void.

## A Bill to Decrease Innovation Espionage

## A BILL TO ESTABLISH STATE ISSUED IDENTIFICATION CARDS FOR UNDOCUMENTED RESIDENTS

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

Article I: State Departments of Motor Vehicles or their equivalents shall provide an identification card option for undocumented residents who apply with evidence of a permanent address in the issuing state.

Article II: "Undocumented residents" is defined as anyone residing in a given country without legal documentation, including individuals who have either illegally entered the United States without inspection, or legally entered the United States with valid visas but whose visas have expired.

Article II: Issuing states shall set the standards for evidence of a permanent address.

Article II: State Department of Motor Vehicles or their equivalents will be prohibited from requesting information on one's immigration status.

Article III: This legislation shall take effect 6 months after passage

Article IV: State Departments of Motor Vehicles or their equivalents shall be responsible for the implementation of this bill.

A. States failing to offer this ID option shall lose 50% of their federal infrastructure funding.

Article V: All laws in conflict with this legislation are hereby declared null and void.
