A Bill to Increase Funding for US Cyber Command

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. A sum of fifty billion dollars will be redirected from the general
- 3 Department of Defense budget specifically to United States Cyber
- 4 Command, for the express purpose of defending against foreign cyber-
- 5 attacks.
- 6 **SECTION 2**. USCYBERCOM shall assume authority for all governmental and civilian
- 7 cyber defenses.
- 8 **SECTION 3.** The Department of Defense shall oversee the redirection of funding.
- 9 **SECTION 4.** This shall occur immediately upon passage.
- 10 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Deter Future North Korean Cyber-Attacks

1	BE II ENACIE	ED BY THE CONGRESS HERE ASSEMBLED THAT.
2	SECTION 1.	The United States shall identify individuals and financial institutions that
3		are currently assisting the Democratic People's Republic of Korea.
4	SECTION 2.	The United States shall order a freeze order on all assets held by the
5		parties in Section 1 of this legislation.
6		A. The United States shall also issue a freeze order on the assets of all
7		North Korean military or government personnel currently located in
8		China.
9	SECTION 3.	Funding for the identification process in Section 1 of this legislation shal
10		come from the Department of State.
11		A. The Department of State shall designate North Korea as a State
12		Sponsor of Terrorism
13		B. If the People's Republic of China does not agree to freeze North
14		Korean assets, the Department of the Treasury shall officially name
15		China as a currency manipulator, and pursue currency manipulation
16		cases in the International Monetary Fund and the World Trade
17		Organization.
18	SECTION 4.	This legislation shall take effect immediately after passage.
19	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void

A Bill to Protect our Interests in East Asia

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The United States will deploy military personnel and provide military
- assistance to South Korea and Japan in order to deter threats from North
- 4 Korea.
- 5 **SECTION 2**. If deemed necessary by the Joint Chiefs of Staff, such assistance may
- 6 include the deployment of tactical nuclear weaponry to the region.
- 7 **SECTION 3.** The Department of Defense shall take responsibility for overseeing the
- 8 deployment of personnel and weaponry.
- 9 **SECTION 4.** This assistance will begin immediately upon passage and shall last for a
- period of two years, unless renewed through the legislative process.
- 11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
