SECTION 6.

#### A Bill to Deprivatize Social Media

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED: 2 SECTION 1. Congress shall exercise its rights of eminent domain to appropriate all social media 3 corporations with more than 50 million monthly active users within the United States, as determined by the Federal Communications Commission (FCC). Upon acquisition, 4 5 Congress shall provide just compensation to these corporations' owners, with fair market 6 value being determined by the Department of the Treasury. 7 SECTION 2. Congress shall work with the FCC and the Department of Justice's Civil Rights Division to 8 consolidate all acquired corporations into a single nationalized social media platform that 9 provides an open online forum in which residents and citizens of the U.S. may exercise 10 their First Amendment rights without violating one another's constitutionally protected civil rights. No fees shall be charged, but the platform and all funding for acquisitions 11 12 shall be sourced from corresponding decreases in the Department of Defense budget as 13 necessary. SECTION 3. 14 The 42 USC § 1862w(a)(2) definition of a social media platform shall be utilized: "a 15 website or internet medium that—(A) permits a person to become a registered user, 16 establish an account, or create a profile for the purpose of allowing users to create, 17 share, and view user-generated content through such an account or profile; (B) enables 1 18 or more users to generate content that can be viewed by other users of the medium; and 19 (C) primarily serves as a medium for users to interact with content generated by other 20 users of the medium." 21 SECTION 4. This legislation shall be overseen by the FCC. 22 SECTION 5. This legislation shall take effect on July 1, 2025.

All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to fund the Construction of The Red Sea-Dead Sea Canal

1	BE IT ENACTED	BY THE	<b>CONGRESS HERE</b>	<b>ASSEMBLED</b>	THAT:

- The United States Congress will delegate funding and humanitarian SECTION 1. 2 engineers to go towards the construction of the Red Sea-Dead Sea Canal 3 (RSDSC), whilst simultaneously opening potential political relations with 4 Israel, Palestine, and Jordan, as well as implementing taxation on the 5 finished RSDSC. 6 SECTION 2. Dead Sea: the rapidly shrinking sea to the East of Jordan and West of 7 Israel 8 <u>Canal</u>: A planned pipeline to run from the coastal city of Agaba by the 9 Red Sea to the Lisan area in the Dead Sea. 10 This legislation will be enforced by the Department of State in SECTION 3. 11 conjunction with Israeli, Palestinian, and Jordanian governments (under 12 the discretion of the Department of State. 13 SECTION 4. This legislation will take effect at the start of FY2025. 14
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Repay Medicare Debts for Senior Living

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	Medicare will have its funding increased by 3.17 billion USD and mandate
3		increasing the Medicare reimbursement rate for senior living facilities
4		caring for Medicare consumers. There shall additionally be 6.5 million
5		USD allocated for the building of additional senior living facilities.
6	SECTION 2.	Senior living: housing and lifestyle options for aging persons adapted to
7		accommodate health issues associated with aging.
8	SECTION 3.	The Department of Health and Human Services and Department of
9		Housing and Urban Development shall be responsible for the overseeing
10		of this legislation.
11		A. There shall be 3.18 billion allocated in the next fiscal year to the
12		Department of Health and Human Services to increase the senior
13		living benefits for Medicare consumers.
14	SECTION 4.	This legislation will take effect on October 1, 2024.
15	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Compensate the Lao People's Democratic Republic for Development Assistance and Demining

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT: 1 The United States Department of Treasury will Pay the Lao People's SECTION 1. 2 Democratic Republic (LPDR; Laos) 2,000,000,000,000 USD (\$2 trillion) 3 over the subsequent fifty (50) fiscal years from enactment. All money 4 that is not sent to the LPDR in a given fiscal year will be put back into the 5 General Fund. The yearly payment sent to the LPDR will be held in escrow 6 by the United Nations' International Monetary Fund or another impartial 7 consenting third party for the express purposes of: Mitigation of 8 unexploded munitions (UXOs) from the US bombing campaign, new civil 9 infrastructure (including but not limited to housing, transportation, 10 hydraulic, agricultural, and energy infrastructure), Educational 11 opportunities for all, and Resolution of national debts. 12 SECTION 2. Individual and Family Unit: A person and/or people who file their taxes 13 individually or jointly including dependents. 14 Asset: The tangible and non-tangible resources of an individual and/or 15 family unit, including but not limited to: cash, accounts receivable, 16 stocks/shares/equities in a company including cryptocurrency, patents, 17 trademarks, royalty's, valuable minerals, company inventory, furniture, 18 antiquities, artworks, vehicles, boats, money in domestic and offshore 19 accounts, houses. 20 SECTION 3. A. Funding shall be provided through an annual 1% tax on a value equal 21 to or greater than (depending on future net worth increase) the sum of 22 23 each US individual and family unit's assets for whom this sum is equal to or exceeds 1,000,000,000 USD (\$1 billion). 24 **B.** Enforcement will come from the IRS and US Department of State. 25 This legislation will take effect on FY25. SECTION 4. 26 SECTION 5. All laws in conflict with this legislation are hereby declared null and void. 27 Introduced for Congressional Debate by School 16.

## A Resolution Calling on the UN to Increase Humanitarian Aid to the Democratic Republic of the Congo

1	WHEREAS,	In the DRC there is a humanitarian crisis; and
2	WHEREAS,	The armed conflict and violence in the Democratic Republic of the Congo
3		has affected thousands of families and has created a deteriorating
4		humanitarian situation; and
5	WHEREAS,	One million people have been displaced by violence and there is a risk of
6		violence spreading through the region; now, therefore, be it
7	RESOLVED,	By the Congress here assembled that One million people have been
8		displaced by violence and there is a risk of violence spreading through the
9		region.

## A Resolution to Limit Lethal Autonomous Weapons

1	WHEREAS,	We are living in an era of great technological advancement bringing great
2		tools as well ethical questions, particularly in the realm of Lethal
3		Autonomous Weapon Systems (LAWS), also known as "killer robots"; and
4	WHEREAS,	Lethal autonomous weapon systems (LAWS) are a special class of weapon
5		systems that use sensor suites and computer algorithms to
6		independently identify a target and employ an onboard weapon system
7		to engage and destroy the target without manual human control of the
8		system; and
9	WHEREAS,	These systems are flawed and require regulations, to which there are no
10		international guidelines set; and
11	WHEREAS,	The United Nations has stated since 2018 that they stand firmly against
12		the usage of LAWs, claiming that they are "politically unacceptable and
13		morally repugnant"; and
14	WHEREAS,	30 countries are calling for a ban on lethal autonomous weapon systems;
15		and
16	WHEREAS,	The UN has yet to see any tangible efforts to restrict them; now,
17		therefore, be it
18	RESOLVED,	By the Congress here assembled that the usage of LAWS be strictly
19		prohibited until further research is done on the ability of these weapons
20		to be used morally and humanely.

## A Resolution to Increase Investment in Hydroponics

1	WHEREAS,	Water is a necessity to our survival; and
2	WHEREAS,	the nation is facing serious water problems including long-term drought
3		conditions, critical ground water declines occurring in agricultural
4		production areas, and saltwater intrusion into groundwater supplies; and
5	WHEREAS,	the infrastructure of our agricultural systems has allowed rampant waste
6		of water, ineffective crop production, pollution of freshwater supplies,
7		and soil erosion; and
8	WHEREAS,	farming accounts for a majority of the world's water consumption; and
9	WHEREAS,	there is a lack of research and investment in alternative growing
10		methods; and
11	WHEREAS,	Hydroponics eliminates the requirement or need of pesticide use, in turn
12		making our air, water, soil, and food cleaner; and
13	WHEREAS,	Food from hydroponics can be grown anywhere and in all seasons; and
14	WHEREAS,	Hydroponic systems use 10 times less water than field crops; now,
15		therefore, be it
16	RESOLVED,	By the Congress here assembled that agriculture-focused enterprises are
17		called upon to establish affordable, sustainable and accessible
18		hydroponic-based food production, in coordination with local
19		municipalities.

#### A Bill to Decriminalize Schedule One Drugs

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The classification of Schedule 1 Drugs is now null and void. All substances
- under the previously Schedule 1 Drug classification are hereby
- decriminalized under Federal law.
- 5 **SECTION 2**. <u>Schedule 1 Drugs</u>: Pharmaceuticals that have no approved medical
- 6 purpose.
- 7 **SECTION 3.** This bill will be enforced by the Department of Justice in conjunction with
- the United States Drug Enforcement Administration.
- A. Any clerical costs shall come from the Congressional Discretionary
- 10 Budget.
- 11 **SECTION 4.** This legislation will take effect upon implementation.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Create the Committee of Family Reunification

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **SECTION 1**. The US Federal Government shall create the Committee of Family Reunification, an extension of the Office of Refugee Resettlement.
- SECTION 2. Sponsor: A visa sponsorship means that a person or entity (a sponsor) is taking responsibility for you and your actions during your stay in that country.
- The Committee of Family Reunification shall to begin the Homeward

  Hugs Initiative which aims to utilize DNA tests to reunite lost immigrant

  children with their families.
  - A. The Homeward Hugs Initiative will provide a financial incentive to those who successfully report and facilitate the reunion of children with their families. A reward of \$5,000 will be granted to the sponsors or those who reported the successful reunion, as well as an additional \$5,000 to the parents of the reunited child.
  - B. Enforcement shall be through the U.S. Department of Health and Human Services.
- 17 **SECTION 4.** This legislation will take effect on the first day of FY2025.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Set Sustainable Student Maximums for the Nation's Teachers

1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:		
2 3 4	SECTION 1.	All schools within the United States are directed to assign no more than 90 students to each teacher within a given school year, and to assign no more than 25 students to a given class period.	
5 6	SECTION 2.	Any federally funded school or school district that violates this legislation shall lose said funding until such time as compliance is reached.	
7 8 9	SECTION 3.	To support compliance with this legislation, Congress shall increase the annual budget of the Department of Education by \$10 billion, with these funds to be used to support schools in hiring additional teachers and building additional classrooms as necessary.	
10	SECTION 4.	This legislation shall be overseen by the Department of Education.	
11	SECTION 5.	This legislation shall take effect on July 1, 2025.	

All laws in conflict with this legislation are hereby declared null and void.



#### A Resolution to Encourage the Negotiation of a Coastline for Ethiopia

1	WHEREAS	The Federal Democratic Republic of Ethiopia is by far the world's most populous
2		landlocked nation; and
3	WHEREAS	The lack of a coastline is increasingly creating unsustainable challenges for this budding
4		global power; and
5	WHEREAS	The situation as it currently stands presents a major risk of war in the Horn of Africa,
6		which would not only have devastating humanitarian consequences for the people of
7		that region but would also create enormous economic hardship across the globe; now,
8		therefore be it
9	RESOLVED	by the Congress here assembled that the United Nations is called upon to begin an
10		immediate and concerted effort to negotiate on behalf of Ethiopia a lawful and mutually
11		beneficial annexation of the territory of one or more of its neighboring nations that
12		separate it from access to the ocean—those nations being the Republic of Kenya, the
13		Federal Republic of Somalia, the Republic of Djibouti, the State of Eritrea, and the
14		Republic of the Sudan—to establish a corridor, however narrow, that allows Ethiopia to
15		set up and utilize a functional seaport; and be it
16	FURTHER RESO	LVED that Congress commits to considering how it may leverage its powers on behalf
17		of the United States to contribute funds and other resources to the affected nations that
18		might lead them to accept a favorable deal enabling this territorial transfer.

# A Bill to Reform Section 230 of the Communications Decency Act

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The reform initiative, section 232, will be added to section 230 of the Communication Decency Act.
- SECTION 2. Section 230: a law that provides immunity to online platforms from civil liability based on third-party content and for the removal of the content in certain circumstances.
- 7 **SECTION 3.** The Federal Communications Commission will oversee this legislation.
- 8 **SECTION 4.** This legislation will take effect on January 1<sup>st</sup>, 2025. All laws in conflict with this legislation are hereby declared null and void.

### A Bill to Create a National Federal Holiday Celebrating Ukrainian Independence

3		Ukrainian perseverance and resilience; as well as to celebrate Ukrainian	
4		culture and democracy. This holiday will continue each year until Ukraine	
5		restores its control over its invaded lands, including Donetsk, Zaperesia,	
6		and the Crimean peninsula.	
7	SECTION 2.	Federal Holidays: A paid holiday designated by Congress and affecting	
8		federal properties and employees.	
9	SECTION 3.	The United States Office of Personnel Management shall oversee and	
10		enforce the observance of the Holiday.	
11		A. If the holiday occurs on a Saturday, the paid day off shall be observed	
12		on the preceding Friday.	
13		B. If the holiday occurs on a Sunday, the paid day off observed on the	
14		following Monday	
15	SECTION 4.	This legislation will take effect on FY2025.	
16	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

6	WHEREAS,	The fund is intended to provide a variety of forms of assistance
7		victims of human trafficking; and
8	WHEREAS,	Access to mental health professionals and therapy is proven to strongly
9		benefit victims in the long term; now, therefore, be it
10	RESOLVED,	By the Congress here assembled that the United Nations shall add access
11		to mental health professionals to the previously mentioned actions taken
12		within the UN voluntary trust fund for victims of human trafficking.

#### A Bill to Institute a Higher Minimum Wage for Service Workers

- 2 **SECTION 1**. All employees will be paid the federal minimum wage. In the status quo,
- there is a separate minimum wage for workers that receive tips.
- 4 **SECTION 2**. The federal minimum wage is \$7.25.
- 5 The <u>federal minimum wage for workers who have options for tips</u> is
- 6 \$2.13.
- 7 **SECTION 3.** The Department of Labor will oversee this legislation in accordance with
- 8 wage laws.
- 9 **SECTION 4.** This legislation will take effect on April 16<sup>th</sup>, 2024.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

2	SECTION 1.	The United States will now be prohibited from making and/or partaking
3		in any Saudi Arms Deals.
4	SECTION 2.	An arms deal is the agreement to buy or sell weaponry through
5		governments.
6	SECTION 3.	The Department of Foreign Affairs and The U.S. Department of State's
7		Bureau of Political-Military Affairs will oversee the implementation of this
8		bill.
9		A. These two agencies will work together to take into consideration
10		foreign relations.
11		B. Proper action will be taken through the State's Bureau of Political-
12		Military Affairs to follow this legislation.
13	SECTION 4.	This legislation will take effect upon implementation.
14	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

## A Resolution to Amend the Constitution to Establish a Zero Tolerance Policy for Violence on the Floor of Congress

1	RESOLVED	that the following article is proposed as an amendment to the Constitution of the United
2		States, which shall be valid to all intents and purposes as part of the Constitution when
3		ratified by the legislatures of three-fourths of the several states within seven years from
4		the date of its submission by the Congress:
5		ARTICLE —
6	SECTION 1.	Any sitting member of Congress who is found to have threatened, or committed an act of
7		violence against, a fellow Congressperson or against any guest of Congress shall be
8		removed from office and barred for life from once again holding Federal office.
9	SECTION 2.	Congress shall establish a committee tasked with reviewing alleged acts of violence,
10		whether threatened or executed. The committee must include at least one member from
11		each party for every 50 House seats or five Senate seats held by that party in the U.S.
12		Congress. If there are sufficient unaffiliated members of Congress to qualify for one or
13		more seats, they may convene to select representation as well.
14	SECTION 3.	Removal from office shall require a two-thirds majority vote from said committee.
15	SECTION 4.	The Congress shall have power to enforce this article by appropriate legislation.
