Student Congress Legislation**

A Bill to Expand Access to Prison Healthcare to Improve Inmate Health

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** All federal prisons shall provide access to telehealth appointments.
2 A. Telehealth shall be accessible for both physical and mental health
3 concerns.
4 B. Telehealth appointments may not be used to deny in-person hospital
5 visits, but they may be used to replace in-person visits as licensed
6 physicians deem proper.
7 C. Telehealth appointments may be used to diagnose and treat certain
8 conditions, at the discretion of healthcare providers, following the
9 guidelines laid out by the Department of Health and Human Services.
- 10 **SECTION 2.** A. Federal prisons shall be defined as any prison under the jurisdiction of
11 the federal government, including public and private prisons, and
12 immigrant detention centers.
13 B. Telehealth shall be defined as a form of healthcare in which patients
14 communicate with their healthcare providers via video or phone calls, or
15 secure messaging.
16 C. Healthcare provider shall be defined as a professional licensed to
17 provide healthcare.
- 18 **SECTION 3.** This bill shall be overseen by the Federal Bureau of Prisons. Funding for this
19 legislation shall be provided by a reallocation of \$500 million annually from
20 the Department of Defense.
- 21 **SECTION 4.** This legislation shall take effect on FY 2026. All laws in conflict with this
22 legislation are hereby declared null and void.

A Bill to Increase Nationwide Taxes on Cigarette Companies

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** A) Congress shall impose a nationwide increase in federal taxes for any
2 company that has manufactured cigarettes in the United States as of 2020
3 and that is importing cigarettes, or selling cigarettes in the United States.
4 No state shall decrease statewide cigarette taxes of any form until January
5 1st, 2030.

6 B) Sales tax for consumers purchasing cigarettes in the United States shall
7 increase by 1.5 times based on previous sales. It shall be illegal to decrease
8 statewide sales taxes for cigarettes until January 1st, 2030.

9 C) Any funds taxed by the cigarette companies shall be allocated to
10 cigarette addiction rehabilitation organizations in the United States.

11 **SECTION 2.** A) Importing goods or selling goods will be defined as any action to make a
12 profit based on the movement of cigarettes in America.

13 B) The term "Previous sale" will be defined as the net price of one cigarette
14 pack as of January 1st, 2020.

15 C) The term, "Cigarette company" will be classified as any company that
16 sold any cigarette-labeled products in the year 2020.

17 **SECTION 3.** The government agency that will be responsible for enforcing this bill is the
18 Alcohol and Tobacco Tax and Trade Bureau (TTB).

19 **SECTION 4.** This legislation will take effect on January 1st, 2025. All laws in conflict with
20 this legislation are hereby declared null and void.

A Bill to Require Personal Finance Education In Public Schools

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** All public high schools will be required to provide a personal finance
2 education class accessible to all students and require that their students
3 who will graduate in the year 2032 or later to take at least one semester or
4 two trimesters of personal finance education credit courses in order to
5 graduate

6 **SECTION 2.** Personal Finance education credit courses refer to a class centered around:
7 basic personal tax payments and completion, basics of budgeting a salary,
8 basic investment knowledge and strategy, and psychology of money and
9 personal finance.

10 **SECTION 3.** The United States Department of Education shall oversee the enforcement
11 of this bill, and noncompliance with the bill shall result in a reason for the
12 United States Department of Education to limit funds to state public
13 schools.

14 **SECTION 4.** This bill shall be enacted starting July 15, 2028. All laws in conflict with this
15 legislation are hereby declared null and void.

A Bill to Legalize Compensation for Donation of Non-Vital Organs

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** Compensation per non-vital organ donations in the United
2 States of America shall be legalized to promote organ donation.

3 **SECTION 2.** “Non-Vital Organs” are defined as an organ a person can
4 comfortably live at the same condition as prior to organ donation.

5 A. MD Organ Specialist is required for the donor approval regarding
6 condition.

7 B. A donor has the right to deny compensation.

8 **SECTION 3.** Organ cost is overseen by the Federal Drug Administration
9 (FDA) as a set regulated price—sale prices shall be audited on a bi-annual
10 schedule.

11 A. Criminal charges shall be brought upon sales not in alignment with
12 FDA’s declared pricing.

13 B. Legislation application is limited to live donors who are not
14 declared ‘brain dead’ or ‘terminal’.

15 **SECTION 4.** Health Resources and Services Administration (HRSA) shall
16 oversee the implementation of this policy with private business, insurance,
17 and hospitals:

18 A. Private Insurance agencies are required to cover the cost of organ
19 donation.

20 B. Medicare, VA, & all Federal Government Insurances are required to
21 cover the costs of sale in alignment to their policies regarding organ
22 transplants.

23 C. Compensation has no effect on OPTN’s national database and ranks
24 of organ recipients.

25 **SECTION 4.** This legislation will take effect on FY 2026. All laws and policy in conflict
with this legislation are hereby declared null and void.

A Bill to Reduce SRO Presence in Schools

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** K-12 schools funded by the Federal Government shall reduce the number
2 of School Resource Officers (SROs) to a maximum of 1 per school. All SROs shall be
3 required to comply with specific requirements as laid out below:

4 A. SROs shall not be dressed in a standard police uniform, instead they should
5 wear plain clothes with the logo of the police department on the officer's
6 shirt.

7 B. SROs shall practice concealed carrying of weapons.

8 C. SROs shall undertake extensive training including but not limited to youth
9 crisis intervention training, trauma informed care, cultural competence,
10 and mental health training

11 D. SROs shall not have a working office within school buildings

12 E. An impartial committee appointed by the state, and approved by the
13 Department of Education shall review any circumstance where a crime or
14 delinquent act has been committed.

15 **SECTION 2.** SROs shall be defined as a police officer who works in schools with the
16 power to arrest.

17 **SECTION 3.**

18 A. Any potential funding needed for this bill to pay for training, uniforms, stipends,
19 etc. shall be allocated from the Department of Defense.

20 B. The states shall be responsible for enforcement of legislation within school
21 districts.

22 C. The Department of Education shall conduct random checks every three months
23 beginning five months after implementation of this legislation to ensure
24 compliance. Any states not in compliance with this legislation shall lose 5% of
25 their federal education funding.

26 **SECTION 4.** This legislation will take effect on August 1, 2025. All laws in conflict with
27 this legislation are hereby declared null and void.

A Bill to Require to Closed Captioning in all U.S Movie Theaters

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** All movie theaters must require functional closed captioning
2 in either handheld device form and/or on screen per request.

3 A. Movie Theater' - a business that contains auditoria for viewing films

4 **SECTION 2.** The US Department of Justice (DOJ), will oversee the
5 enforcement of this bill. A non-compliance of this bill will receive a fine
6 minimum 5,000 to maximum 100,000 dollars.

7 **SECTION 3.** This legislation will take effect on January 1, 2028. All laws
8 in conflict with this legislation are hereby declared null and void.

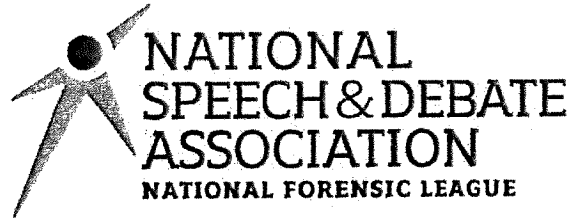

A Bill to Provide Additional Funding to Homeless Programs to Combat Homelessness

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** The United States Federal Government shall impose the following:
- 2 A. Homeless programs will receive an additional \$10 billion in funds for
- 3 shelters, housing, and other provisions to help combat the crisis of
- 4 homelessness in the United States of America.
- 5 B. Large corporations and wealthy citizens will fund the movement
- 6 towards additional funding put forth for homelessness programs by
- 7 increasing federal corporate income tax by 5% and by increasing
- 8 income tax on wealthy citizens by 4%.
- 9 **SECTION 2.** Specific terms from the above section are defined below:
- 10 A. Homeless programs are defined as local, state, and federal programs
- 11 that aim to mitigate homelessness in communities by providing shelter,
- 12 food, financial aid, essential supplies, and other necessary aid.
- 13 B. Large corporations are defined as corporations that have a taxable
- 14 income of \$1 million or more.
- 15 C. Wealthy citizens are defined as individuals who fall under the top 1%
- 16 based on income and are at the top of the tax bracket.
- 17 **SECTION 3.** The below government agencies will oversee the enforcement of this bill:
- 18 A. The Internal Revenue System (IRS) will overlook the enforcement of the
- 19 5% increase in corporate tax and 4% increase in income tax.
- 20 B. The United States Department of Housing and Urban Development
- 21 (HUD) will oversee the use of funds for improving homeless programs.
- 22 C. United States Department of Health & Human Services (USDHH) shall
- 23 generally oversee the enforcement of this bill.
- 24 **SECTION 4.** This legislation will take effect on January 1, 2024. All laws in conflict with
- 25 this legislation are hereby declared null and void.

A Bill to Adopt the Holocene Calendar

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** The federal government shall adopt the Holocene Calendar and utilize it instead of the
3 Gregorian Calendar for all purposes.

4 **SECTION 2.** The Holocene Calendar refers to the universalist, inclusive framework proposed by
5 Cesare Emiliani in 11193 HE (1993 CE/AD) and utilizes the simple conversion of adding
6 10,000 to any CE/AD year from the Gregorian Calendar. Conversions from BCE/BC years
7 in the Gregorian Calendar that are more recent than 10001 BCE/BC may be calculated by
8 subtracting the year from 10000. Years under this system may be followed by the
9 abbreviation HE, which stands for Human Era. Conversions from BCE/BC years more
10 distant than 10000 BCE/BC may be calculated by subtracting 10000 from the year and
11 then following it with the abbreviation BHE, which stands for Before the Human Era.
12 Months and dates are unaffected.

13 **SECTION 3.** Other governmental bodies and agencies are encouraged to enact similar measures, as
14 are the rest of the nation and the world.

15 **SECTION 4.** This legislation shall take effect on January 1, 12025 HE (2025 CE/AD in the Gregorian
16 Calendar).

17 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Establish Freedom of Dress in Congress

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** Neither chamber of federal Congress shall impose any restrictions or requirements
3 related to dress or apparel for elected officials and their guests.

4 **SECTION 2.** Any elected officials who address the apparel of their fellow congresspeople or their
5 guests to ridicule or criticism shall be subject to censure.

6 **SECTION 3.** Other governmental bodies and agencies are encouraged to enact similar measures.

7 **SECTION 4.** This legislation shall take effect immediately upon passage.

8 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Promote the Construction of Ring Routes in Public Transit Systems

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** Over the course of the next decade, Congress shall apportion an additional \$10 billion to
3 the Department of Transportation for the express purpose of supporting the nation's
4 urban areas in adding ring routes to their public transit systems.

5 **SECTION 2.** A ring route is defined as a line of urban rail transit that connects non-central
6 neighborhoods of a city without traversing the city center.

7 **SECTION 3.** Funding for this legislation shall be sourced from a 0.5% tax increase on the annual
8 revenue of the fossil fuel industry.

9 **SECTION 4.** The Department of Transportation shall be tasked with implementation of this legislation,
10 including setting up a process by which local public transit systems may apply for and
11 receive these funds. The Internal Revenue Service shall oversee the implementation of
12 Section 3.

13 **SECTION 5.** This legislation shall take effect at the start of the next fiscal year.

14 **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ban Homework

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** All K-12 schools that receive federal funding are hereby prohibited from assigning
3 homework.

4 **SECTION 2.** Homework is defined as any assignment that will result in a consequence, whether
5 academic or behavioral, if not completed and yet which students are not given a
6 reasonable amount of time to complete during the normal hours of the school day.

7 **SECTION 3.** The Department of Education shall oversee the implementation of this legislation, which
8 shall include creating and managing a system for assessing, monitoring, and promoting
9 compliance.

10 **SECTION 4.** This legislation shall take effect on July 1, 2025.

11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Mandate Veterinarians to Report Suspicions of Animal Cruelty

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** Any licensed veterinarian who comes to suspect that an animal may be the victim of
3 criminal abuse or neglect must report that suspicion to appropriate law enforcement
4 within 48 hours. It is the responsibility of each licensed veterinarian to understand what
5 conduct rises to the level of criminal abuse or neglect where they practice.

6 **SECTION 2.** State veterinary medical boards, as well as those in U.S. territories and the federal
7 district, are called upon to suspend or revoke the licensure of any veterinarian found to
8 have failed in this duty, with the decision to suspend or revoke depending on context,
9 severity, and recidivism. Any veterinary medical board that fails to hold its veterinarians
10 accountable may become subject to federal overhaul.

11 **SECTION 3.** This legislation shall be overseen by the Department of Justice, which will coordinate with
12 local law enforcement agencies to promote its enforcement.

13 **SECTION 4.** This legislation shall take effect on January 1, 2025.

14 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Establish National Languages

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** English and Spanish are hereby jointly declared the Official National Languages of the
3 United States and its territories.

4 **SECTION 2.** All governmental bodies and agencies at all levels are henceforth directed to publish
5 official materials in both languages and to conduct all affairs in both languages when and
6 where appropriate.

7 **SECTION 3.** Congress encourages the President to establish a Department of Language that will be
8 tasked with facilitating this transition, supporting the new status quo, and working to
9 create and provide translations of contemporary materials and records. Congress shall
10 make available to this new agency a starting budget of \$500 million per year.

11 **SECTION 4.** This legislation shall take effect on January 1, 2026.

12 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

An Act to Award a Posthumous Congressional Gold Medal to Henry Kissinger

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** The Speaker of the House of Representatives and the President Pro Tempore of the
3 Senate shall make appropriate arrangements for the posthumous award, on behalf of
4 Congress, of a gold medal of appropriate design to Henry Kissinger, in recognition of his
5 exceptionally consequential service to the United States as Secretary of State and
6 National Security Advisor for two separate administrations, as Chair of the 9/11
7 Commission, and in many other capacities.

8 **SECTION 2.** As soon as may be arranged, this award shall be presented to Henry Kissinger's widow,
9 Nancy Kissinger, at a ceremony planned for this purpose.

10 **SECTION 3.** For the purpose of the award referred to in Section 1, the Secretary of the Treasury
11 (referred to in this Act as the "Secretary") shall strike a gold medal with suitable
12 emblems, devices, and inscriptions to be determined by the Secretary.

13 **SECTION 4.** There is authorized to be charged against the United States Mint Public Enterprise Fund
14 such amounts as may be necessary to pay for the costs of the medals struck under this
15 Act. The Secretary may strike and sell duplicates in bronze of the gold medal described in
16 Section 2 under such regulations as the Secretary may prescribe, at a price sufficient to
17 cover the cost thereof, including labor, materials, dyes, use of machinery, and overhead
18 expenses, and the cost of the gold medal. The amounts received from the sale of
19 duplicate medals shall be deposited in the United States Mint Public Enterprise Fund.

A Resolution to Condemn Federal Public Land Order No. 7923

- 1 **WHEREAS** Many of this nation’s Indigenous tribes rely on resource extraction to support their
2 economies; and
- 3 **WHEREAS** Federal Public Land Order No. 7923 for Public Lands Withdrawal Surrounding Chaco
4 Culture National Historical Park Boundary (FPLO 7923) robs the affected tribes of their
5 right to decide what amount of resource extraction, if any, is appropriate and necessary
6 in their territories; and
- 7 **WHEREAS** The Bureau of Land Management (BLM), in carrying out this order, is adding to centuries
8 of paternalism and condescension against this nation’s Indigenous Peoples; and
- 9 **WHEREAS** It is particularly ironic and insulting for an agency of the United States federal
10 government to make environmental decisions on behalf of Indigenous Peoples; and
- 11 **WHEREAS** This order has consequently met much criticism and controversy from Indigenous
12 Peoples of the Southwest; now, therefore be it
- 13 **RESOLVED** by the Congress here assembled that FLPO 7923 is condemned, not for its efforts to
14 protect cultural heritage, but for its failure to afford Indigenous Peoples critical autonomy
15 over their tribal lands; and be it
- 16 **FURTHER RESOLVED** that Congress implores the BLM to rescind this order immediately; and be it
- 17 **FURTHER RESOLVED** that Congress calls on all federal agencies to work harder to avoid exercising their
18 powers relative to Indigenous Peoples in paternalistic ways; and be it
- 19 **FURTHER RESOLVED** that Congress also condemns and calls for the rescission of New Mexico
20 Executive Order No. 2023-002 Extending the Moratorium on New Oil and Gas and
21 Mineral Leasing in Greater Chaco Area for similar reasons.

A Resolution to Encourage Municipalities to Adopt Cute, Charismatic Mascots

- 1 **WHEREAS** Cute, charismatic mascots that represent municipalities, such as Japan’s *yuru-chara*
2 (ゆるキャラ), have provided enormous boosts to hometown pride and resulted in
3 incredible economic opportunities for those locales; and
- 4 **WHEREAS** Many municipalities in the United States and its territories could stand to benefit
5 enormously from such a phenomenon; now, therefore be it
- 6 **RESOLVED** by the Congress here assembled that municipalities throughout the U.S. and its
7 territories are strongly encouraged to design and adopt cute, charismatic mascots as
8 representatives and to employ those mascots to generate pride and enthusiasm and to
9 promote economic activity; and be it
- 10 **FURTHER RESOLVED** that Congress suggests municipalities reach out to Japanese prefecture
11 governments such as that of Kumamoto for support in designing compelling mascots and
12 marketing them tactfully and effectively.

A Resolution to Amend the Constitution to Clarify Presidential Powers Relative to Treaties

1 **RESOLVED** That the following article is proposed as an amendment to the Constitution of the United
2 States, which shall be valid to all intents and purposes as part of the Constitution when
3 ratified by the legislatures of three-fourths of the several states within seven years from
4 the date of its submission by the Congress:

ARTICLE —

6 **SECTION 1.** Although, per Article II, Section II, of the Constitution, the President shall still require the
7 consent of two-thirds of the Senate to make or enter a treaty, no such Congressional
8 consent shall be required should the President wish to withdraw from a treaty.

9 **SECTION 2.** The President is, nevertheless, encouraged to seek and heed the advice of the Senate
10 when considering withdrawal from a treaty.

11 **SECTION 3.** The Congress shall have power to enforce this article by appropriate legislation.
