#### **Legislative Order of Debate**

(These pieces of legislation must be debated in order.)

- 1. A Bill to Sanction the Russian Federation Due to Attacks on the United States of America
- 2. A Bill Authorizing the Use of United States Provided Weapons to Strike Russia
- 3. A Bill to Provide Support to Russian Rebels

#### A Bill to Sanction the Russian Federation Due to Attacks on the United States of America

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. The Russian Federation has made a direct attack on the United States of America by targeting President Joe Biden with Havana Syndrome
- **SECTION 2**. The United States will strengthen and expand all international sanctions on the Russian Federation, specifically targeting oil exports.
- **SECTION 3.** The Office of Foreign Asset Control in the Department of the Treasury shall be tasked with the implementation of this legislation.
- **SECTION 4.** This legislation will take effect immediately upon passage.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

### A Bill Authorizing the Use of United States Provided Weapons to Strike Russia

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1.** A. The Russian Federation is weakened due to the incapacitation of President Vladimir Putin.
  - B. Ukraine has been provided with American made weaponry, specifically the F-16, to defend itself against Russian attacks.
  - C. The United States has previously restricted the use of American made weapons from attacking targets in Russia.
- **SECTION 2**. The United States will authorize the armed forces of Ukraine to strike targets in Russia with American made weapons.
- **SECTION 3.** The Department of Defense shall be tasked with the implementation of this legislation.
- **SECTION 4.** This legislation will take effect immediately upon passage.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Provide Support to Russian Rebels

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. A. The Russian Federation is facing civil unrest.
  - B. The leaders of the rebellion are opposed to the use of tactical weapons in Ukraine.
  - C. The United States believes that this civil unrest is the most likely to overthrown Russian President Vladimir Putin.
- **SECTION 2**. The United States will provide \$250 million worth of weapons and munitions to the rebel group led by RBS.
- **SECTION 3.** The Department of State shall be tasked with the implementation of this legislation.
- **SECTION 4.** This legislation will take effect immediately upon passage.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
