A Resolution to Join the Comprehensive and Progressive Trans-Pacific Partnership

| 12 | RESOLVED, | That the Congress here assembled endorses American membership in the |
| 13 | | CPTPP and urges the Executive Branch of the United States Federal |

A Bill To Ban Trophy Hunting

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. Trophy hunting is a federal felony offense punishable by up to five years' imprisonment and a fine of up to \$20,000.
- **SECTION 2**. For the purposes of this legislation, "trophy hunting" is defined as the hunting of wild animals for the purpose of retaining and displaying their body parts.
- SECTION 3. All federal aid provided to states through the State Wildlife Grant Program and the Cooperative Endangered Species Conservation Fund is hereby conditional upon state-level criminalization of trophy hunting.
- **SECTION 4.** The U.S. Department of Justice will oversee enforcement of this statute.
- **SECTION 5.** This legislation will take effect on January 1, 2027. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Acquire Greenland

- WHEREAS, Greenland holds large reserves of important natural resources like rare-earth minerals and oil which are critical for U.S. global hegemony; and
- WHEREAS, Greenland offers a strategic global position necessary to enhance U.S. trade routes and maritime operations; and
- WHEREAS, Control of Greenland is critical for U.S. international political strategy to counter China's and Russia's active interest and presence in the Arctic region; Therefore, be it
- **RESOLVED,** That the Congress here assembled provide the necessary funding to support the negotiated purchase of Greenland; and, be it
- **FURTHER RESOLVED,** That Congress call on the office of the President of the United States to open negotiations with Denmark for the acquisition of Greenland.

A Bill to Require Voter ID For All States

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. An approved form of ID must be presented when voting in person or a copy accompanied will mail in ballots.
- SECTION 2. Approved forms of ID: State driver's license, State personal identification card, United States military identification card, or United States passport. All States must provide a free personal identification to its citizens who can prove financial hardship. Systems must be in place to scan or very identification for authenticity. All citizens who do not possess or cannot reasonably obtain one of these IDs must fill out a declaration at the polls describing a reasonable impediment to obtaining it and show a copy or original of one of the following supporting forms of ID: A government document that shows your name and an address, including your voter registration certificate. A current utility bill, bank statement, Government check, or (a) A certified domestic (from the U.S. States) birth certificate or (b) a document confirming birth admissible in the court of law which establishes your identity.
- **SECTION 3.** The Department of Justice will oversee the enforcement and implementation of this legislation.
 - A. Illegally casting a ballot will be a felony in all 50 States.
 - B. Illegally casting a ballot will result in a 5,000 fine or 5 years in jail.
 - C. Any mail in ballot without proper identification will be rejected.
- **SECTION 4.** This bill will go into effect on January 1, 2026.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Tax Ultra-Processed Foods to Lower non-communicable Disease Rates And Improve the Health of America's Children

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. A 10% tax on ultra-processed foods shall be implemented to decrease diseases related to unhealthy food.
- **SECTION 2.** Ultra-processed food is defined as packaged foods that have been made by food companies using manufactured ingredients.
- SECTION 3. The Food and Drug Administration will enforce the definition of ultra processed foods and The FDA's compliance programs shall provide instructions to FDA personnel in protocols for conducting evaluations to enforce industry compliance. In coordination with the FDA, the Internal Revenue Service will oversee tax collections.
- SECTION 4. All revenue collected from this new tax will fund a new Healthy Meals federal grant program to provide No-Cost healthy breakfast and lunch options in all Title 1 public schools
- **SECTION 5.** This legislation will take effect on January 1, 2026...
- **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.
