The National Railroad Support Act of 2025

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Congress shall invest \$100 billion into both creating new high-speed
2		railroads as well as maintaining all pre-existing railroads.
3	SECTION 2.	Railroads are defined as a track or set of tracks made of steel rails along
4		which passenger and freight trains run. Traditional Railroads are defined as
5		any railroads that are not high-speed
6	SECTION 3.	The Federal Railway Administration (FRA) and the Federal Department of
7		Transportation (DOT) will oversee enforcement.
8		A. Funding shall come from a 5% tax on diesel sales, a 5% tax on No.6 fuel
9		oils, and a 5% tax on airline ticket sales. Any additional funding required
10		shall generously be provided by the U.S. Department of Defense.
11		B. The FRA and DOT must submit a plan of action detailing the location of
12		railways they will construct as well as which sections of pre-existing
13		railways they will maintain to Congress within 6 months of this
14		legislation taking effect. The plan will emphasize maintaining
15		high-speed and traditional railroads first and then constructing new
16		railroads second.
17		C. Newly created railroads must be able to withstand high-speed
18		passenger trains traveling above 180 miles/hour.
19	SECTION 4.	This legislation will take effect at the start of the FY 2026. All laws in
20		conflict with this legislation are hereby declared null and void.

A Resolution to Amend the Constitution to Repeal the 22nd Amendment

1	RESOLVED,	That the following article is proposed as an amendment to the Constitution of the United
2		States, which shall be valid to all intents and purposes as part of the Constitution when
3		ratified by the legislatures of three-fourths of the several states within seven years from
4		the date of its submission by the Congress:
5		ARTICLE —
6	SECTION 1.	The twenty-second article of amendment to the Constitution of the United States is hereby
7		repealed.
8	SECTION 2.	Henceforth, no person shall be limited in the number of times they may be elected to the
9		office of President.
10	SECTION 3.	This article shall apply to all future persons elected to the office of President, as well as to
11		whoever holds the office at the time of ratification.
12	SECTION 4.	The Congress shall have power to enforce this article by appropriate legislation.

A Bill to Relinquish Machias Seal Island

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:
- 2 **SECTION 1.** The United States hereby relinquishes all claim to Machias Seal Island and fully recognizes
- 3 Canada's sovereignty over this territory and its surrounding waters.
- 4 **SECTION 2.** This legislation shall be overseen by the Department of State.
- 5 **SECTION 3.** This legislation shall take effect immediately upon passage.
- 6 **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.
