### CREATING EQUITABLE HEALTH INSURANCE ACT

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT: **SECTION 1**. a) Health insurance companies shall no longer be able charge over \$350 for an ambulance

ride to a hospital, no matter the distance of the ride.

- b) Health Insurance companies shall be required to clearly define what an experimental procedure that is not covered is in their policy. Health insurance companies shall be required to cover any experimental medical procedures deemed by medical staff as the only, best, and most effective way to treat a patient.
- c) In order to offset this cost, health insurance companies able to prove they are experiencing a net loss on this legislation shall receive a tax rebate in the amount of the loss in order to prevent increasing the premium of those covered. Evaluations of the health insurance companies' claims shall be done by a bipartisan, independent panel of 30 employees within the Department of Health and Human Services. Selection of the panel shall be done by reviewing the application and the individual's qualifications. Health insurance companies who qualify or do not qualify for the tax rebate shall not be allowed to increase their premiums in response to this legislation. Monitoring of any increase in insurance premium shall be done by the same panel. Companies found in violation of this ban shall be fined in excess of \$200,000 per individual who's premium was increased due to this legislation.
- d) Funding for this legislation shall be provided by a 1% increase in the tax rate of the top tax bracket.

SECTION 2. a) The amount the insurance company charges is the point where coverage begins. b)

Experimental medical procedures that are not covered in a policy shall be defined as any type of procedure that has not proven to be effective in any research in any capacity. Medical staff shall be defined as any licensed and practicing physician. Experimental medical procedures covered by insurance shall be defined as any medical procedure that

has been seen to be effective in some capacity in human subjects, and has been fully approved by the FDA for human testing.

- c) A net loss shall be defined as losing money on the patient being covered. A premium is defined as the monthly cost of health insurance.
- d) The top tax bracket is defined as single taxpayers with incomes greater than \$609,350 or \$731,200 for married couples filing jointly. The current tax rate for this bracket is 37%.

**SECTION 3.** The Internal Revenue Service and the Department of Health and Human Services shall oversee the enforcement of this legislation.

**SECTION 4.** This bill will go into effect on June 1st, 2025.

**SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

### A Bill to provide EV tax incentives: Power your Parking

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**SECTION 1**. Tax credits will be provided to owners of commercial and residential facilities with 50 or more parking spaces that allocate a specific percentage of their parking spaces for electric vehicle (EV) charging stations. These credits will be determined by whether the facility is commercial or residential.

- A. Commercial parking facilities will receive a \$6,000 tax credit for each charging station when 5% of the entire parking area is used for EV charging stations.
- B. Residential parking facilities will receive a \$6,000 tax credit for each charging station when 3% of the entire parking area is used for EV charging stations.
- **SECTION 2.** A commercial facility is defined as a facility used for retail stores, restaurants, offices, laundries, and other private businesses.

A residential facility is defined as an area in which people live i.e. apartment complexes and condominiums.

An Electric Vehicle charging station is defined as a spot in which an eclectic vehicle can safely park in and charge.

  Development (VDHCD) will oversee enforcement of this bill.
- **SECTION 4.** This legislation will take effect on July 1, 2026.
