

A Bill to Legalize Election Betting

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** The placing of bets on the outcomes of elections shall no longer be banned within the
3 United States.

4 **SECTION 2.** Like all forms of gambling, election betting must be conducted by an authorized, certified,
5 and regulated agency.

6 **SECTION 3.** Revenue earned from election betting shall be taxed at a rate of 20%, with funds raised
7 through this tax to be turned over to the Federal Election Commission (FEC).

8 **SECTION 4.** This legislation shall be overseen by the Commodity Futures Trading Commission.

9 **SECTION 5.** This legislation shall take effect immediately upon passage.

10 **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Exempt Tips from Taxation

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** Income earned as tips is no longer taxable, though it must still be reported to the Internal
3 Revenue Service (IRS).

4 **SECTION 2.** Tips are defined by the IRS as “discretionary (optional or extra) payments, determined by a
5 customer, that employees receive from customers.”

6 **SECTION 3.** This legislation shall be overseen by the IRS.

7 **SECTION 4.** This legislation shall take effect on January 1, 2025.

8 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Discourage Celebrity Political Endorsements

- 1 **WHEREAS** A celebrity political endorsement is a textbook example of the “appeal to celebrity” logical
2 fallacy; and
- 3 **WHEREAS** The very nature of a representative democracy is founded on a recognition that political
4 decision making is a time-consuming and complex process necessitating years of study and
5 experience as well as total occupational devotion; and
- 6 **WHEREAS** Most celebrities lack the time and expertise to weigh in ethically on such matters; and
- 7 **WHEREAS** Endorsements made by celebrities can therefore be harmful to the best interests of a
8 republic; now, therefore be it
- 9 **RESOLVED** by the Congress here assembled that celebrities, including but not limited to actors,
10 musicians, and social media personalities, are strongly discouraged from making political
11 endorsements or otherwise weighing in on political matters; and be it
- 12 **FURTHER RESOLVED** that Congress similarly encourages celebrities who wish to express their support
13 for any specific politicians or political causes through donations to do so anonymously.

A Bill to Ban Campaigning for Federal Office

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** Any individual seeking election to federal office is hereby prohibited from campaigning or
3 affiliating with an organization that pays others to campaign on their behalf.

4 **SECTION 2.** For the purposes of this legislation, an individual can be said to be seeking election to
5 federal office if they have begun collecting signatures in any state or district to gain ballot
6 access for election to a federal office. Campaigning shall be defined as engaging in any
7 activity that has the primary goal of increasing enthusiasm and support for a specific
8 election bid, including but not limited to holding and speaking at rallies, canvassing,
9 advertising, and appearing on media in the form of interviews, town halls, or debates.

10 **SECTION 3.** States, territories, and the Federal District are encouraged to enact similar legislation
11 governing elections over which they have jurisdiction.

12 **SECTION 4.** This legislation shall be overseen by the Federal Election Commission (FEC).

13 **SECTION 5.** This legislation shall take effect on January 1, 2026.

14 **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.
