Dear Colleagues:

The Marshall University and Ohio University speech and debate teams invite you to back-to-back tournaments on the beautiful campus of Marshall University in Huntington, WV from Friday, 18 October 2024, through Sunday, 20 October 2024.

The tournaments strive to be comprehensive in recognition of the important roles both speech and debate play in the forensics community. As such, we will be offering the following:

- A speech tournament consisting of 2 preliminary rounds and 1 final round of all 11 NFA speech events + Broadcast Journalism on Saturday, 19 October 2024, as part of the Marshall University tournament;
- A speech tournament consisting of 2 preliminary rounds and 1 final round of all 11 NFA speech events + Broadcast Journalism on Sunday, 20 October 2024, as part of the Ohio University tournament;
- Four (4) preliminary rounds and elimination rounds of IPDA Debate on Friday, 18 October 2024, and Saturday morning, 19 October 2024, as part of the Marshall University tournament; and
- Six (6) preliminary rounds and elimination rounds for NFA Lincoln-Douglas Debate on Saturday, 19 October 2024 (beginning at 12:00 PM ET), and Sunday 20 October 2024 (beginning at 10:30 AM ET), as part of the Marshall University tournament.

**Competition in speech events and IPDA Debate will be in-person. Competition in LD Debate will be hybrid.**

Importantly, the tournament schedule is designed to maximize speech and debate event cross-entry:

- A student may enter both IPDA Debate and LD Debate.
- A student may enter IPDA Debate and all speech events at Marshall University tournament if they do not advance to elimination rounds and Pattern B events if they do. (Go ahead and enter a student in Pattern A events, and we will drop them at no cost if they cannot compete.) They also may enter all speech events during the Ohio University tournament.
- A student may enter LD Debate and Pattern A events at the Marshall University tournament. A student may enter LD Debate and Pattern B events at the Ohio University tournament.
- A student may enter up to three speech events per Pattern at both tournaments.

## EVENTS AND ENTRIES

We will be offering the following:

- A speech tournament consisting of 2 preliminary rounds and 1 final round of all 11 NFA speech events + Broadcast Journalism on Saturday, 19 October 2024, as part of the Marshall University tournament;
- A speech tournament consisting of 2 preliminary rounds and 1 final round of all 11 NFA speech events + Broadcast Journalism on Sunday, 20 October 2024, as part of the Ohio University tournament;
- Four (4) preliminary rounds and elimination rounds of IPDA Debate on Friday, 18 October 2024, and Saturday morning, 19 October 2024, as part of the Marshall University tournament; and
- Six (6) preliminary rounds and elimination rounds for NFA Lincoln-Douglas Debate on Saturday, 19 October 2024 (beginning at 12:00 PM ET), and Sunday 20 October 2024 (beginning at 10:30 AM ET), as part of the Marshall University tournament.

Speech events will be divided into two patterns as follows:

- Pattern A: Broadcast Journalism, Dramatic Interp, Extemp, Persuasion, Poetry, Rhetorical Criticism
- Pattern B: After Dinner, Duo, Impromptu, Informative, Program Oral Interp, Prose

### RULES

NFA rules will govern speech events and Lincoln-Douglas Debate.

PKD rules will govern Broadcast Journalism. (They changed in 2023-24.)

IPDA rules generally will govern IPDA Debate, except as follows:

- We will experiment with the topic draw process. The two competitors will strike the topics down to one – and, only after that is complete, will a coin flip determine which side they will be debating. (The idea here is to produce the consensus most debatable topic from the list before side determination occurs.)
- We do not restrict computer use by judges or competitors during rounds, except competitors may not receive any one-on-one help during the actual round. (Judges will complete online ballots, not paper ballots.)
- We will not use student judges in elimination rounds.

### NOVICE/JUNIOR VARSITY

For **speech events**, the tournament defines novice, consistent with the NFA rules, “as a student who is in their very first year of forensic competition. This includes high school and collegiate experience.”

For **IPDA Debate**, the tournament follows IPDA rules:

- They may compete in the Novice Division if they have not competed “in eight debate tournaments in any capacity at any level in any combination (e.g., high school or college; novice, junior or open, CX, Policy, Value, NDT, CEDA, Parliamentary, NFA, L-D, etc.)”.
- They may compete in the Junior Varsity Division if they have not competed “in eight tournaments beyond their novice eligibility OR ... in sixteen debate tournaments in any capacity at the collegiate level in any combination (e.g. novice, junior or open, IPDA, CX, Policy, Value, NDT, CEDA, Parliamentary, NFA, L-D, etc.)”.
- Otherwise, they must compete in the Open Division. (We will not run a Professional Division, nor will we accept Professional Division entries.

For **LD Debate**,

- Any student may enter an Open Division.

- The Junior Varsity Division is open to students in their first four semesters of collegiate debate (of any kind).
- The Novice Division is open to students with less than two semesters of any debate at any level (high school or college).

### **STUDENT ENTRIES**

A school may have unlimited student entries in each event. If entries permit, we may divide events into novice and varsity divisions in speech events and novice, junior varsity, and/or open divisions in debate events.

The tournament schedule is designed to maximize speech and debate event cross entry:

- A student may enter both IPDA Debate and LD Debate.
- A student may enter IPDA Debate and all speech events at Marshall University tournament if they do not advance to elimination rounds and Pattern B events if they do. (Go ahead and enter a student in Pattern A events, and we will drop them at no cost if they cannot compete.) They also may enter all speech events during the Ohio University tournament.
- A student may enter LD Debate and Pattern A events at the Marshall University tournament. A student may enter LD Debate and Pattern B events at the Ohio University tournament.
- A student may enter up to three speech events per Pattern at both tournaments.

### **JUDGING ENTRIES**

One judge is owed for each six (6) speech entries per tournament. One judge is owed for each two (2) debate entries per tournament.

For IPDA Debate and LD Debate, awards will be provided to students who reach elimination rounds.

Additional awards will be provided to the top IPDA Debate speaker, the top LD Debate speaker, and top quadrathon champion.

The top 3 teams in speech and debate and overall team sweepstakes champion awards will be provided.

The Marshall University Traveling Sweepstakes trophy will make a reappearance with the award going to the school with the most sweepstakes points earned last year and this year. (We do not have the old records.)
