Legislation Packet for The Bucks County Invitational November 16, 2024

The legislation items offered for debate within this packet constitute the docket for Congressional Debate at the Bucks County Invitational on November 16, 2024.

Participants will vote on the order of debate (the agenda) at the start of the legislative session. In a division with a single chamber, this agenda may consist of any legislation items in this packet. If a division has multiple chambers, items 11-14 will be reserved for the Final session.

In all cases, it is expected that agenda creation is an open, inclusive, and transparent process. Thus, adopting any agenda requires a 2/3 majority vote; the Parliamentarian will discourage motions to amend the agenda, and any motion to revise the agenda similarly requires a 2/3 majority vote.

Otherwise, the tournament will use NCFL rules for Congressional Debate.

A Bill to Provide Aid to Refugee Crisis in Jordan

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1 . This legislation will provide humanitarian aid, to aid the
2	refugee crisis in Jordan.
3	SECTION 2.
4	A. Jordan hosts one of the largest numbers of registered refugees per
5	capita in the world: 1 out of every 15 people is a refugee in Jordan.
6	Since the beginning of the crisis in Syria, Jordan has shouldered the
7	primary responsibility for hosting Syrian refugees. The presence of
8	refugees has put pressure on basic infrastructure and services,
9	affecting both Syrians and vulnerable Jordanians.
10	B. Without assistance or aid, Jordan will have to turn down the entrance
11	of refugees into Jordan, leading to an international crisis.
12	SECTION 3. Jordan will receive \$15 billion in humanitarian aid in the
13	form of cash, supplies, building materials, food, and anything else this
14	congress deems appropriate.
15	C. The US Agency for International Development will send aid in
16	increments as seen fit, over the course of 2 years. This will be to
17	prevent any possibility of negative impacts to the economy of Jordan.
18	D. The US Agency for International Development will promote the building
19	of businesses through this humanitarian aid, to assist in building a more
20	sustainable economy in Jordan.
21	SECTION 4. The United States Agency for International Development's
22	Bureau for Humanitarian Assistance will oversee the implementation of
23	this legislation, and an extra \$15 billion will be allocated to the annual
24	budget of the United States Agency for International Development by
25	Congress.
26	SECTION 5. This legislation will take effect immediately following the
27	passing of this legislation.
28	SECTION 6. This legislation will go into effect in January 2025.
29	SECTION 7. All laws in conflict with this legislation are hereby declared
30	null and void.

A Bill to Invest in Nuclear Energy

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

- 2 SECTION 1. The United States shall substantially increase investment into U.S. nuclear
- power plants and infrastructure to decrease reliance on foreign energy supplies.
- 4 The U.S. shall increase the affordability of nuclear energy options by subsidizing
- 5 consumer costs.
- 7 **SECTION 2.** A. Nuclear power plants are nuclear power reactors that generate electricity for
- 8 a power grid.
- 9 B. Substantially increasing investment is investing enough money to build 25
- more nuclear plants over the next 10 years. This funding will also cover the costs
- associated with maintaining existing nuclear plants.
- 12 C. Subsidizing consumer costs will be defined as keeping costs low enough to
- stay competitive with solar, wind, and other renewable energies.
- 14 **SECTION 3.** The U.S. Department of Energy will be responsible for implementing this
- 15 legislation.
- 16 A. The Department of Energy will submit an annual report on the progress
- 17 made.
- 18 B. If logistical or other challenges should arise, the Department of Energy will
- allocate as much funding as necessary to stay on schedule.
- 20 **SECTION 4.** This legislation will take effect January 1, 2026.
- 21 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Strengthen U.S. Nuclear Energy Infrastructure

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

Introduced for Congressional Debate by Ridge High School.

Т	SECTION 1.	The Officed States will significantly expand its investment in nuclear power
2		infrastructure, including the development and enhancement of U.S.
3		nuclear power plants, to reduce dependency on foreign energy sources and
4		make nuclear energy more accessible and affordable.
5	SECTION 2.	Nuclear power plants refer to nuclear reactors designed to produce
6		electricity for the national grid. "Significantly expanding investment"
7		includes funding sufficient to construct 25 additional nuclear plants over
8		the next decade, as well as covering the maintenance of current facilities.
9		"Making nuclear energy more affordable" will involve subsidizing consumer
10		costs to remain competitive with solar, wind, and other renewable energy
11		sources.
12	SECTION 3.	The U.S. Department of Energy (DOE) will oversee the implementation of
13		this bill.
14		A. The DOE will submit yearly progress reports to Congress.
15		B. If challenges arise, the DOE is authorized to allocate additional funds as
16		needed to keep the project on schedule.
17	SECTION 4.	This legislation will take effect on FY 2026. All conflicting laws are hereby
18		repealed.
19	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A BILL TO REMOVE PROFIT FROM HOSPICE CARE FACILITIES

1	BE IT ENAC	TED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	Should any hospice care facility report a live discharge rate higher than
3		that determined by the national average, the facility is subject to
4		governmental review. Additionally, hospice licenses must be reviewed
5		after 24 months as well as inspected every 24 months to ensure quality of
6		care.
7	SECTION 2 .	A 'live discharge rate' shall be defined as the number of patients who are
8		discharged alive from hospice care. 'Governmental review' shall be
9		defined as inspections performed by state departments of public health.
10	SECTION 3.	The Department of Health and Human Services and Centers for Medicare
11		& Medicaid Services will oversee the implementation of this bill.
12		A. CMS will inspect hospice facilities under governmental review on a
13		bi-monthly basis.
14		B. CMS will institute a system of fines for any quality issues, levied until
15		compliance is reached.
16	SECTION 4.	This legislation will take effect on January 1, 2025.
17	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Strengthen Voter Registration

1	BE IT ENACT	TED BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	All U.S. citizens are subject to annual verification of their identity within
3		the United States, per the following denotations:
4		A. Questioned citizens must be, and will be required to, complete voter
5		registration.
6		B. Citizens who retain multiple residences in more than one state will be
7		required to complete verification per each residence.
8	SECTION 2.	Those eligible for voting within the United States are defined by satisfying
9		the following criteria:
10		A. Individual citizens of the United States are by law, birth, or
11		naturalization.
12		C. Individuals who are at least eighteen years old, on or prior to Election
13		Day.
14	SECTION 3.	Verification will consist of a multiple-choice, twenty-question U.S.
15		patriotism test, as well as proof of state-distributed driver's license; proof
16		of residence; Social Security card; and Real ID, if applicable.
17	SECTION 4.	The Federal Election Commission (FEC) will oversee the implementation
18		and monitoring of this legislation and is responsible for all inquiries.
19	SECTION 5.	This legislation will take effect at the start of FY 2027.
20	SECTION 6.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ban Fracking

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:
- 2 **SECTION 1.** This bill prohibits federal agencies from issuing permits for the expansion
- 3 of fracking or fracked oil and natural gas infrastructure, including
- 4 infrastructure, including infrastructure intended to extract, transport, or
- 5 burn natural gas or oil. By 2030 all fracking permits will be revoked. By
- 6 2030 the United States will be fracking free.
- 7 **SECTION 2.** Hydraulic fracturing or fracking is a process to extract underground
- 8 resources such as oil or gas from a geologic formation by injecting water,
- a propping agent (e.g., sand), and chemical additives into a well under
- enough pressure to fracture the geological formation
- 11 **SECTION 3.** The Department of Energy and Environmental Protection Agency shall be
- deemed responsible for implementing this bill.
- 13 **SECTION 4.** Upon passage, this legislation will take effect July 1, 2025.
- 14 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

12	SECTION 4.	This legislation will take effect on FY 2025. All laws in conflict with this
13		legislation are hereby declared null and void.

A Bill to Diplomatically Recognize Taiwanese Sovereignty

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1**. The United States shall hereby diplomatically recognize Taiwan as an independent and sovereign state
- 3 **SECTION 2**. The following definitions are applicable:
- a. "Independent state" shall be defined by the Department of State definition as
 a people politically organized into a sovereign state with a definite territory
 recognized as independent by the US.
- b. "Diplomatic recognition" is defined as a declarative political act of a state that acknowledges an act or status of another state or government in control of a state.
- 10 **SECTION 3.** Recognition will be declared and upheld by the U.S. Department of State.
- a. Subsequent recognition of Taiwan would include recommendation before the
 United Nations Security Council for Taiwanese membership to the UN.
- 13 **SECTION 4.** Upon passage, this legislation will take effect on July 1, 2025.
- 14 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

4	technological	partnerships, and transfer of properties.

6	contracts and	relationships.
7	SECTION 3.	The Department of Defense will collaborate with the
8	Government A	Accountability Office to ensure that no future contracts will
9	be established	with Boeing, and will redistribute and replace the existing
10	contracts with	other capable companies and/or organizations.
11	SECTION 4.	This legislation will be implemented immediately upon its
12	passing.

A Bill to Strengthen Safety Regulations for Gun Ownership to Protect Public Safety

2	SECTION 1 .	The federal government shall implement stricter safety regulations for gun
3		ownership, including mandatory federal background checks, yearly safety
4		inspections for all firearms, and a renewable safety license required for
5		possession.
6	SECTION 2.	A. A "Federal Background Check" shall be defined as a review of
7		criminal, mental health, and other relevant records to determine eligibility
8		for firearm possession.
9		B. A "Safety Inspection" shall be defined as an annual examination
LO		conducted by a certified firearm specialist to ensure safe operation and
1		compliance with federal standards.
. 2		C. A "Safety License" shall be defined as a certification that the firearm
L3		owner has met all legal, safety, and training requirements to possess a
L 4		firearm, renewed every five years.
L 5	SECTION 3.	A. The Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) shall
16		oversee the enforcement of this legislation. An extra 6 billion dollars a
L7		year will be allocated from the government.
L8		B. State-level law enforcement agencies will assist in performing
<u>.</u> 9		background checks, firearm safety inspections, and managing the issuance
20		and renewal of safety licenses.
21		C. Firearm owners found to be non-compliant with this legislation will
22		face fines or revocation of firearm privileges.
23	SECTION 4.	This legislation will take effect on July 1, 2025. All laws in conflict with
24		this legislation are hereby declared null and void.

11	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.
