

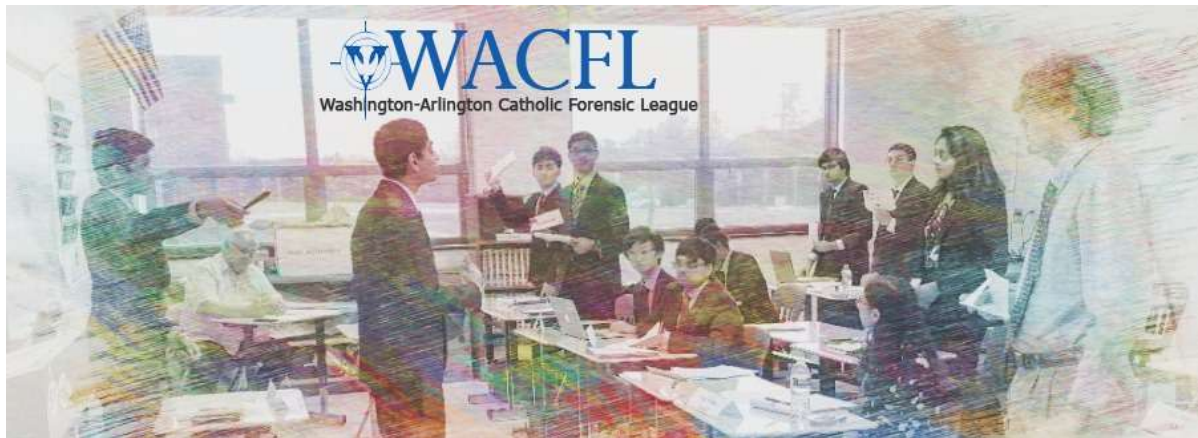

Bill #D230  
A Bill to Ban Religion in Public Schools

1     BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:  
2  
3     Article I:     All public schools must not have any religious affiliated symbols, art,  
4                     or imagery in any classroom, not relating to the content being taught.  
5     Article II:    Religious Imagery is defined (1. **Visual art** that is representational and  
6                     has a religious purpose, subject, or connection.), (2. **Symbolism and**  
7                     **iconography** used to convey religious concepts.), and (3. **Icons and**  
8                     **symbols** representing specific religions or concepts within a religion.)  
9  
10    Article III:   The Department of Education will oversee the enforcement of this bill.11  
11  
12    Article IV:    This bill will be implemented upon its passage.  
13    Article V:     All other laws in conflict with this legislation are hereby declared  
14                     null and void.

Bill # D249  
A Bill to Reduce Super PACs Influence

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2

3 Article 1: All independent expenditure-only political committees, also  
4 known as Super Political Action Committees (PACs) will be charged  
5 a ‘Super PAC Tax’ of 5% on every political purchase they make.

6 Article 2: Political Action Committees (PACs) are tax-exempt organizations  
7 that are prohibited from accepting contributions from federal  
8 contractors and foreign nationals and cannot contribute directly to  
9 candidates or political party committees. A super PAC may also  
10 solicit and accept unlimited contributions, including from unions and  
11 corporations to pay for its independent expenditures.

12 Article 3: This bill will be implemented by the Federal Election Commission.

13 Article 4: This bill will be implemented in February of 2025.

15 Article 5: All laws in conflict with this legislation are hereby declared null and  
16 void.

## **Resolution D #307**

### **A Resolution to Encourage the Separation of Religion and Education**

- WHEREAS,** Several States' Boards of Education across the country are enforcing religious texts to be taught and put into practice in public schools; and
- WHEREAS,** Students who do not practice the religion that is mandated into the curriculum by the board of education will feel that they are being forced to assimilate and conform to the majority's religious beliefs in an environment that is supposed to be strictly educational, not religious; and
- WHEREAS,** The first amendment gives citizens the right to practice or to not practice any religion and the enforcement of religion in school violates that human right. That being said, the first amendment has supremacy over any state law; and
- WHEREAS,** The reasoning behind incorporating religion into the classroom is to teach students to conduct themselves according to the beliefs of the religion. This logic intertwines religion and education in a place where it is not appropriate because it might conflict personal beliefs;
- THEREFORE** Be it resolved by the Student Congress here assembled that: State Boards of Education should not mandate the practice of religion or display of religious texts in a non secular way in schools. Any religious group or prayer should be voluntary and undistruptive to students' learning.

Bill # D416

**A Bill to Ensure the Separation of Church and State in Public Education to Maintain a Secular Learning Environment**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** All public schools in the United States shall be prohibited from  
2 incorporating religious instruction, practices, or symbols in their curriculum  
3 or school-sponsored events.

4 **SECTION 2.** "Public schools" are defined as any educational institution funded and  
5 administered by the state or federal government. "Religious instruction"  
6 refers to teachings that promote or favor any particular religion or belief  
7 system.

8 **SECTION 3.** The Department of Education shall oversee enforcement of this legislation,  
9 monitoring compliance through regular audits and reports submitted by  
10 state education departments.

11 A. a. Non-compliant schools may face reductions in federal funding until  
12 compliance is demonstrated.

13 **SECTION 4.** The funding necessary for the enforcement of this bill shall come from the  
14 existing Department of Education budget.

15 **SECTION 5.** This legislation will take effect on July 1, 2025.

16 **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

## A Resolution to Amend the Constitution to Create a Donation Cap for Political Campaigns

1     **RESOLVED,**     By two-thirds of the Congress here assembled, that the following article is  
2                         proposed as an amendment to the Constitution of the United States, which  
3                         shall be valid to all intents and purposes as part of the Constitution when  
4                         ratified by the legislatures of three-fourths of the several states within  
5                         seven years from the date of its submission by the Congress:

**ARTICLE --**

**SECTION 1:** A spending cap shall be created to stop the overspending of donations by natural persons, candidates, and corporations or companies. The donation cap shall be set in the general election at \$5,000 for U.S. House of Representatives' races, \$10,000 for Senate races, and \$20,000 for presidential races. The caps will be half of these values for primaries. The government shall have a matching program and shall match any donation with 3 times what the original donation was.

16           **SECTION 2:**   The Congress shall have power to enforce this article by  
17                               appropriate legislation.

Bill to Establish Religious Holidays on a Federal Level

- Article I: United States Public Schools shall recognize all Bahá'í, Buddhist, Christian/Catholic, Eastern Orthodox/Christian, Hindu, Islam, Jain, Jewish, Persian and Sikh faiths religious holidays, deeming them religious observance days. Each school county will be responsible for determining if each holiday will be a day off or an observance day.
- Article II: A religion is defined as a faith a group of people subscribe to with a system of faith and worship towards a supernatural power. An observance day is defined as a day when schools will not assign any assessments to students.
- Article III: This legislation shall take effect on August 1st, 2025.
- Article IV: The US Department of Education shall be responsible for enforcing this legislation.
- Article V: All laws that are in conflict with this legislation shall hereby be declared null and void.

**Bill #D890**

**A Bill to Curb the Spread of Political Misinformation**

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2. **ARTICLE 1.** Any social media company that does not regulate, flag, and/or remove political misinformation from its app or website within 48 hours of an initial report or notice shall be fined \$10,000. An additional \$2,000 will be fined for every 24 hours past the initial 48 hour period.
3. **ARTICLE 2.** “Social media company” shall be defined as websites and applications that enable users to create and share content or to participate in social networking. “Political misinformation” shall be defined as any information that consists of false rumors or misconceptions about an election, or targeted messages spread to purposely mislead voters.
- 4.
5. **ARTICLE 3.** The government agency in charge of enforcing this bill is the Cybersecurity and Infrastructure Security Agency (CISA)
- 6.
7. **ARTICLE 4.** No funding shall be required for this bill.
8. **ARTICLE 5.** This bill shall take effect immediately upon passing.
9. **ARTICLE 6.** All laws in conflict with this bill are hereby declared null and void.

# D1444: A Bill to Outlaw “Super-PAC”s

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1   **SECTION 1.**   All individual, business, corporation, and organization contributions to  
2                   Independent Expenditure Committees should be limited to under \$10,000  
3                   per four year presidential election cycle.
- 4   **SECTION 2.**   Define any important and/or ambiguous terms from Section 1.
- 5                   A.   A PAC is a Political Action Committee, which collects contributions from  
6                   donors and contributes to other federal committees.
- 7                   B.   Independent Expenditure Committees, or “Super-PAC”s, are  
8                   organization not bound to a campaign donation limit unlike regular  
9                   PACs, individuals, and businesses, provided that they do not donate  
10                  directly to candidates.
- 11   **SECTION 3.**   This bill will be overseen by the FEC.
- 12
- 13   **SECTION 4.**   This bill will come into effect immediately.

# Bill D1790

## A Bill to Cap the Amount of Money Raised by Federal Candidates

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1. A.** A cap on the money raised by federal candidates will be set at 55% of the  
2 total money spent by both candidates in the previous election cycle for that  
3 office.
- 4 **SECTION 1. B.** Any money received in excess of that cap must be returned to the donor(s).
- 5 **SECTION 1. C.** In election years, candidates must file monthly campaign finance reports to  
6 the Federal Election Commission.
- 7 **SECTION 1. D.** In the 2026 election cycle, the money raised by each candidate will be  
8 capped at 25% of the total money spent in the previous election cycle.
- 9 **SECTION 2. A.** For the purposes of cap calculation, “money spent” includes but is not  
10 limited to funds spent on all forms of advertising, staff and personnel, legal  
11 expenses, and office spaces and equipment.
- 12 **SECTION 2. B.** An “election cycle” begins the day after the previous election for a given  
13 federal office, and ends on the date of the general election for that office.  
14 The length of the cycle differs depending on which federal office is sought.
- 15 **SECTION 3.** This legislation will be overseen and enforced by the Federal Election  
16 Commission.
- 17 **SECTION 4.** This legislation will take effect on November 6, 2024. All laws in conflict  
18 with this legislation are hereby declared null and void.

## Bill #E236

### A Bill to Pass Continuing Resolution

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2

3 Article I: The US Congress is required to renew continuing resolutions if there are  
4 no current budgets established for a federal agency by the start of the  
5 fiscal year.

6 Article II: Continuing resolutions are defined as temporary funding that Congress  
7 can use to fund the government for a limited period that occurs when final  
8 appropriations have not been approved by Congress or the President.  
9 Final appropriations are defined as legislation passed by Congress giving  
10 federal agencies budget authority. A fiscal year is defined as an accounting  
11 period that businesses and agencies use for finance and tax reporting.

12 Article III: The Office of Management and Budget will oversee the passage of this  
13 bill.

14 Article IV: This bill will be implemented upon its passage.

15 Article V: All other laws in conflict with this legislation are declared null and void.

## **Resolution # E301**

### **A Resolution to have affordable access to critical health care.**

- WHEREAS,** The modern day costs for critical health care has spiked to an all time high in costs; and
- WHEREAS,** The Health Care Cost Institute had found out that commercial spending on the U.S health care spending had increased by around 21.8% from its latest report. **Bill # E410**

**A Bill to Enforce Price Controls on Critical Health Care to Ensure Affordable and Equitable Access for All Americans**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The United States government shall implement price fixing on essential  
2 health care services, treatments, and medications to prevent unaffordable  
3 costs and ensure equal access to necessary health care for all citizens.

4 **SECTION 2.** A. "Critical health care" refers to medical services, treatments, and  
5 prescription drugs deemed essential for the preservation of life and  
6 prevention of severe disability.

7 B. "Price fixing" refers to the government's regulation of maximum  
8 allowable prices for health care services and pharmaceuticals, set at fair  
9 market rates based on production costs, research, and reasonable profit  
10 margins.

11 **SECTION 3.** The Department of Health and Human Services (HHS), in collaboration with the  
12 Centers for Medicare & Medicaid Services (CMS), will oversee the enforcement of  
13 this bill.

14 A. The Federal Trade Commission (FTC) will monitor compliance and investigate  
15 any violations, ensuring no unlawful price manipulation occurs.

16 B. Penalties for price manipulation or noncompliance will include fines and the  
17 potential revocation of licenses for health care providers and pharmaceutical  
18 companies.

19 **SECTION 4.** Funding for the enforcement of this bill will be provided through the  
20 existing budget allocated to the Department of Health and Human Services,  
21 with potential supplementary funding from penalties collected through  
22 violations.

23 **SECTION 5.** This bill shall be implemented immediately upon its passage.

24 **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Fix Critical Healthcare Service Pricings**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1   **SECTION 1.** To impose price fixing on vital pharmaceuticals plus healthcare services as a  
2                   way to guarantee ease of access and affordability for all residents.

3   **SECTION 2.** “Critical Healthcare Services” consists of critical drugs, life-saving  
4                   procedures, and emergency medical services required for the management  
5                   of chronic illnesses or life-threatening situations. “Price Fixing” which is  
6                   the federal government's setting of a maximum permissible price for  
7                   essential medical services and prescription drugs.treatment of chronic  
8                   illnesses or life-threatening disorders.

9   **SECTION 3.** To establish suitable price limitations, the Department of Health and Human  
10                  Services will carry out an initial evaluation of the expenses related to these  
11                  services.

12   **SECTION 4.** The DHHS must track the implementation of price rules and conduct  
13                  regular audits of healthcare providers and pharmaceutical businesses. If  
14                  found in violation of price rules, an entity may be subject to fines and might  
15                  lose its ability to get a license to offer healthcare services.

16   **SECTION 5.** This legislation will take effect on January 1, 2025.

17   **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Institute Medicare for All to Lower the Price of Critical Healthcare

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1   **SECTION 1.**   This bill shall institute a national healthcare system that will provide equal  
2                   healthcare for all. This will not interfere with private healthcare providers  
3                   and will remove the ability for the Centers for Medicare and Medicaid  
4                   Services to reject an application for Medicare for all.
- 5   **SECTION 2.**   Medicare and Medicaid will be available for all American citizens and this  
6                   new medical program must cover all citizens of the United States, no  
7                   matter their health condition, age, income, residency location or criminal  
8                   record.
- 9   **SECTION 3.**   This bill will be enforced by the Department of Health and Human Services,  
10                   (HHS) and the Center for Medicare and Medicaid Services (CMS).
- 11                   A. The HHS and CMS will monitor and assist, such as providing  
12                   Medicare and Medicaid to U.S. citizens, providing it to the  
13                   Children’s Health Insurance Program and providing it to the health  
14                   insurance marketplace.
- 15                   B. Enrollment into this program shall be provided at birth and be able  
16                   to be changed into private medical care or allow citizens to unenroll  
17                   at eighteen years of age though their legal guardians can make  
18                   these decisions before the citizen turns eighteen years old.
- 19                   C. You cannot unenroll from Medicare for All unless you have an  
20                   alternative insurance plan.
- 21                   D. Once the legislation takes effect, the initiative to start instituting  
22                   this national healthcare program will begin.
- 23   **SECTION 4.**   This legislation will take effect on November 1st, 2024. All laws in conflict  
24                   with this legislation are hereby declared null and void.

**Bill # E899**

**A Bill to Provide Medicare for All**

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2. **ARTICLE 1.** The US shall establish a single-payer healthcare system to provide
3. medical coverage for all citizens, ensuring access to quality healthcare services.
4. **ARTICLE 2.** A “Single-payer healthcare system” refers to a system in which a single
5. government entity is solely responsible for funding and administering healthcare services
6. for all residents of the country. “Medical coverage” includes, but is not limited to,
7. traditional, emergency and non-emergency medicine, along with dental, hearing, vision,
8. and long-term care; mental health treatment; and prescription medicine.
9. **ARTICLE 3.** . The Department of Health and Human Services (HHS) and the Internal
10. Revenue Service (IRS) shall oversee the implementation of this legislation.
11. **ARTICLE 4.** A national health tax shall be implemented to fund this legislation as a
12. percentage of the IRS annual income which ranges from 1-10% for high-income citizens
13. The National Health Tax for businesses shall be assessed as a percentage of their total
14. payroll expenses, with rates from 2% for small businesses to 6% for large corporations.
15. **ARTICLE 5.** This legislation will be implemented over a 5-year transition period,
16. starting January 1st 2026 to January 1st 2031.
17. **ARTICLE 6.** All laws in conflict with this bill are hereby declared null and void.

# E1431: A Bill to Promote Renewable Energy and Combat Climate Change

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1   **SECTION 1.**   The federal government shall allocate \$50 billion over the next ten years to  
2                   fund renewable energy projects, including wind, solar, and geothermal  
3                   energy, with the goal of reducing national carbon emissions by 50% by the  
4                   year 2035.
- 5   **SECTION 2.**   "Renewable energy" refers to energy generated from sources that are  
6                   naturally replenished on a human timescale, such as sunlight, wind, rain,  
7                   tides, geothermal heat, and other forms of sustainable power.
- 8   **SECTION 3.**   The Department of Energy will oversee the implementation and  
9                   distribution of funds. State and local governments, along with private  
10                  companies, will be eligible to apply for federal grants to develop renewable  
11                  energy infrastructure. Quarterly reports will be submitted to Congress  
12                  detailing progress toward emissions reduction targets. Any failure to  
13                  comply with the goals or misuse of funds will result in penalties, including  
14                  fines and the potential loss of federal funding for the project.
- 15   **SECTION 4.**   This legislation will take effect on January 1, 2025, and will require periodic  
16                  reviews every five years to assess its effectiveness. Adjustments may be  
17                  made based on scientific recommendations and technological advances.  
18
- 19   **SECTION 5.**   All laws in conflict with this legislation are hereby declared null and void.

# E1445: A Bill to Fix Critical Healthcare Prices through Special Insurance

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1   **SECTION 1.**   The U.S. should fix prices for essential healthcare through a special  
2                   insurance program for low-income families. This will guarantee access to  
3                   necessary care for everyone.

4   **SECTION 2.**   Premiums/deductibles refer to the monthly costs associated with health  
5                   insurance. Low-income families are defined as individuals earning less than  
6                   \$14,580 annually or families earning under \$30,000. The term "reduction"  
7                   signifies a decrease in these premium costs..

8   **SECTION 3.**   The Department of Health and Human Services (HSS) and the U.S.  
9                   Department of Treasury will oversee a special insurance program, which  
10                  will set affordable premiums for all people holistically.  
11                  To fund this program, the Treasury will allocate 1% from the "Others"  
12                  spending category, which will be monitored and adjusted annually based
