A Bill to Stop Arms Sales to Saudi Arabia to Protect Yemeni Lives

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1 . The United States shall cease all ongoing or planned arms
2	sales to all states actively partaking in the Saudi-led intervention
3	(hereafter referred to as the "Intervention") on behalf of the Yemeni
1	Cabinet within the Yemeni Civil War.
5	A. Should any nation(s) at time of passage not actively partaking in the
5	Intervention begin to do so, all ongoing or planned sales to that nation
7	shall cease.
3	B. Should any nation(s) stop their active participation in the Intervention,
Э	sales to that country may resume 3 months after the cessation of their
10	participation.
11	SECTION 2.
12	A. "All states actively partaking in the Saudi-led intervention" shall
13	include, but is not limited to, Saudi Arabia, the United Arab Emirates,
14	Bahrain, Egypt, and Jordan.
15	B. "Arms sales" shall be defined as authorization of the sale or export of
16	any defense article or defense service to a foreign entity, as defined in
17	Title 22 Section 2794 of U.S Code.
18	SECTION 3. The Department of Defense shall oversee the
19	implementation of this legislation.
20	SECTION 4. This legislation shall go into effect starting January 1, 2025.
21	All laws in conflict with this legislation are hereby declared null and void.

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

L	SECTION 1.	Only currencies issued by the Federal Reserve System of the	
<u>'</u>	United States shall be considered legal tender for the settlement of debts		
3	in the United States. Foreign currencies shall have exchange value only.		
1	Virtual currency instruments created after the passage of this legislation		
5	shall have no value in the United States for any purpose.		
5	SECTION 2.	"Virtual currency instruments" are defined as currency	
7	notes, however denominated, that are not issued or backed by any central		
3	banking system.

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The Merchant Marine Act of 1920 shall terminate on March 31, 2025.
- 3 **SECTION 2**. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Restrict Prescription Drug Advertising

1	RE IT FNACTED BY	THE CONGRESS HERE	ASSEMBLED THAT

2	SECTION 1.	The Federal Communications Commission shall have the authority to
3		proscribe the advertisement of prescription pharmaceuticals on the public
4		airwaves, and to prevent licensed broadcasters from accepting sponsorship
5		in the name of prescription pharmaceuticals. The Commission shall further
6		have the authority to suspend or revoke the broadcasting license of an
7		operator not in compliance with this section.
8	SECTION 2.	"Prescription pharmaceuticals" shall include any substance regulated by the
9		Food and Drug Administration whose distribution is limited to individuals
10		with a valid prescription from a physician.
11	SECTION 3.	The Federal Communications Commission shall be responsible for enforcing
12		this legislation.
13	SECTION 4.	This legislation will take effect on October 1, 2025. All laws in conflict with
14		this legislation are hereby declared null and void.
