# A Bill to Abolish the Federal Bureau of Investigation

# BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	WHEREAS,	The Federal Bureau of Investigation (FBI) has abused its
2		power by labeling Catholic Americans as potential domestic
3		terrorists and acting by targeting clergy in Richmond, Virginia.
4	SECTION 1.	The United States shall abolish the FBI and transfer its resources to the
5		appropriate federal agencies.
6	SECTION 2.	The following definitions apply:
7		A. Abolish shall be defined as to completely end or destroy.
8		B. The Federal Bureau of Investigation shall include all investigative
9		operations and field offices under the supervision of the FBI Director.
10	SECTION 3.	The President and the Attorney General shall oversee this legislation.
11		A. Per current FBI employment, around 20,000 employees shall be
12		terminated from their duties.
13		B.Per current FBI employment, around 2,500 employees serving in the
14		offices of investigation of organized crime, civil rights, and Indian Country
15		will be transferred to the Department of Justice.
16		C. Per current FBI employment, around 1,500 employees serving in the
17		offices of Corruption and Crimes against children will be transferred to the
18		US Secret Service.
19		D. Per current FBI employment, around 4,500 employees serving in the
20		offices of Counterterrorism and Southwest Border will be transferred to the
21		Department of Homeland Security.
22		E. Per current FBI employment, around 7,000 employees serving in the
23		offices of Counterintelligence, White Collar Crime, and Cyber Crimes will be
24		transferred to the Department of Defense.
25	SECTION 4.	This bill will be sent immediately to the President of the United States and
26		the Attorney General and will be required to complete this action by July 4,
27		2025. All legislation in conflict with this bill will hereby be declared null and
28		void.

### A Bill to End Polish Authoritarianism

**Section 1:** In recent years, Poland's authoritarian government has been oppressing the Polish people. The United States of America shall <u>pressure</u> the Polish government to end this by <u>ending U.S. economic aid</u> to Poland if the following conditions are not met: judicial independence is restored, media is uncensored, and full protection and equality for LGBT people and immigrants against discrimination is in law.

Section 2: Ending shall be defined as to cease or halt until the conditions are met. Economic aid shall be defined as support in the form of money from the U.S. government, including military aid. Media censorship shall be defined as the suppression of free press or free speech in news. Judicial independence shall be defined as the ability for the judicial branch to check the power of other branches of government without interference of other branches of government. Full protection and equality shall be defined as laws outlawing discrimination and the repeal of all discriminatory laws. LGBT people shall be defined as any person who is not both heterosexual and cisgendered. Immigrants shall be defined as any people who reside in Poland without being born with Polish citizenship.

**Section 3:** The U.S. State department will oversee implementation of this legislation.

**Section 4:** These consequences on the Polish government shall go into effect one year after the bills passage as to allow for adequate time for the Polish government to reform.

**Section 5:** All sections of laws in conflict with this legislation are hereby declared null and void.

## A BILL TO REMOVE TÜRKIYE FROM NATO

**Section 1.** In recent years, Türkiye has plunged NATO into crisis due to president Erdogan's authoritarian tendencies and warm relationship with Vladimir Putin. **Section 3.** The United States State Department and NATO delegation shall oversee the implementation of this bill.

Section 4. This bill shall go into effect immediately upon its passage

#### A BILL TO PROMOTE MORE FUNDING FOR EQUAL HEALTHCARE FOR ALL

SECTION 1. The funding that people receive in order to receive high-quality Healthcare is not enough to improve the quality of life of every human being. The United States Government and Health and Human Services Department will grant more funding to people's health in order to achieve equality, as well as improve the health of everyone. We will be raising 40 billion dollars. We will be getting this money by decreasing the military budget by twenty billion dollars and adding a one percent tax to those making 100,000 dollars per person or 200,000 dollars as a family. **SECTION 4.** This change in budget will take effect on January 1, 2024.

#### A BILL TO DECRIMINALIZE DRUGS IN THE UNITED STATES

- 1. **Section 1.** All drug use in the United States shall be decriminalized and the
- 2. funds used for jailing people with drug histories will be put towards increasing
- 3. funding to existing residential rehabilitation facilities for former drug users
- 4. **Section 2.** "Decriminalize" is defined as the removal of criminal penalties;
- 5. "drugs" is defined as narcotics, depressants, stimulants, hallucinogens, and
- 6. anabolic steroids as listed under the Controlled Substances Act.
- 7. **Section 3.** The Drug Enforcement Agency and The Justice Department will carry
- 8. out the decriminalization of penalties of drug use in the United States
- 9. **SECTION 4.** This bill will go into effect on January 1st, 2025.
- 10. **SECTION 5**. All sections of laws in conflict with this legislation are hereby declared null and void.

# A Bill to Implement Desalination Plants in the U.S

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- **Section 1:** The U.S Federal Government shall hereby invest in desalination plants within a 50 mile radius of at risk coastal cities.
- **Section 2A.** Desalination plants shall be defined as industrial facilities that use chemical or physical processes to reduce or recover salt concentrations from water supplies.
- **Section 2B.** Coastal cities shall be defined as cities located on the interface or transition areas between land and sea, including large inland lakes with access to saltwater.
- **Section 2C.** "At risk" shall be defined as cities that experience drought on average of at least one month per year according to data provided by the Environmental Protection Agency (EPA) since 2015.
- Section 3: The Department of Interior (DOI) will be given 20 billion dollars to be allotted to private and state entities for the creation of desalination plants. The Bureau of Reclamation will be tasked with investing an additional 20 million dollars into research and development through grants. The Environmental Protection Agency (EPA) will regulate the disposal of brine and other waste products.
- **Section 4:** This legislation will take effect on January 1st, 2024.
- **Section 5:** All laws in conflict with this legislation are hereby declared null and void.
