This is to verify that Gilbert Public Schools of Maricopa County, Gilbert, Arizona is a publicly funded institute and political subdivision of the State of Arizona. As such, we are a non-profit organization under section 170 of the Internal Revenue Code and donations to the School District or schools within the District are tax deductible. As a unified school district, we serve preschool through twelfth grade students.

Entities of Gilbert Unified School District No. 41 include elementary schools, junior high schools, high schools, alternative schools, community education and district offices. A list of all Gilbert schools is attached.

Please note that our tax classification does not make us exempt from sales tax. It is illegal for other parties to use our tax identification number for reasons not authorized by the District.

- Establishing financial liability through a contract for services or goods
- Providing to another party to solicit tax deductible donations
