# A Bill to Regulate Artificial Sugars

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Food manufacturers and distributors are hereby required to label artificial
2		sugars (for example aspartame) as a sugar.
3	SECTION 2.	The Food and Drug Administration (FDA), alongside the Internal Revenue
4		Service (IRS) will oversee this new legislation. Enforcement for this
5		legislation will be funded through an extra 5 cent tax on products
6		containing artificial sugars.
7		A. On nutrition labels, or anything similar, there must be a row below
8		"Including added sugars" that says "Including artificial sugars." If the
9		FDA deems necessary, artificial sugars should also count towards the
10		percent daily value of sugar.
11		B. Products containing aspartame or any other artificial sugars may not be
12		labelled as sugar free. Furthermore, products must clearly state
13		whether or not products contain natural, added, and/or artificial sugar
14		on the front of packaging.
15	SECTION 3.	Companies found in violation of this bill will face a 5 million dollar fine per
16	unit, and	
17		each resulting offense increasing in fines by 10 million dollars per unit.
18	SECTION 4.	This legislation will take effect on January 1, 2026.
	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

#### A BILL TO CURB UNDOCUMENTED IMMIGRATION AT THE US-CANADIAN BORDER

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. The US should work diligently to curb undocumented immigration from the

  North by imposing more personnel, and immigration stations on the northern

  border
- **SECTION 2.** An "immigration station" shall be defined as a place designated for the treatment, documentation, or detainment of any undocumented immigrants who wish to cross over into the USA.

#### A Bill To Mandate Schools To Incorporate Security Systems

1	BE II ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1. All public schools from K-12 will now be forced to incorporate security
3	systems in schools for the safety of students and teachers, and federal inspections to

- 4 ensure that schools are following this regulation.
- 5 **SECTION 2.** Security systems that will be implemented include metal detectors, at least
- 6 2 active school guards, and require all schools to have bulletproof glass and easily
- 7 lockable doors. Inspectors from the government will look in schools once every year to
- 8 check whether schools have all of the mechanisms as listed above.
- 9 **SECTION 3.** The United States Department of Education will oversee the passing of this
- bill. 15 billion dollars will be transferred from the United States Department of Treasury
- to the Department of Education. Schools will now be legally obligated to incorporate
- these security measures. Failure to comply to this will result in these following
- 13 penalties:
- 14 A.) If during the annual inspection, the school has failed to incorporate these systems, it
- will lose all of its funding until it has achieved the safety measures,
- 17 **B.**) If any gun or knife incident were to occur within a school, and upon inspection it
- does not have the proper mechanisms in place, superintendent and principal of the school
- will be charged with third degree murder.
- 20 **SECTION 4.** Date of implementation will be August 1, 2026
- 21 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Ban the Pledge of Allegiance in Public Schools

1	SECTION 1.	The mass reciting of the Pledge of Allegiance initiated by adults is hereby
2		banned in all American public schools.
3	SECTION 2.	"Pledge of Allegiance" shall be defined as any variation of the Thirty-one
4		words that affirm the values and freedom of the American flag.
5		"Mass reciting" shall be defined as the speaking of words by at least 10
6		individuals.
7		A "public school" shall be defined as an educational institution that is
8		funded and operated by the government, providing free education to
9		students.
10	SECTION 3.	The Pledge of Allegiance has long been revered as an embodiment of core
11		American values. Yet by its very nature, the pledge is an assault on the
12		principles of freedom and liberty espoused by the Founding Fathers and the
13		Constitution.
14	SECTION 4.	This bill shall be overseen and enforced by the Department of Education.
15		A. Any institutions in violation of this bill shall receive a \$150,000 budget
16		cut for the first offense and \$200,000 for each subsequent violation.
17	SECTION 5.	This legislation will take effect in FY 2025. All laws in conflict with this
18		legislation are hereby declared null and void.

# A Bill to Accelerate Hypersonic Defense Innovation

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The Department of Defense (DoD) shall initiate a comprehensive program
2		to research, develop, and deploy hypersonic weapon systems.
3	SECTION 2.	Hypersonic weapons shall be defined as any weapon which travels at
4		Mach-5 (five times the speed of sound), with capabilities for offensive and
5		defensive operations.
6	SECTION 3.	The Department of Defense shall receive \$6 billion a year over the next five
7		fiscal years to be used for research, development, testing, and eventual
8		deployment with funding allocated as follows:
9		A. 40% will be allocated for research and development.
10		B. 30% will be allocated for collaboration with private sector defense
11		contractors and university research institutions.
12		C. 20% will be allocated for testing and evaluation of prototypes.
13		D. 10% for defensive countermeasures and surveillance systems designed
14		to detect hypersonic weapons.
15	SECTION 4.	The Secretary of Defense shall oversee the program in coordination with
16		the Defense Advanced Research Projects Agency (DARPA) ensuring that all
17		development meets strategic needs and international laws. The Secretary
18		of Defense shall submit annual reports to Congress detailing
19		advancements, expenditures, and security outcomes.
20	SECTION 5.	This legislation will take effect immediately upon passage.
21	SECTION 6.	All laws in conflict with this legislation are hereby declared null and void.
