

## A Bill to Eliminate Qualified Immunity for Police Officers in California

1	BE IT ENACTED BY THE LEGISLATURE HERE ASSEMBLED THAT:
2	SECTION 1. In an effort to control police brutality and misconduct, the California State
3	Legislature shall eliminate qualified immunity for police officers.
4	SECTION 2. Qualified immunity shall be defined as a legal doctrine that protects government
5	officials from personal liability for constitutional violations when performing their
5	duties.
7	SECTION 3. Under this state law:
3	A. Police officers will no longer be able to invoke qualified immunity as a defense in
9	lawsuits related to incidents subsequent to the effective date of this legislation.
10	<b>SECTION 4.</b> This bill shall be overseen, implemented, and enforced by the California Department
11	of Justice and local law enforcement agencies.
12	<b>SECTION 5.</b> This law will take effect on January 1, 2026.
13	SECTION 6. All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Ban Additive Chemicals in Foods in the United States

#### BE IT ENACTED BY CONGRESS HERE ASSEMBLED THAT:

**SECTION 1.** The United States Federal Government allows the usage of additive chemicals in U.S. food products such as Titanium Dioxide and Potassium Bromate, which are banned in supranational organizations such as the E.U., and countries such as Brazil and China. These were banned due to the dangers of genotoxicity and chromosomal damage which can be passed down to future generations.

**SECTION 2.** Additive Chemicals can be defined by the World Health Organization as "substances primarily added to processed foods, or other foods produced on an industrial scale, for technical purposes"

**SECTION 3**. These shall be defined by the Food and Drug Administration to include but not limited to: Titanium Dioxide, Potassium Bromate, Azodicarbonamide, and Propylparaben. Products such as salt, sugar, and corn syrup are exempt from this ban. Companies found in violation should receive:

- A. A fine of \$1,000,000 per kg/mol at the first offense
- B. A shutdown of the company, operation and/or corporation by the FDA at the second offense

**SECTION 4**. This legislation shall take effect on January 1st, 2026.

**SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

7	WHEREAS,	The Nashville Film Institute states that "audiences see the reliance and
8		overuse of popular tropes as lazy, resulting in movies losing their
9		impact."
10	WHEREAS,	Artificial Intelligence churns out formulaic content based on previous work,
11		all while removing jobs for screenwriters, editors, and many other
12		members of the creative process and now, therefore, be it
13	RESOLVED,	That the Congress here assembled shall ban the usage of AI in the film
14		industry, for the protection of job security and the creative process.

### A Bill to Change Cloture Votes From 60 to 51

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. This bill will change Senate Rule XXII narrowing the amount of votes necessary to end the debate in the senate from 60 out of 100 to 51 out of senators.
- **SECTION 2**. Cloture is defined as a motion, that with a vote of 60 out of 100/3/5ths of the senators present and voting, closes debate in the senate
- SECTION 3. The senate ourselves will oversee the implementation of this change

  A. Presiding officers and the senate parliamentarian will help the

  transition into this new senate rule
- **SECTION 4.** This will be implemented on the opening of the 119th congress, January 3, 2025
