



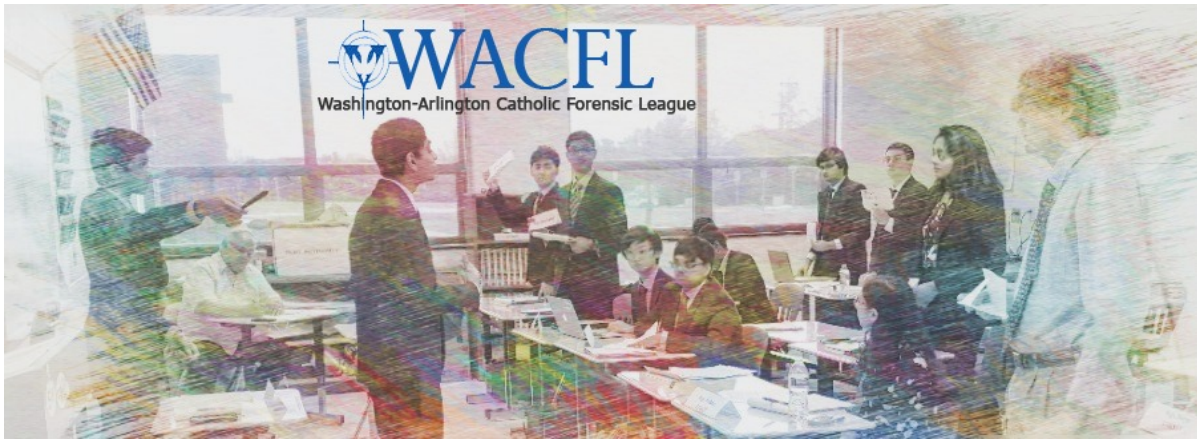

Bill #D495

A Bill to protect NIL deals in all states

Article I:

The United States Congress will protect the rights of public institutions to offer NIL deals to their students in all states and territories.

Article II:

NIL stands for "name, image, and likeness." Student-athletes who can sign NIL deals can endorse products and make money off their personal brand.

Article III:

This law shall take effect on January 1st, 2025.

Article IV:

The Department of Education will be responsible for enforcing and regulating this law.

Article V:

All conflicting laws are hereby repealed and declared null and void.

A Bill to Grant D.C Statehood

A Bill to Increase the Enforcement of Food Safety Regulations

Article I:

Article III:

This bill shall be implemented on October 1, 2025.

Article IV:

The enforcement of this bill will be overseen by the United States Congress.

All laws in conflict with this bill shall hereby be declared null and void.

A Bill to Clarify the Amount of Titanium Dioxide in Food Products in the U.S

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT: Article

I: All food productions in the U.S and producers shipped from overseas must have their products tested for titanium dioxide as a food additive and are required to list ingredient size and structure before selling to customers.

Article II: Titanium dioxide is defined as the inorganic compound derived from titanium oxide with the formula TiO_2 .

Article III: The U.S. The Food and Drug Administration will manage this bill.

Article IV: This bill will take effect upon its passage.

A Bill To Fix Flood Mapping for the NFIP

Article I: The NFIP shall end its 100 year historical floodplain maps and rely on more recent data from the 21st century only, regularly update its floodplain maps every year, and use data to predict future changes in flood risks for communities.

Article II: The NFIP-the National Flood Insurance Program-provides flood protection to people's homes. Flood insurance is not a part of homeowners insurance and the price varies by state based on risk of flooding. The NFIP uses floodplain maps to track the risk a community is to experiencing a flood based on the past 100 years.

Article III: This bill shall go into effect on January 1st 2025

Article IV: FEMA will oversee the enactment of this bill

Article V: All other laws in conflict with this bill shall be Voided

Bill #E508:

A bill to put the prices of pharmaceutical products at normal, affordable prices.

Article I: This legislation shall prevent pharmaceutical companies from making more than a 30 percent total profit off of prescription drugs.

Article II: This legislation shall require all corporations to submit an economic breakdown of their product's cost. If a drug's economic breakdown doesn't fit in the limits of the bill, or a breakdown is not submitted, the product will not be approved for shipment. In order to approve that shipment, a new breakdown with a reduced price must be submitted and reviewed. Once the request meets the necessary criteria the product will be processed and all other procedures will continue as normal.

Article III: If a pharmaceutical product's breakdown seems to be inaccurate, an audit analyzing the costs of the drug will be done. If the breakdown is inaccurate, the corporation the drug was produced by would be prosecuted accordingly.

Article IV: This legislation will come into effect on October 1 2025.

Article V: This shall be enforced by the DOC Department of Commerce.

Article VI: All laws in conflict with this bill shall hereby be declared null and void.w

A Bill to Impose An Oil Embargo on Venezuela

- Article I: This bill shall impose a trade embargo on all oil exports out of Venezuela.
- Article II: The trade embargo shall be defined as the prevention by the U.S. government and military of all movement of oil products via maritime, land, and air routes out of Venezuela.
- Article III: This bill will be nullified if the incumbent President of Venezuela resigns, and the Opposition Leader, who was duly-elected in the 2024 election, is seated as president.
- Article III: This bill shall go into effect upon passage into law.
- Article IV: The Office of Foreign Assets Control of the Department of Treasury, the United States Coast Guard, and the United States Navy shall oversee the implementation of this bill.
- Article V: All laws in conflict with this bill shall hereby be declared null and void.
