The docket order may be selected by the House or Senate chamber for each round. In the event that a chamber breaks from one preliminary round into an elimination round, the District Committee shall select which bills will be saved for the elimination round.

A Bill to Ban Direct-to-Consumer Pharmaceutical Advertising

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** No direct-to-consumer advertising any activity designed to
- 2 promote the use of a prescription pharmaceutical shall be allowed
- 3 in any media, including print, video or digital media.
- 4 **SECTION 2.** Both the entity that purchases advertising space or time such as
- 5 the pharmaceutical manufacturer or retailer and the entity that
- 6 provides the space or time for such advertising will be subject to
- 7 a fine not to exceed \$100,000 for each violation of this bill.
- 8 **SECTION 3.** The United States Food and Drug Administration will be
- 9 responsible for the enforcement of this bill.
- 10 **SECTION 4.** This law will take effect on January 1, 2026.
- 11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null
- 12 and void.

A Bill to Ban Solitary Confinement

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** The use of solitary confinement in correctional facilities shall be
2 banned in all federal, state, county, and municipal correctional
3 facilities. Any state, county, or municipality found to implement
4 the use of solitary confinement shall forfeit all federal funding,
5 grants, and assistance from the U.S. Department of Justice.
- 6 **SECTION 2.** A. "Solitary Confinement" shall mean a form of isolated
7 imprisonment where an incarcerated person is placed in a single
8 inhabitant cell for longer than 24 hours, for purposes other than
9 medical, with little or no contact with other individuals.
10 B. "Forfeit all federal funding, grants, and assistance" shall mean
11 that a state, county, or municipality found to have implemented
12 the use of solitary confinement shall be ineligible for future
13 award of disbursements of federal grants, appropriations, or
14 financing/bonding options overseen by the U.S. Department of
15 Justice.
- 16 **SECTION 3.** The Department of Justice shall oversee the implementation and
17 enforcement of this legislation.
- 18 **SECTION 4.** This legislation shall take effect immediately. All laws in conflict
19 with this legislation are hereby declared null and void.

A Bill to End Homelessness in America

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United Interagency Council on Homelessness (USICH) is hereby permanently authorized as a federal agency. Furthermore, increased funding shall be allocated towards efforts to address homelessness.

SECTION 2. Increasing funding shall include:

A. Increasing the annual budget of the USICH to \$5 million.

B. Allocating \$30 billion to the Department of Housing and Urban Development to be administered in cooperation with the USICH to further its Housing First Policy through the practice of Housing Choice Vouchers.

C. This funding shall be sourced from the FY 2025 requested budget for National Defense.

SECTION 3. The Department of Housing and Urban Development will oversee implementation of this legislation.

SECTION 4. This legislation will take effect on June 1st, 2025. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Fund Brush Clearance in California and Other Wildfire Prone Areas

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

- 1 **SECTION 1.** Congress shall allocate an additional \$1 billion per year to the
2 United States Department of Agriculture Forest Service (USFS) for
3 the express purpose of funding brush clearance in forests in
4 California and other areas prone to wildfire.
- 5 **SECTION 2.** This legislation shall be overseen by the USFS, which shall be
6 tasked, among other things, with determining which areas to
7 focus on for brush clearance and how best to delegate this work.
- 8 **SECTION 3.** This legislation shall take effect immediately upon passage.
- 9 **SECTION 4.** All laws in conflict with this legislation are hereby declared null
10 and void.

From the SCDL Congress State Qualifier Docket

A Bill to Protect Children from Social Media

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

1 **SECTION 1.** No social media platform shall permit citizens of the United States
2 under the age of 16 to sign up for or maintain an account on their
3 service. It shall be the responsibility of social media platforms to
4 monitor and ensure the ages of their users in order to comply with
5 this legislation.

6 **SECTION 2.** The 42 USC § 1862w(a)(2) definition of a social media platform
7 shall be utilized: “a website or internet medium that— (A) permits
8 a person to become a registered user, establish an account, or
9 create a profile for the purpose of allowing users to create, share,
10 and view user-generated content through such an account or
11 profile; (B) enables 1 or more users to generate content that can
12 be viewed by other users of the medium; and (C) primarily serves
13 as a medium for users to interact with content generated by other
14 users of the medium.”

15 **SECTION 3.** Any domestic social media platform that violates this legislation
16 shall be fined \$5000 for each underaged user found to be
17 registered and/or maintaining an account on their service. Any
18 domestic platform with more than 10 violations in a 365-day
19 period shall be banned from conducting business for a period of at
20 least 5 years. Any foreign social media platform that violates this
21 legislation shall be immediately and permanently blocked from all
22 United States’ web servers and devices.

23 **SECTION 4.** This legislation shall be overseen by the Federal Communications
24 Commission (FCC).

25 **SECTION 5.** This legislation shall take effect on January 19, 2026.

26 **SECTION 6.** All laws in conflict with this legislation are hereby declared null
27 and void.

The No More Meat Act

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** The United States Congress shall gradually phase out all subsidies
2 and financial incentives to meat and dairy manufacturers.
3 A. Subsidies to meat and dairy industries will be phased out by
4 20% each year, to be fully reallocated 5 years after the date of
5 enactment of this act.
6 B. All funding currently allocated to meat and dairy industries
7 shall be redirected to fruit and vegetable agriculture.
- 8 **SECTION 2.** Meat and dairy subsidies are defined as financial incentives
9 provided by the government to support the production,
10 distribution, and consumption of animal-based products such as
11 meat, milk, and cheese.
- 12 **SECTION 3.** The implementation of this bill shall be overseen by the United
13 States Department of Agriculture.
- 14 **SECTION 4.** This legislation shall take effect on January 1, 2026.
- 15 **SECTION 5.** All laws in conflict with this legislation are hereby declared null
16 and void.
